## REPORT OF THE EXPERT COMMITTEE FOR THE PRESERVATION OF ANTIQUITIES IN GOVERNMENT BUILDINGS IN TAMIL NADU

(Constituted by the Government of Tamil Nadu)

In G.O.Ms. Mo. 2146, Education, Science and Technology Department dated 14.11.83 (Appendix 1), the Government of Tamil Nadu constitued an Expert Committee for identifying the large number of antiquities in Government Buildings in Tamil Nadu. The tenure of the Committee was for a year from the date of issue of the order namely 14.11.83, but at the request of the Committee at its meeting on August 13, 1984, it was extended for one more year from 14.11.84. As per the Government Order, the following are the members of the Committee.

1. Director of Museums	 Chairman
2. Director of Archaeology	 Member
3. Chief Engineer (Buildings) Public Works Department or his nominee	 Member
4. Director of Municipal Administration or his nominee	 Member
5. Curator (Archaeological Section), Government Museum, Madras	 Member
6. Curator (Anthropology Section), Government Museum, Madras	 Member
7. Registering Officer (Archaeology Department), Madras	 Member

The Government Order sets down the functions of the Committee as

follows:

1. The antiquities such as old paintings, furniture, art objects, crockery etc., kept in Government buildings (i.e.) Raj Bhavan, circuit houses, guest houses, municipal buildings, etc. should be identified.

2. After identification necessary steps shall be taken for their proper preservation. The Government Order also stated that in the case of government buildings in districts, the work of identifying them may be entrusted to the Registering

Officers of the Department of Archaeology and the Curators of the District Museums of the Department of Museums, and requested the Collectors of districts to extend necessary facilities to the Registering Officers of the Archaeology Department and the Curators of the Museum Department. Besides, the Government Order permitted the co-option of the Curator for Chemical Conservation in the Government Museum, Madras for preservation of the objects that are identified by the Committee.

In the course of its tenure, the Committee met fifteen times (on 16.4.84, 21.5 84, 19.6.84, 13.8.84, 24.9.84, 29.10.84, 3.12.84, 21.1.85, 18.2.85, 22.4.85, 20.5.85, 24.6.85, 19.8.85, 23.9.85, 18.10.85) and discussed the matter of identifying the antiquities in government buildings in detail. At its very first meeting, the Expert Committee defined for itself the scope of its enquiry. It resolved that as objects over hundred years old came under the purview of the Antiquities and Art Treasures Act of 1972 and hence were registered by the Archaeology Department, the Committee may identify objects less than 100 years old but pertaining to a period earlier than Independence. This criterion was adopted because such objects have a value of their own as period pieces but being in many cases damaged and old-fashioned in appearance are often neglected and are either modified or disposed of. It is these objects which have to be identified and steps taken to preserve them. The Committee also resolved that a circular letter may be sent to the officers of the State Government Departments requesting them to provide a list of objects like paintings, art objects, furniture, crockery etc. available in the building under their charge (Appendix II). At its meeting on June 19, 1984, the Committee reviewed the response from the various officers addressed and found that there was not sufficient response and felt that it may be due to a difficulty in categorising the objects to be identified and resolved that a second circular may be issued listing the type of objects which are to be identified and listed (Appendix II-A). More replies were received for this circular, but many of them were in the nature of 'nil' replies. After analysing the reasons for such a large number of 'nil' replies, the Committee feit that there was still some difficulty in understanding the types of objects to be identified, and that possibly proper replies could be received if a questionnaire was issued. Accordingly a questionnaire was printed and issued to all Collectors and Departmental Heads in January 1985 (Appendix III). At its meeting held on August 13, 1984, the Committee reviewed the work done till then and felt the need to request the Government to extend the tenure of the Committee for six months from November 14, 1984 so as

to enable it to collect the required data completely. After due consideration, Government in its G.O. Ms. No. 229, Tamil Development-Culture Department dated 8.8.85, extended the tenure of the Committee by one year from November 14, 1984 (Appendix VI).

Meanwhile an interim report of the Expert Committee for the period from 14.11.83 to 31.1.84 was submitted to Government on January 31, 1985 (Appendix IV). Moreover, as recommended by the Expert Committee, the various heads of the departments who are members of the Committee also addressed their district officers for preparing lists and sending them to the Chairman of the Committee at Madras.

To date, one hundred and forty responses to the questionnaire have been received by the Committee from different districts in the State. However, out of them only twelve replies contain lists of objects which total 870. An abstract of these lists of objects is given in Appendix VIII.

A general analysis of the replies received showed that in spite of several circular letters and a printed questionnaire explaining the objectives of the Committee, there seems to have been insufficient understanding of the types of objects to be identified. It was even pointed out to the officers addressed that the identification of the objects was only for the purpose of preserving them in situ so as to obviate any feeling that if objects are listed, they are likely to be taken away elsewhere for preservation. At its meeting on August 19, 1985, the Committee suggested that a circular letter (Appendix VII) containing the names of offices which have sent positive replies may be issued to those who have sent 'nil' replies, as an incentive for creating a sense of confidence and sending positive replies. Thus during the tenure of the Committee it devised various means to elicit from the departments in the State, replies of a positive nature containing lists of objects worth preserving for posterity.

One hundred and twenty eight Government offices and institutions have sent 'nil' replies to the questionnaire, and this may probably be due to the fact that there was difficulty in classifying what would come under the purview of the Committee's questionnaire and what would not. Furniture, crockery, photographs, clocks being objects of everyday use, many would not probably give much importance to these objects as cultural materials of the recent past, which could contribute to the preserving of our cultural heritage. It is possible that some might have been under the impression that once the objects are identified, these might be transferred at a later stage for preservation as museum pieces. Further there might

have the fear that once objects are identified, routine day-to-day care of these objects is a must, thereby imposing more responsibilities in the offices and institutions concerned.

It may be seen however from the list of objects received from a few offices that these objects have a period flavour about tham and deserve to be presereved. Quite often the preservation may be only a matter of taking proper care of them and of mending them if they have been damaged. It should also be ensured that in no case these are altered to make them look modern (eg. the covering of caned furniture with laminated sheets). In the matter of preserving them, it is necessary that expert opinion is sought, and this could be made available from the sections of the Government Museum, Madras especially the Chernical Conservation Laboratory.

As for the antiquities in government buildings identified by the Committee with the help of concerned departments and offices and listed in Appendix IX, the Committee makes the following recommendations for their preservation:

1. The objects may be recorded in a separate register in the respective Department or Office and numbered separately to differentiate them from similar other objects in their departments or offices and to help in periodical inspection of their condition.

2. No alteration in the appearance of the objects may be carried out. Every effort should be made to preserve their original appearance. In case any damage which has already occured in them is to be mended, such mending has to be carried out in consultation with the Government Museum. Madras which could extend necessary facilities for this purpose.

3. The care of such objects may be entrusted to a responsible officer of the concerned department who could periodically review their condition and take steps to keep them in a good state of preservation. Such care will include periodical cleaning, polishing, varnishing etc.

4. The expenditure for preservation and mending, as the case may be, may be incurred by the concerned department from its own funds. Government may however consider sanctioning special funds if necessary for care of the objects when approached by the concerned department or office. It may be stated that this expenditure may not be large.

5. In no case however these objects may be disposed of by the departments concerned without consulting the Government Museum, Madras. Every effort should be made to restore them even when they are damaged and not to dispose them of.

This report is submitted to Government in pursuance of para No.7 in G O Ms. No. 2146 of November 14, 1983. In case further particulars are received from more departments, a supplementary report would be submitted to Government in due course. The Committee requests Government to take into consideration its recommendations as mentioned above and issue such orders as may be necessary to preserve these objects which are valuable as cultural materials of a recent period in our country's history.

#### ORDER:

The Government of India in the Ministry of Education and Social Welfare have suggested to this Government to set up an Expert Committee to identify the large number of old paintings, art objects, furniture, crockery etc. which are lying unattended in the basements of Museums, Raj Bhavan, and other Government buildings, in order to classify them as antiquities and works of arts and take action for their preservation.

2. The Government have examined the above suggestion of the Government of India in consultation with the Director of Museums. The Government constitute an Expert Committee with the following members, to identify the objects in various Government Buildings in Tamil Nadu.

3. The Government also permit the Director of Museums, Madras to associate the Curator, Chemical Conservation Section Government Museum, Madras in the preservation of the objects that are identified by the Committee.

4. The Director of Museums, will be the convenor of the said Committee. The tenure of the Committee will be for one year with effect from the date of issue of this order. It shall meet as often as necessary. The functions of the Committee shall be as follows:-

i) The antiquities such as old paintings, art objects, furniture, crockery art etc. kept in Government Buildings (i.e.) Raj Bhavan, Circuit Houses, Guest Houses, Municipal buildings etc. shall be identified.

ii) After identification necessary steps shall be taken for their proper preservation.

5.. The Government also approve the proposal of the Director of Museums, that the identification and preservation of antiquities in the various Government buildings in the Districts, be entrusted to the Registering Officers of the Department of Archaeology and the Curators of the District Museums of the Department of Museums in the Districts under the overall supervision of the Expert Committee constituted in para 1 above.

6. The Colloctors of Districts are requested to render necessary assistance to the Registering Officers of their Department of Archaeology and Curators of the Department of Museums in this matter.

7. The Committee shall submit its report to Government as early as possible for onward transmission to the Government of India.

8. The expenditure on holding the meetings will be debited to "278.A. Art and Culture - AE. Archives and Museums - I. Non Plan AD. Government Museums-04. Travel Expenses (D.P.C. 278A AEAD 0478).

 8. Prints, 9. Paintings, 10. Plaques, 11. Statues, 12. Busts, 13. Carpets, 14. Crockery items, 15. Musical Instruments, 16. War Shields, 17. Trophies and 18. Weapons.

It is further clarified that the purpose of preparation of these lists is to enable steps to be taken for preserving the objects in situ. They would not be disturbed from their places.

Further the District Collectors are also requested kindly to furnish the list of objects in the Collectorate Office buildings themselves apart from other Govt buildings under their control in the district.

May I request you, therefore, to kindly furnish me the list of objects on or before 2nd August 1984, for taking further action.

### AN INTERIM REPORT OF THE EXPERT COMMITTEE (Dated 31.1.85) SUBMITTED TO THE GOVERNMENT

## A REPORT OF THE EXPERT COMMITTEE FOR THE PRESERVATION OF ANTIQUITIES IN GOVERNMENT BUILDINGS, GOVERNMENT MUSEUM, MADRAS, FOR THE PERIOD FROM 14.11.1983 TO 31.1.1985.

The Government of Tamil Nadu have constituted an Expert Committee (as per the G.O. Ms. No. 2146 Education, Science and Technology Department, dated 14.11.1983) to identify the large number of paintings, art objects, furniture, crockery etc., which are lying unattended to in the basement of museum, Raj Bhavans and other Govt. buildings, in order to take action for their proper preservation. The Committee is headed by the Director of Museums. Govt. Museum, Madras and the other members of the Committee are, the Director of Archaeology, Chief Engineer (Buildings) Public Works Department or his nominee, the Director of Municipal Administration or his nominee, the Curator for Archaeology and the Curator for Anthropology of the Govt. Museum, Madras and the Registration Officer of the State Archaeology Department. Besides the Government have permitted the Curator for Chemical ... Conservation Section of the Madras Government Museum to coopt and to associate in preservation of objects that are identified by the Committee. The tenure of the Committee was for a year from the date of issue of the order i.e., 14.11.83.

The Expert Committee met eight times (16/4/84, 21/5/84, 19/6/84, 13/8/84, 24/9/ 84, 29/10/84, 3/12/84, and 21/1/85) to date and discussed the matter in detail and issued circular letters (7204/84-E3 dated 17.5.84 and dated 11.7.84) twice in an eleborate and simplified way for preparing the list of objects in Govt. buildings, to more than forty institutions and Departments in the districts and in Madras city. The response was not so encouraging and except the P.W.D Madras circle and the Collectorate of Pudukkottai, the other Departments and institutions have not yet furnished the list of objects for identifying and for preservation. However quite a few departments such as the Medical Education Department, (The Thanjavur Medical College, The Chingle pattu Medical college, the Madurai Medical college the peripheral Hospital at K.K. Nagar, Madras and Anna Nagar, Madras and the Institute of T.B. and Chest Diseases, Chetput, Madras) six Collectorates (The South Arcot, The Periyar, Kanyakumari, Madurai, The Nilgiris and Dharmapuri) the Anna University, Madras, the D.G.P. and D.I.G. (C.I.D.) Madras and the Rajaji Hall etc., have sent nil reports. The Expert Committee at its meeting held on 24.9.84 took serious note of the large number of nil replies and felt that possibly if a questionnaire listing the types of objects was prepared and circulated there may be more a detailed response. In persuance of the committee's decision a questionnaire has been prepared and printed (copy enclosed) and sent to fifty institutions and Departments in the Districts and in Madras City. Once the relevant particulars are collected through the questionnaire, an inventory of objects will be prepared and after identifying them, they may be preserved in situ and they would not be disturbed.

The Committee at its meeting held on 24.9.84 suggested that due course. the members of the Committee may undertake tours and meet the District Officers at different centres and impress upon them about the method of identifying the period pieces in Government buildings. The Committee at its meetings held on 3.12.84 and on 21.1.85 had resolved that orders from the Government may be obtained appropriate time to the effect that any proposal for disposal of pre-independence materials/objecrs in all Government buildings in the State may be approved only after being referred to the Director of Museums, Government Museum, Madras and obtain his clearance. The Committee in its sitting on 3rd Dec.'84 suggested that an imterim report may be sent to the Government about the activities of the Expert Committee during the past one year. Further at its meeting held on 13th August 1984, the Committee resolved to request the Government to extend the tenure of the Committee for six more months from 14.11.84 so that the list of the objects be collected, processed and classified for preservation etc.
