SECTION I.

Preliminary Remarks.

- 1. THE most effectual and just mode of securing discipline in a Regiment is the establishment of such an exact gradation of responsibility, from the Field Officer who commands the Corps, to the Corporal who directs the Squad,—that every individual may know his precise station, and execute its attendant duties with zeal and alacrity.
- 2. A fair distribution of duties must ever be an object of primary importance—circumstances, however, especially on Service, may occasionally prevent strict attention to this point. Of such circumstances the immediate superior must be the judge, and the individual whom his decision may affect, must bear in mind that when the Service calls, a Soldier has only to obey. But if a grievance be at any time imagined, the duties must be performed with perfect alacrity and good will,—and respectful remonstrance may follow. Obedience must, therefore, be prompt, respectful, and without a murmur, and it equally behoves those in Command to exercise authority with steadiness, good sense, and propriety.
- 3. All orders shall pass through the regular channels of communication, prior to their execution, and all applications, of whatever nature, are equally to follow the same course in their address, unless urgent reasons may necessitate

a deviation therefrom. It is, however, of course, to be understood that the orders of a superior are at all times to receive immediate obedience, although not given through the prescribed channel.

4. Every Officer, Non-Commissioned Officer, and Soldier, will observe that it is an invariable rule and principle in discipline, that in the absence of a superior the whole of the duty or charge which was entrusted to him, devolves upon the next in Rank, so that a blank or chasm is never to exist in the various responsible situations of the Corps.

SECTION II.

Officers.

- 1. With the Commanding Officer of the Regiment rests the entire responsibility for its discipline, economy, and general well being: His authority is supreme, and it is, therefore, to be remembered, throughout these orders, that whenever any exclusive charge or control is assigned, in any instance, to a subordinate Officer, such exclusion is in no case to be understood as in the least degree referring to the Commandant.
- 2. The Major is responsible to his immediate Superior for a general superintendance of the discipline and internal economy of the Regiment, in the execution of which duty he will receive such directions from the Lieutenant Colonel as circumstances may render necessary.
- 3. The Captain's responsibility to the Commanding Officer for his Company, is similar to that of the latter for the Regiment—it is undivided. The various duties arising out of it will demand his closest and most coustant attention. He should personally know and attend to every circumstance connected with his men, enforcing regularity and attention to duty without severity, patiently enquiring into, hearing, and adjusting their various complaints and discussions, and, above all, invariably executing the duties of his situation in person.

4. The duties of a Subaltern Officer in charge of a Company are similar to those of a Captain, whose duties then devolve upon him. When not in such charge, he will assist the Officer commanding the Company in whatever duties he may require, or as may be occasionally directed in Regimental orders, whether by a subordinate superintendence of squads, or of the whole Company.

SECTION III.

Native Officers.

- 1. The Subadar Major although holding Brevet Rank, which, on occasions of General Duty, entitles him to take precedence of all Subadars, yet for all Regimental Duties will be borne upon the Roster with reference to his Regimental Rank only.
- 2. The Native Officers are required to be particularly distinguished by propriety of conduct, carefully avoiding every thing tending to lower their Character in the estimation of their inferiors. They are required to communicate to their superiors every occurrence worthy of note which may come to their knowledge, keeping their European Officers at all times well acquainted with the conduct and feelings of the men, whose errors may thus be promptly corrected, and whose grievances, when any exist, by being earlier known, may at once be redressed.
- 3. Every Native Officer is to be carefully instructed in the various duties pertaining to his Station, and it is expected that he shall be perfectly capable of exercising a Company in every situation.
- 4. When a Native Officer may be taken sick, he will be allowed to remain in his quarters, attending at the Hospital at such periods as the Medical Officer may direct, if not prevented from doing so by the nature of his dis-

order, in which case the Surgeon will visit him at his own house

5 Native Officers are most strictly inhibited from ever employing, or accepting the services of, the men of the Corps in any manner whatever for their private purposes, without the especial sanction of the Commanding Officer first obtained,


SECTION IV.

Adjurant.

- 1. The Adjutant conducts the duties of his Department under the immediate direction of the Commanding Officer His talents and qualifications will best be ascertained from the general appearance and efficiency of the Corps. He is to report even the minutest questions relating to its discipline and economy, and must, therefore, exercise an unremitting vigilance, as nothing should pass unnoticed by him which can, even in a remote degree, affect its interests.
- 2. He is solely responsible to the Commanding Officer for the economy, correctness, and regularity of all Regimental Books, Records, Papers, and Returns, concerning his Department.
- 3. All Orders conveyed by him from the Commanding Officer, whether written or verbal, are to be implicitly obeyed by every officer.— Should it appear to an Officer that any mistake has been made in an Order thus issued, he is at liberty to bring it to the notice of the Commanding Officer or Adjutant, for correction, but he is on no consideration to suspend its execution.
 - 4. He is to exercise a strict superintendence over the conduct of the Native Commissioned, and Non-Commissioned Officers, immediately bringing to the notice of the Commanding Officer any irregularity or impropriety which may come to his knowledge.

- 5. He is required to attend the Drill of the Recruits, morning and evening, unless prevented by other duty, and to Parade and Inspect all parties for Guard and Detachment.
- 6. He is to keep the Roster for the duties of all ranks of the Regiment, detailing Commissioned, Non-Commissioned Officers, and Naigues by name—and Privates, &c., by number leaving to Company Officers to detail the individuals.
- 7. He will wait upon the Commanding Officer daily at A. M. and will lay before him the Morning Report Book of the Corps, as well as all letters, reports, &c. received for submission to him, unless his attendance shall be dispensed with when he will be punctual in sending all requisite reports and papers, &c.
- 8. It is his duty to attend at the prescribed hour for orders, at the Public Office of the Station, or to ensure the regular attendance of the Serjeant Major or Clerk for that purpose, as may be required by local regulations.—In Camp, he must personally attend to this part of his duty.
- 9. It is the peculiar province of the Adjutant to superintend the Drill and Instruction of every young Officer joining the Regiment, nor is he to consider the dismissal of the Officer from his immediate Drill as exonerating him from further attention to this important subject it will still be his duty to afford every assistance to the completion of his instruction.
- 10. It will also be the duty of the Adjutant to introduce to the Commanding Officer, all Officers immediately on their joining the Regiment.

- 11. The Adjutant is empowered to confine any Non-Commissioned Officer or other of interior rank, whenever he may deem it necessary, reporting the circumstance without delay to the Commanding Officer.
- 12. He must be ready at all times to afford every information on points of duty which may be required, especially by Junior Officers, and it is, therefore, necessary that he should be perfectly master of every subject connected with the Regulations and Discipline of the Army.
- 13. He is not to interfere with the interior economy of any Companies other than such as may be under his own charge.



SECTION V.

Quarter Master, ect.

- 1. The Quarter Master is charged with the general care of the Stores, Arms, and Ammunition of the Regiment. It will be his duty at all times to keep the Commanding Officer informed whether they are duly taken care of in the Barracks or other place of Arms, and to make a report of such arms or other articles as may be brought to him for repair which appear to have been carelessly or wantonly damaged.
- 2. He is charged with the care of the Barracks and all other Public Buildings occupied by the Regiment, as well as of the Parade and Regimental Lines, and he is responsible to the Commanding Officer for their general cleanliness and preservation.
- 3. He is to receive and have the general superintendence of all Barrack furniture and utensils thereunto appertaining—Rests, Scaling Ladders, &c &c., as delivered over by the Barrack Master for the use of the Corps. He will give them in charge of Officers of Companies and others, as may be requisite, taking their receipts for the same, and when ordered by the Commanding Officer he will make occasional surveys to prevent neglects, besides accompanying the Barrack Master at his periodical Inspections.
- 4. The issue of Provisions, whether on Service or otherwise, falls under his immediate charge and responsibility. Their distribution

will be made under such regulations as circumstances may require, and which will be published in Regimental Orders at the time. Should any article be deficient, either in quantity or quality, the Quarter Master is enjoined to make an immediate report, accompanied, if necessary, by a sample, to the Commanding Officer.

- 5 He is never to issue any article from the Regimental Stores but upon a regular receipt from the Officer of the Company or Department made out agreeably to Form No. 1. and which receipts he will lay before, or send to, the Commanding Officer at Orderly Hour for Countersignature previous to making the issue.
- 6 All ordinary issues from, and receipts into, the Regimental Store Room, are to be made from 8 to 10 A. M. and from 2 to 4 P. M. daily, Sundays excepted.
- 7. The Quarter Master will enter in his Return Book for submission to the Commanding Officer, Mouthly Reports and Returns made out agreeably to Forms II and III.
- 8. On the march it will be the duty of the Quarter Master, accompanied by his Serjeant and camp colors, to precede the Regiment in sufficient time to select and mark out the ground for encampment at the next stage, previous to the arrival of the Corps thereat. On the Regiment approaching, he is to meet it for the purpose of pointing out the ground to the Commanding Officer.
- 9. The Quarter Master will also ascertain from the Inhabitants of the country, and report to the Commanding Officer, every necessary point relative to the next day's march,

such as the state of the road, nature of the country, depth of rivers and streams, whether fordable, or if not, what means of crossing are available, &c. &c. He is also to procure the necessary guides.

- 10. The Quarter Master is held responsible for the regularity of the encampment, observing that the Tents are all pitched agreeably to the lines laid down by him, that Horses and Cattle are all picketed in rear of the Camp, and generally that the strictest attention is paid to the general Regulations.
- 11. A certain number of Men, as will be fixed from time to time by the Commanding Officer, may be employed under the Quarter Master as Tailors. They will, while so employed, be exonerated from guard and orderly duties, but they are to attend all Drills and Parades unless specially excused. They are on no account to be employed on any but strictly Regimental Work: to wit, the making and altering, &c. of Turbands, Clothing, and other articles of Regimental Equipment.
- 12. No Man shall be employed on this duty, at any one time, for a longer period than three Months, at the end of which he is to be relieved—and is not again to be so employed until after he has done three Months duty in the ranks.
- 13. The Quarter Master will apply to the Commanding Officer whenever he may require Men for this or any other similar duty.
- 14. Unless the Commanding Officer may give other orders at the time, Men required for such duties are to be detailed numerically, the

selection of the individuals being made by Officers of Companies.

- 15. The Quarter Master will have in his Office a sealed Pattern of every article of Regimental Equipments, as particularized in the Tables of necessaries, Section XII. These patterns are at all times to be available for the inspection of Officers Commanding Companies, but are not to be sent from the Office for that purpose,
- 16. As a general rule, the Quarter Master will be included in the Roster for all Regimental duties in Garrison, and Cantonment, and struck off all but Courts Martial and Committees when marching or in the Field. He does no General or Garrison duties but as Quarter Master or Interpreter.

Paymaster's Department.

- 1. THE Paymaster's Office will be open for the receipt and issue of Money from 10 to 1 A. M. daily, Sundays excepted, and on the day on which pay may be issued and the two subsequent, from 8 to 4.
- 2. The Paymaster will report to the Commanding Officer the receipt of Pay, or other Money for issue, and he will at the same time submit to him a statement shewing the description and proportion of coins received and the rate of exchange. The statement is invariably to be published in Regimental Orders. Form No. 1V.
- 3. The Paymaster will notify to the Adjutant, the time at which the Monthly Pay of the Regiment will be received from the Pay Office, and the Adjutant will then furnish him with the Guard of which the strength will from time to time be fixed by the Commanding Officer as may be requisite. This Guard will be continued for three days including that on which the Pay is received. During that period the Regimental Cash Chest may, for greater convenience, be kept at the Paymasters Office: at all other times it must be lodged in the Barrack or Quarter Guard.
- 4. Officers are to receive the Pay of their respective Companies at the Regimental Pay Office in person, and will insert their Signatures in the Raymasters Distribution Roll in proof of having duly received the amount of their Abstracts.

5. A Subaltern or Junior Officer of a Company may attend for the above purpose, on the responsibility of the Commandant of the Company.

6. No issue of Pay or other Public Money, is ever to be made without the sanction of a Regimental order, unless under the authority

of the Commanding Officer.

Interpreter's Department.

- 1. The Interpreter will attend all Regimental Courts Martial, and Courts of Inquiry. He is to Interpret all Evidence, &c. given in Hindoostanee, and, when required, he will procure competent Interpreters in other languages. He is also to provide Cazee and Brahmin.
- 2. He is to be at all times prepared to interpret or translate as may be required by the Commanding Officer.
- 3. It will be the duty of the Intrepreter to make or provide plain and intelligible translations of all general or other orders required to be explained to the Men. as also, in communication with the Adjutant, of the Standing Regulations for the various Regimental Guards.
- 4. A Book is to be kept in his Office in which will be entered copies of all translations made by him for the official purposes of the Regiment.

SECTION VI.

Native Adjutant.

- 1. The Native Adjutant is to be considered as the Assistant of the European Adjutant, under whose immediate authority he is placed. All orders received through him are to be obeyed by the Native Officers and others, in like manner as if given by the European Adjutant in person.
- 2. He warns the Native Commissioned and Non-Commissioned Officers for duty, receives on the Regimental Parade the Non-Commissioned and Men for duty, inspects them, and delivers them over to the Adjutant
- 3. He is on no account to interfere in any manner with the interior economy of Companies, but assisted by the Havildar Major, he will collect and make reports to the Adjutant, who is the organ of all communications to the Commanding Officer whether on Parade or otherwise.
- 4. He will attend daily at the Adjutant's Quarters for Orders at such hours as may from time to time directed, and it will be his duty, generally, to inform the European Adjutant of every circumstance, in any manner connected with the welfare or Discipline of the Regiment, which may come to his knowledge.

5. Unless otherwise directed, his post at Drill, &c. will be, in Line, six paces in reaf of the centre, and in column, on the reverse Flank of the leading Centre Company.

SECTION VII.

Serjeant Major.

- 1. The Regimental Serjeant Major is under the immediate orders of the Adjutant, and is not to be employed by any other person without his permission. His duty is to assist in making up all official Returns, Books and Papers, of every description, relative to the Adjutant's Department.
- 2. The Serjeant Major although drilled, and liable to perform the duties of a Soldier, is to be confined to the clerical duties of the Adjutant's Office, and unless peculiar circumstances may prescribe a deviation from the rule now laid down, he will always be employed on such.
- 3. Unless on particular occasions, the Serjeant Major will not attend Drill or Parade: when he attends, he is to take post in rear of the Right Wing.
- 4. Although the Serjeant Major is generally exempted from Military Duties, it must be understood that misconduct on his part may at all times be punished by his being ordered on any, whether of fatigue or otherwise, which the Commanding Officer may deem proper.
- 5. Whenever it may be necessary to place the Serjeant Major under restraint, he will be confined to his Quarters, but not under a sentry unless circumstances may render it advisable to place one over him, or to adopt the harsher measure of confining him in the Barrack or Main Guard.

6. When the Serjeant Major may be taken sick, he will be allowed to remain in his Quarters, attending at the Hospital at such periods as the Medical Officer may direct, if not prevented from doing so by the nature of his disorder, in which case the Surgeon will visit him at his own house.

SECTION VIII.

Quarter Master Serjeant.

- 1. The Quarter Master Serjeant is under the immediate orders of the Quarter Master, and is not to be employed by, or to receive orders from, any other person, except in such instances as it may be otherwise directed.
- 2. He is held responsible, under the Quarter Master, for the preservation of the Arms, Ammunition, &c. lodged in the Regimental Stores, and for the due care and preservation of the Barracks and all other public buildings of the Corps.
 - 3. He is also responsible for the cleanliness of the Regimental Lines and Parade, which he must frequently visit and inspect.
 - 4. Whenever the Corps may be ordered to Parade, it will be the duty of the Quarter Master Serjeant to attend with the Regimental Camp Colors, and plant the Flags, &c., as also the Targets for ball practice, and in these particulars he is subject to the direction of the Adjutant.
 - 5. He is carefully to superintend the Regimental Lascars of his Department and Artificers, and he is answerable to the Quarter Master for their correct and punctual performance of their various duties.
 - 6. In choice of quarters, &c the Quarter Master Serjeant ranks after the Serjeant Major.

7. The rules contained in paragraphs 5 and 6, of the preceding Section, are equally applicable to the Quarter Master Serjeant. When required to fall in with the Regiment on any particular occasion, his post will be in rear of the Left Wing.

SECTION IX.

Havildar Major.

- 1. The Havildar Major, under the Native Adjutant, is to do the duties pertaining to the Serjeant Major in an European Regiment—Superintended by the Adjutant, he is to keep the Roster for the various duties of the Non-Commissioned Officers and Rank and File of the Regiment.
- 2. At Parades and Drills the Havildar Major will take post and perform the duties prescribed by His Majesty's Regulations for the Serjeant Major.
- 3. He takes precedence of all other Havil-dars of the Regiment.
- 4. It is the duty of the Havildar Major to instruct all Non-Commissioned Officers, recently promoted, in the various Orderly duties of their new grade.
- 5. The Havildar Major is to keep an Order Book in which will be entered, under the super-intendence of the Adjutant, all Orders, other than those of daily detail, which are intended for the guidance of the Men. Native Officers, Orderly Havildars and Naigues, are to have free access to this Book whenever they may require it.

SECTION X.

Drill Havildar.

- 1. THE Drill Havildar is the immediate assistant to the Adjutant in the Drill, and in the instruction of the Recruits. He reports to, and receives his orders from the Adjutant, and no other Officer is to interfere with the Drill.
- 2. He ranks with other Havildars according to his standing, his situation, although generally conferring prior claims to promotion, giving him no precedence of his comrades.
- 3. The Drill Naigue is under the orders of the Drill Havildar. He is to assist him in the execution of his various duties, and he is to attend every morning at the Adjutant's Office to receive the orders of the day.

SECTION XI.

Kon-Commissioned Officers, Naigues, and Lance Raigues.

- 1. Non-Commissioned Officers take rank according to the dates of their appointments, Color Havildars having the precedence of other Havildars.
- 2. Non-Commissioned Officers, whether on or off duty, are not to permit any irregularity, neglect, or deviation from orders whatever. They are to exact the promptest obedience from all inferiors, when in the execution of their duty, immediately reporting every man who disputes their orders, or who, on being reproved for inattention or neglect, replies to them in an insubordinate manner. When left in charge of any duty, they ought at all times to execute it with as much punctuality as if under the immediate eye of their Officers. A Non-Commissioned Officer who is found to have connived at any irregularity, even of the most trifling nature, cannot be considered trust-worthy.
- 3. They must report all Men whom they suspect to be diseased, and must be watchful over their Men's health, urging them to report sick on the first symptom of illness.
- 4. Young Non-Commissioned Officers, or men doing duty as such, are particularly cautioned against conniving at any neglect of

duty on the part of those under their command, and the slightest breach of this order will be punished.

- 5. Every Non-Commissioned Officer on his promotion to the Commissioned Ranks shall attend the Adjutant's Drill, until reported by that Officer to be fully acquainted with the several duties of his new grade.
- 6. In like manner every Naigue promoted to Havildar, and Private to Lance Naigue, shall be required to attend Drill for the same purpose.
- 7. On the occurrence of a vacancy in the Ranks of Havildars or Naigues it will rest with the Commanding Officer to promote such individual as he may deem most qualified to fill the situation, and in making this selection he will be guided by positive merit rather than by mere seniority or length of service. Officers of Companies will, therefore, be careful in reporting upon the character and conduct of the Orderly Havildars and Naigues, on the Monthly relief, as these reports will naturally attend to influence the Commanding Officer in his opinion of those Men.
- 8. Officers Commanding Companies will send to the Adjutant, when required by the Commanding Officer, recommendation* Rolls of six Men, three Moosulmens, and three Hindoos, whom they may wish to promote to the Rank of Lance Naigue, and, unless on special occasions, no Man will be promoted to that Rank, who is not so recommended; Officers are restricted in their choice to their immediate Companies.

- 9. No Naigue shall be eligible for promotion to the Rank of Havildar, unless he can pass a satisfactory examination in Parts I and 2 of Torrens, and in "Duties in Garrison."
- 10. No Private shall be eligible for promotion to the Rank of Lance Naigue unless he can pass a satisfactory examination in Part I of Torrens, including the Manual and Platoon.
- 11. These examinations shall be made in the presence of the Commanding Officer or Major of the Regiment.
 - 12. Each Battalion Company will have two Lance Naigues, and each Flank Company four.
 - 13. Officers of Companies in filling up their recommendation Rolls are required to give their particular attention to the General Regulations on the subject of Promotion.
- 14. Whenever from any circumstance an additional number of Lance Naigues may be temporarily required, they are to be regularly recommended by the Officers Commanding Companies, and appointed to act by the Officer Commanding. The casual selection of Men, at the moment their services are required, to act as Lance Naigues, is prohibited.

SECTION XII.

Interior Economy of Companies.

1. Each Company is to be divided into four permanent Sections, told off from Right to Left of the full Company as standing when regularly sized and formed,—the Havildars, Naigues, and Lance Naigues being equally apportioned among them. The head of each Section is to have in his possession a Roll of the Individuals composing it; written in his own language, and in English.

Two Sections form one Sub-division—to each Sub-division one of the Native Officers is to be distinctly attached, being changed as often as the Officer Commanding the Company may direct—and whose especial duty it will be to superintend that part of the Company at Roll Call, &c. &c.

- 2. The Non-Commissioned of each Section will be held responsible for the general conduct and appearance of the Men composing it, and will be liable to punishment in the event of any Man being paraded for duty; &c. improperly dressed or accounted.
- 3. Whenever a Man has any complaint to make, or application to prefer, rendering a reference to the Commanding Officer requisite, the Officer Commanding the Company will either make a verbal report to the Commandant, or he will forward a written one to the Adjutant

for his information. The Commanding Officer will determine from time to time, as may be necessary, whether these Reports are to be verbal or written. In either case the Individual must appear before the Commanding Officer,—and when the Officer may not attend, the Orderly Havildar must, to answer such questions as may be put on the subject.

- 4. Before submitting any complaint or application to the Commanding Officer, the Officer of the Company is required to make himself perfectly acquainted with every particular of the case, that he may be prepared to afford every information which may be required on its subject.
- 5. Officers of Companies are permitted to grant "Present Leave" to two Privates at a time, for a period not exceeding three Parades, without reference to the Commanding Officer not, however, interfering with their tour of duty. Officers will be liable to forfeit this privilege should it appear to the Commanding Officer to be indiscreetly used.
- 6. Present leave to the same extent may be granted to one Native Officer—and to either one Havildar, or Naigue, or Lance Naigue, one individual only of these grades having leave at the same time:—thus, if leave be granted to a Havildar, it is not to be granted at the same time to any Naigue or Lance Naigue.
- 7. When leave may be required to any greater extent than now specified, application must be made to the Commanding Officer at Orderly hour, in the manner prescribed in Para.

 3.—The application when in writing, is to be made out agreeably to Form No. XVII.

- 8. Unless under urgent circumstances, leave will not be granted to any individual who has been warned for duty, until he has performed the tour.
- 9. Present leave, when granted in any Company, is to be noted in the column of Remarks of the Morning Report.
- 10. The indulgence of present leave is not to be granted to the same individual more than once in the course of the same month without reference to the Commanding Officer.
- 11. An Officer Commanding a Company is restricted in the correction of his Men's irregularities to the following punishments.

The withholding of recommendation for furlough,—extra Drill to the extent of 8 extra Drills, without Knapsacks, 2 extra tours of duty, General or Regimental, 8 extra tours of * fatigue,—and restriction to Barracks for three Parades. This restraint does not come within the meaning of Paragraph 14 of this Section, and a Man under such restriction will attend all Parades, &c. and take his tour of duty as usual. All cases of a nature to require more severe punishment, must be reported to the Commanding Officer.

- 12. It is to be observed, that Drill as a punishment must be ordered for a certain number of "extra Drills," never days—extra Drills are never to interfere with other duty.
- 13. Officers Commanding Companies will enter in their Morning Reports, the Names,

&c. of all men who may have been ordered for punishment as above, specifying the nature of the offence and punishment,—and the Adjutant will lay before the Commanding Officer at orderly hour a general Memorandum of the whole. Form No. VI.

- 14. No Officer should ever confine a Man of the Regiment without previous reference to the Commanding Officer, unless the nature of the Man's Offence may require his instant appreheusion. Every Officer confining a Man is immediately to transmit his charge against him to the Officer of the Day, by whom it will be forwarded to the Adjutant.
- 15. No Man is to be ordered into confinement when the Regiment is under Arms, by any authority inferior to that of the Officer in Command of the Parade.
- 16. No Subaltern Officer, unless he commands a Company, is to order a Soldier any punishment, but will report to the Commandant of the Company, or of the Regiment, as the case may require, all irregularities and offences which may come under his observation. This rule, however, is not to affect Officers Commanding Companies at Parade or Drill, or on Guard or Orderly duty—in those cases they are authorized to award punishment to the extent of three extra Drills without Knapsacks to individuals of any Company, making the report above specified.
- 17. Every Officer in charge of a Company or Department shall receive its Pay from the Regimental Paymaster, and disburse it to every individual present in person. The interposition, therefore, of any other person in the

discharge of this duty, further than as regards the mere distribution of the Coin, is strictly prohibited. The Acquittance Roll being prepared previous to the issue of Pay, will be signed by each individual on receiving the balance due to him after authorized deductions. Men absent on Guard are to be paid on being relieved, those Sick at the Hospital—all in presence of the European Officer. Men absent on Detachment whose Pay it may be necessary to send them, are to sign the Roll on rejoining the Company.

- 18. It is the duty of the Officer to explain to the Soldier, before receiving his signature, the particulars of all stoppages, and balance.
- 19. Every entry in a Soldier's Stoppage Account, whether on the Debit or Credit side, is to be signed by the individual at the time of its being made, in the column appropriated for that purpose.
- 20. On the issue of Pay, the Men are to be marched with all regularity to the Quarters of the Company Officer, in Regimentals, and without Arms.
- 21. No stoppages are ever to be made from the Pay of the Men, without the authority of a Regimental Order.
- 22. Whenever it may be necessary to order stoppages from the Pay for the purpose of providing Equipments and Necessaries, they are to be made in accordance with the subjoined scale, unless otherwise directed at the time by the Commanding Officer.

23. Officers in charge of Companies and Departments will lodge the Pay of Men who may he absent on duty or otherwise on the day of its issue, in the Paymaster's Office, in Sealed Bags—accompanied by a Memorandum in the following Form.

"The Sealed Bag of B Company to be lodged in the Regimental Cash Chest."

This Memorandum will be countersigned by the Paymaster and returned to the Officer, as a voucher for the re-issue of the Bag—and, in this manner only, will the Pay Master be required, at any time, to receive money for deposit.

24. Officers Commanding Companies will deliver into the Regimental Pay Office, as soon as practicable after the issue of Pay in each Month, all unclaimed sums of money which

may be in their hands accruing from Deaths or other Casualties, accompanied by a Statement agreeably to Form No. VII.

- 25. The morning Report Book of each Company, filled up for the day, is to be sent to the Adjutant's Office every morning at an hour which will be specified from time to time, as may be necessary, in Regimental Orders.
- 26. Each Officer of a Company is personally to inspect his Men detailed for duty, at least once weekly.
- 27. Each Officer is to visit the Men of his Company Sick in Hospital, at least once a week, exclusive of such visits as may be made by him in his Orderly Tour.
- 28. All Orders intended to be entered in the Order Books of Companies will be noted accordingly in the Regimental Order Book at the time of their publication, and, if such as are to be communicated to the Men, they are to be read at the next Parade or Roll Call, the European Officer of each Company himself explaining them. Orders required to be entered in Company Order Books as above, will be circulated on a sheet of paper to Companies in succession for the purpose of being copied. Each Officer having made his copy with as little delay as possible, will forward it to the next Company, affixing his initials to it in proof of its having reached him, and the last Officer will return it to the Adjutant. Should an Officer be from home, the paper must pass him, and be transmitted to the next in succession.
 - 29. Whenever practicable the orders for

the day will be promulgated to the Men at Roll Call, or previous to their dismissal from their private Parades, if the Regiment has been under Arms.

30. When circumstances prevent this the following system is to be observed.

The orders having been communicated as usual to the Native Adjutant and orderly Havildars. &c. the Native Adjutant will proceed to the Lines accompanied by the Orderly Drummer or Bugler, and there have the Roll beat, or Call sounded, as a signal for the attendance of a Havildar or Naigue, from each subdivision or Section, (in native dress) who having received the orders, will announce them in the Lines of their respective Sections.

31. All complaints, applications, or appeals, must be preferred through the regular channel of the Non-Commissioned and Native Commissioned Officer of the Company or Department, according to circumstances, to the European Officer thereof, on whom it will be incumbent to give his personal attention to their adjustment.

Young Officers especially should recollect that grievances which to them may appear frivolous, are frequently of serious import when considered with reference to the peculiar prejudices of the Men, and that even when the redress of such grievances may be impracticable, they still have it in their power, by listening with patience to the Soldier's statement, to convince him that his feelings have not been disregarded.

32. No man shall make any complaint

direct to the head of his Company unless the intermediate authorities have refused to forward it.

- 33. An individual is authorised to appeal direct to the Commanding Officer, only when his complaint is not attended to by the Officer of his Company
- Whenever any dispute or cause of complaint may arise between Men of different Companies, the European Officers of those Companies are, in communication with each other, to investigate and, if possible, adjust the same; when this may be found impracticable, the subject is to be submitted for the consideration of the Commanding Officer at Orderly hour.
- 35. Whenever from an Officer joining or quitting the Regiment, any change may be necessary in the charge of a Company,—notification thereof will be made in Regimental Orders, specifying the date for which the Command allowance is to be drawn by the relieved and relieving Officers respectively.
- 36. An Officer in charge of a Company, temporarily absent from the Corps, whether on duty or otherwise, within the Returns, shall not forfeit any part of his Command allowance, he being held responsible that the Books of his Company are properly kept up during his absence.
- 37. When an Officer in charge of a Company may be detached with any part thereof, he shall be entitled to the Command allowance, without reference to the limitation of the preceding paragraph:—if on detached duty, not involving the charge of any party, such as Courts Martial, &c. he shall be entitled to the

Command allowance, when so employed within the limits of the Division in which the Regiment is serving. In these cases the Company will be taken charge of by the Adjutant, or by such other Officer as the Commandant may select for the duty—the absent Officer being responsible for all attendant expenses.

- 38. In the event of any Company becoming vacant, it will be taken charge of by the Adjutant, should there be no Officer without a Company available for this purpose.—When there may be more than one Company vacant, the excess will be provided for in such manner as the Commanding Officer may at the time deem expedient.
- 39. As it is essential that the Flank Companies should at all times be kept complete, fit Men will be selected for them by the Commanding Officer, as may be requisite; and Captains of Flank Companies will also be allowed their pick of the Recruits.
- 40. Whenever any individual may be removed from one Company to another, the Officer of the Company from which he is removed shall furnish the other Officer with an Extract from the Company Register.
- 41. On the removal of a Man from any Company, all existing stoppage accounts are, if practicable, to be adjusted—the Officer drawing from the Regimental Pay Office the amount of stoppage to the Man's credit, and transmitting it, with an extract from the stoppage account book, to the Officer Commanding the Man's new Company. When the amount to the individual's credit may not at the time be known, as in the instance of

equipments having been supplied, the price of which may not have been determined, the extract from the stoppage account book will be sufficient.

42. The effects of all Men who may die and whose Heirs may be present with the Corps, will be made over to the Heirs, to be disposed of by them at their pleasure. When the Heirs may not be present with the Corps, it will be the duty of the Company Officer to cause a correct inventory to be made of the property, which will either be sold at outcry, or retained as the Commanding Officer may determine.

All such outcries are to be held at Roll call in the most public manner. The Orderly Havildar is to take the account of the proceeds.

- 43. No claims against the estates of deceased Men will be investigated, with the exception of Bazar debts within the prescribed bounds, or of debts contracted with the sanction of the European Officer agreeably to the provisions of Para II, Section XIV.
- 44. As it is desirable that the general character which is inserted in discharges, &c. should be as clear and expressive, and yet as concise, as possible, the following scale is invariably to be used.
 - 1. Unexceptionable.

2. Very Good.

3. Good,

4. Indifferent.

5. Bad.

6. Very Bad.

45 It is the duty of Officers to make themselves acquainted with the character of every Man under their Command, so as to be able to afford with justice both to the Service and to the individual, every information that may be required from them on the subject. Nothing evinces more culpable neglect in an Officer than his being obliged to refer for such information to another person.

Orderly Havildars and Naigues.

- 46. An orderly Havildar and Naigue shall be appointed in each Company, Monthly.—
 They are to be present with, and available for all duties of the Company, and are not to be detached or put on Guard or General duty, during their orderly tour.
- 47. The orderly Havildar will assist the Officer in making out his Morning Report, in detailing the Men for duty, command, &c. for the due performance of which, he may, if unable to write, employ a man to prepare the requisite memoranda, but the individual so employed is on no account to be excused from any duty, nor is he to have any authority in the Company further than as conterred upon him by his rank whatever it may be.
- 48. The orderly Havildar is to collect all reports of the Company, and deliver them to his Officer. He must attend daily at the Adjutant's Office for orders, and report them to the Officers of his Company.
 - 49. He will parade all men for duty.
- 50. The orderly Havildar will act as coverer on Parade, and is always to be provided with a Plummet.
- 51. He is to be relieved on the 20th of each month, and Officers Commanding Companies will notify to the Adjutant in writing the names of the Men for the ensuing month, that they may be published in Regimental orders
- 52. Every Havildar and Naigue in the Company, is to take his tour of these duties in re-

gular rotation, observing that whenever practicable the orderly Havildar and Naigue are to be one a Moosulman and one a Hindoo.

53. Officers Commanding Companies in sending to the Adjutant the Names of the orderly Havildar and Naigue for the ensuing month, will at the same time report the degree of intelligence and activity, or otherwise, evinced by those who have been relieved.

Orderly Naigues.

- 54. The orderly Naigue is to assist the orderly Havildar in the execution of his various duties. He is to accompany him when attending for orders, which he will report to the Native Officers of the Company.
- 55. He is to attend at the Hospital every morning at such hour as shall from time to time be specified in Regimental orders to receive all Men of his Company who may be discharged thence.
- 56 He shall take all Prisoners of his Company to the Parade of the Drill, properly dressed and accoursed, and shall return them to the place of confinement immediately upon the Drill being dismissed.
- 57. He shall Parade all Men of his Company ordered to Drill.
- 58. He shall convey to the Hospital any Man of his Company who may be taken sick.
- 59. Whenever severity of duty or other circumstances may necessitate the measure, and which will be notified in orders, the appointment of an orderly Naigue may be suspended.

Books of Companies and Depart= ments.

- 60 THE Books of Companies and Departments are to be in most exact conformity to the General Regulations.
- 61. Unless otherwise permitted by the Commanding Officer, Books of Companies are to be kept in the hand writing of the Captain of the Company, or of his Subaltern whose services are at his disposal for that as well as every other duty. The Books of the Adjutant's and Quarter Master's Companies may be kept by their respective Clerks.
- 62. The Commanding Officer will inspect the Books of Companies and Books of Instruction, Monthly, at such time and in such manner as he may from time to time see fit to direct.
- 63 Books of Departments will also be inspected whenever the Commanding Officer may think necessary.
- 64. No Officer shall ever quit the Regiment, on leave or otherwise, without first delivering over the Books of his Company to the Officer taking charge of it.
- 65. Books of Instruction are never to be taken from the Regiment by any Officer.
- 66. Officers Commanding Companies will be held responsible that those under them have all the ordered books in their possession and in good order?
 - 67. No Books or Records of Companies or

Departments, however old, are to be destroyed without the previous sanction of the Commanding Officer notified in Regimental Orders.

68. All Books are to be kept on Europe Paper—to be bound,—numbered,—and labelled on the outside to show what each contains.

Dress.

- 69. The following Regulations are established on the subject of Dress, &c. and the strictest attention is required thereto from all ranks.
 - 70. There are three orders of Dress for the Regiment, namely; Review Order,—Marching Order, light and heavy,—and Fatigue or Undress.
 - 71. For European Officers the "Review Order" is particularised in the General Regulations under the head "Dress,"

It is to be worn at Divine Service, Dress Parades, Guards, Field Days, General Inspections, Funeral Parties, and General, District, Garrison, and Cantonment Courts Martial and Courts of Inquiry.

72 In Marching Order, they are to wear the Undress Jacket, Forage Cap, Sash, and Waist Belt,—with,—unless otherwise directed, —Cloth Trowsers, in heavy marching order, and white Trowsers for all other duties.

This dress is to be worn at Drills, Ball Practice, Picquets, Working Parties, Fatigue Duties, Regimental Inspections, Regimental Courts Martial and Courts of Inquiry, Committees General and Regimental, Orderly Duty, and on the March.

- 73. THE Dress of the Native Officers corresponds with that of the Men as particularised in Para. 78, with the exception of the "Undress" and Knapsacks, &c. which are not applicable to the Commissioned Ranks.
- 74. The Native Officers are to wear Boots in "Review Order"—at all other times they are to wear a light sandal of the Regimental Pattern.
- 75. They are also to wear Gloves when in "Review Order" but at no other time—Gloves are not to be worn by any other of the Native Ranks.
- 76. The Native Officers are to wear Buff Leather Sword Knots, whitened, with a tassel of the same—and their Swords are to be hung perpendicularly down the left side.
- 77. They are to wear a plain crimson Silk Sash, similar to that of the European Officers, to go twice round the body and tie.

- 78. In "Review Order" the Men are to wear White Trowsers, unless otherwise ordered, and Turbands uncovered.
- In " Marching Order" Black Trowsers, unless Cloth are ordered, and Turbands covered.
- In " Light Marching Order" the same with the addition of Cloak, Carpet, and Havresack.
- In "Heavy Marching Order" Cloth Trowsers, unless otherwise ordered, and Knapsacks, &c. complete.
- In "Fatigue" or "Undress," covered Turband, White Jacket, and Black Trowsers.
- 79. Sword Knots for the Non-Commissioned Officers are to be of white leather.
- 80. The Havildar Major and Drill Havildar are to wear the same dress in every particular as the other Havildars of the Regiment. Their Rank is to be marked by the prescribed badge only.
- 81. All Ranks of the Regiment are to wear the hair cut close behind,
- 82. In order to ensure uniformity and adherence to orders, in the various particulars of dress, there are to be in each Company two Pattern Men.—They are to be selected by the Company Officer, and the strictest attention must be paid, to the correctness of their appointments in every respect,—The Officer will be held responsible that every Man of his Compa-

ny is dressed and equipped in exact conformity with the Pattern thus established.

- 83. The Pattern Men are to take their tours of all duties in common with the other Soldiers, with the exception of Detachments, on which they are only to go with the Head Quarters of the Company.
- 84. No Pattern Man is ever to be allowed to provide pipe clay for the Company—every Man is to be held responsible for the proper cleaning of his own accoutrements, and is himself to provide the necessary materials.
- 85. The Native Adjutant is to be considered the Pattern for the Native Commissioned Ranks, and the Havildar Major for the Non-Commissioned.
- 86. The Pattern Men, or one from each Company, according to circumstances, are to be paraded for the Commanding Officer's inspection, Monthly, at such time, and in such order of dress as may be directed.
- 87. Company Officers are held responsible for the Dress, Arms, and Accourtements, &c. of their Men—as well for their fitting, as for their correctness and good order.—When any alterations may be necessary requiring the aid of the Quarter Master, the individuals are to be sent to the Regimental Workshop accompanied by a Havildar or Naigue, with a Memorandum from the Officer.
- 88. Officers may employ Men of their Companies for the purpose of cleaning their Accoutrements, not interfering with duty: the same Man never being allowed to serve more than one Officer. No Non-Commissioned Officer or Naigue, is ever to be thus employed.

Particulars of Aress.

- must be made in exact conformity, in every respect, to the sealed Pattern lodged in the Quarter Master's Office.—It must be made to fit the Man's head well, and to come down forward on the brow, without inclining to either side,—especial care must be taken to prevent the Men from wearing the Turband thrown back on the head, or slouching on the ears, habits which they are prone to adopt if not duly checked, and than which nothing can have a more slovenly and un-soldier-like appearance. The cover must fit with exactness so as to prevent the brass being seen.
- 90. White Jacketor Ungreka.—The White Jacket must be made to fit with freedom but not too loosely, particularly the sleeves, which should not be larger than necessary at the wrist, and which are to reach below the Cuff of the Regimental Jacket. The Collar is to be made in every respect the same as the Pattern in the Quarter Master's Office. It is to be of three plies of Cloth, and to fit the neck, having two rows of stitching all round, and buttoning behind with three buttons.
- 91. Trowsers.—The Trowsers, both Woollen and Linen, are to fit neatly about the hips without being too tight, and to be made strait down from the hip to the instep, perfectly loose, so as to give the Men a full appearance. It is particularly to be observed, that the Trowser reaches freely to the instep, without, however, being too long or bagging, and that it is of a

proper breadth at bottom as the Men are apt to narrow it towards the ancle.

- 92. Sandals.—The Sandals are to be in strict conformity with the established pattern lodged in the Quarter Master's Office, and care must be taken that they fit the foot well.
- 93. Knapsacks—The Knapsack is to be worn high and firm against the back so as not only to be clear of the pouch, but to admit of easy access to it. It must be perfectly square and even on the back, and so secured as not readily to be displaced by the action of walking. The straps must be strait, from top to bottom.
- 94. Cloak and Carpet.—The Carpet and Cloak are to be folded flat, and of the dimensions of the Knapsack, under the back flap of which both are to be enclosed, care being taken that the Pack is not made unnecessarily thick.—When the Cloak is wet it must be packed up outside on the back of the Knapsack, flat.
- 95. In Light Maching Order, and when for Guard, the Cloak is to be folded flat, as tightly and compactly as possible, with the Carpet inside, and slung with the long Knapsack slings square on the back. When for Guard, the Cloak, &c. to be taken off at the Guard Room, unless ordered to be worn.
- 96. The Jumboo is to be fixed at the top of the Knapsack by a loop so fastened as to admit of its being easily taken off without assistance, when required; if assistance cannot be obtained at the time to replace it after using, the loop will admit of its being slung over the right shoulder. The cord to be about seventeen

yards long, made up into a hank and stowed inside the jumboo.

- 97. Havresack The Havresack is to be made of strong white cloth, bleached and washed, similar in every respect to the pattern lodged in the Quarter Master's Office. It is to be slung over the right shoulder, and above all the Accourrements, hanging down the left side two inches below the hip joint. The Men must not be permitted to wear the Havresack in front of the thigh.
- 98. The following Tables shew the description and quantity of necessaries required to be furnished and kept complete from the Pay of the different ranks.

- 99. Every article of Regimental necessaries is invariably to be legibly marked with the owner's Regimental number, and the number of the Regiment.
- 100 A Parade will be ordered for the inspection of the Men's necessaries once in each month, or oftener as the Commanding Officer may deem necessary. Every Individual, not in Hospital or on guard, is required to attend-Officers Commanding Companies will transmit to the Adjutant by orderly hour on the second day after such inspection, Reports made out agreeably to Form No. VIII.
- 101. Any Man who shall pawn, or sell, any of his necessaries, or shall assist another to do so, or who shall lend necessaries to another to shew at an inspection, shall be punished.
- 102. At all inspections the necessaries will be exhibited so as to display the numbers, which

will best enable Officers of Companies to ascertain that the articles belong to the Men who shew them.

- 103. Officers of Companies may have private inspections of necessaries at any morning or evening Roll call, not interfering with any Regimental duty.
- 104. All Non-Commissioned Officers, Drummers, Rank and File, are to carry their Knapsacks, in marching order. The only exceptions to this rule are the Havildar Major, Drill Havildar, and Musicians.

Arms and Accoutrements.

105. The Barrels of the Muskets are to be well cleaned and dried inside, and to be rubbed outside with an oiled rag and to be thoroughly dried. When it may be necessary to renew the browning, it must be done as directed in the General Regulations.

106. In cleaning the Firelock the Soldier is positively forbidden to take the barrel out of the stock, nor is the lock ever to be taken off but in presence of a Non-Commissioned Officer or Naigue. Although the Captain is held generally responsible for the arms of his Company, yet each stand of arms when delivered ever to the care of a Soldier is so fully in the individuals charge, that he will be answerable for any injury which he cannot prove before a Regimental Court Martial to have happened without carelessness on his part.

107. The use of Heel Ball is prohibited The Leather case of the Pouch, and inside of the Flap, must be occasionally fed with mutton fat so as at all times to remain clean and soft. The outside of the Pouch and all such parts as are exposed to view are to be well cleaned and polished with blacking and a shoe brush.

108. The inside of the Locks must be kept lightly oiled, and the Tins of the Pouches greased. They are to be taken out, and inspected by Officers of Companies at Roll Call, once a fortnight.

109. The Buff Belts must always be well whitened with Pipe Clay carefully mixed; all

Buckles are to be kept bright, and clear from the Pipe Clay.

- 110. The Belts may be occasionally washed, but in general not oftener than twice a year, and then not without the permission of the Commanding Officer. No man is to presume, on any account, to wash his Belts without orders.
- 111. In fi tting the Accourrements, the following Rules are to be observed.
- two inches below the elbow, and is to hang square and even to the man's back; in measuring this distance, and for which purpose each orderly Havildar will be provided with a light piece of wood two inches broad, the Man's hand is to be raised in a line with his elbow, the upper arm hanging straight down his right side, without constraint.

The Pouch is to be kept close to the Bayonet Frog by a strap of Buff Leather.

- 113. Bayonet.—The Bayonet is to be hung so low, and to the rear, that the left arm when strait by the side may be clear of it.
- 114. Breast Plate.—The Breast Plate is to lie fairly on the breast, immediately below the fourth button, the upper and lower corners of the Plate being in the line of the buttons. In fitting the Plate, no holesare to be made in the Belts with the exception of one in the lower belt for the hook. On the upper part of the belt is to be sewed a thin loop of Buff leather. In passing the Pouch Belt under the Breast Plate care must be had that it is as close as possible to the hook so that the Breast Plate may exactly coincide with the crossing of the Belt.

- 115. Pricker and Brush.—The Pricker and Brush to be suspended from the lower corner of the Breast Plate. The Chain or Strap to be nine inches in length, and to be worn over the waist belt on all occasions.
- of exactly the same breadth as the Waist Plate. The Buckle is always to be kept free from pipe clay so as to admit of the belt being readily lengthened or taken up. The Waist Belts are to be fitted and worn so as to be just above the bottom button of the jacket, but they are on no account to be loose or liable to slip.
- 117. Sword.—The Sword is to be slung at an uniform height, the hilt corresponding with the hollow of the side just above the hip. It is invariably to be properly buttoned in the Frog of the Belt.
- 118. In fitting Accourrements, Officers will observe that the Belts are never to be cut, nor are they to be pierced more than is absolutely necessary.
- 119. Whenever a Soldier's Arms' may be damaged or lost, immediate report must be made to the Officer of his Company.
- 120. All Arms and other Articles of Regimental Equipment requiring repair, or to be lodged in Store, are in the former case, to be taken to the Workshop by the Men to whom they belong, accompanied by the Orderly Havildar or Naigue of the Company; in the latter case, a Memorandum, signed by the Officer of the Company, is to be sent with them, which, being Countersigned by the Quarter Master, will be returned to the Officer as a voucher of receipt, and re-issue when required.

- 121. No Man shall use the arms, &c. of another, without orders, on pain of being punished.
- 122. The time and mode of cleaning the Arms and Accourrements will be fixed in Regimental Orders, and no men are to be permitted to take their Arms, &c. for the purpose of cleaning them except at the time so specified.
- 123. The Arms, &c. are to be taken from, and re-placed in the Racks in the presence of a Havildar or Naigue; on no account is this rule to be dispensed with.

SECTION XIII.

Clothing.

- t. On the arrival of Clothing for the Regiment, the Quarter Master will make a report to the Commanding Officer, in order that a Committee may be assembled for its immediate inspection.
- 2 The Bales are to be opened in presence of the Committee, and the Clothing to be carefully examined. It will be the duty of the Committee to reject and remark upon, in its proceedings, whatever may be damaged, or deficient.
- 3. When the clothing may be ready for issue, a Distribution Roll thereof shall be published in Regimental Orders, and Indents agreeably to Form No. 1X, shall be forwarded to the Quarter Master, by whom they will be submitted to the Commanding Officer for countersignature, which will be the authority for delivery.
- 4. The Clothing will be issued, with reference to the size of the various Companies, so as to fit them, generally, as well as possible; the Companies being paraded in Undress for that purpose: observing that when practicable the whole of the smallest size jackets, &c. are to be fitted before the next in size are issued and so on.
 - 5. After each Officer has fitted his Men he will parade those separately, whose Clothing

requires any material alteration, for the inspection of the Commanding Officer, who will order such changes between the different Companies as may tend to a better fitting with the least necessity of altering.

- 6. The Regiment will then be paraded without Arms, for the inspection of the Commanding Officer, who will issue such orders as he may think necessary.
- 7. No alteration in the Clothing shall at any time be made by the Soldier himself. Such number of Tailors as may be requisite will be placed under the orders of the Quarter Master, and Companies will attend, in succession, to have such alterations made as may have been pointed out by their Officers, and approved of by the Commandant.
- 8. It will be the duty of the Quarter Master to observe that no other alterations be made than such as may be requisite for the perfect fitting of the Clothing—none can be permitted in its fashion or ornaments, Wings and shoulder knots excepted.
- 9. When the Quarter Master may report that the whole have been fitted, the Regiment will be ordered to parade, without arms, for final inspection by the Commanding Officer, when Officers of Companies will make such observations to him on the fitting as they may consider necessary.
- 10. No Man shall shift or renew the lace upon his Jacket without the previous permission of his Company Officer, who will be held responsible for its being done in strict conformity with the established pattern.

SECTION XIV.

General Kules.

Officers.

Regiment, whether on their first appointment to the Service, or otherwise, are to go through the full course of Drill of a Private Soldier and Non-Commissioned Officer. They will be placed in a squad of Recruits, or of Men specially appointed for the occasion. This squad will be under the direction of the Adjutant, or, should his duties interfere, of an European Officer who will be nominated for that purpose by the Commanding Officer. This course of instruction will in no case be terminated till the individual may be perfectly Master of every point connected with his Drill.

Should it happen that an Officer to be drilled is Senior to the Adjutant, the squad will then be superintended by some Senior Officer who will be named for the duty.

- 2. When necessary in the opinion of the Commanding Officer, all the Captains and Subalterns will be formed into squads, and be exercised by the Adjutant under the immediate superintendance of the Commanding Officer or of the Major, in every part of the Foot and Musket Drill, the Sword Exercise, and in taking up distances.
 - 3 Officers upon joining the Regiment are to report themselves to the Adjutant, who will

note their arrival in the Regimental Reports, &c.

4. Whenever an Officer may be taken sick he will notify the same to the Surgeon, by whom the requisite reports will be made to the Adjutant. The Surgeon will also report the Officer's recovery.

An Officer absenting himself on the plea of sickness from Drill or other duty, shall immediately call for the attendance of the Medical Officer, and until reported by him sick or well, he shall not quit his quarters.

- 5. An Officer being on the sick report is required to restrict himself to his own quarters, Visiting, attending parties, &c. &c., cannot be allowed. When permitted by the Commanding Officer, at the recommendation of the Surgeon, to proceed abroad for air and exercise, the hours for which the indulgence may be sanctioned are to be specified in the Surgeon's recommendation.
- 6. No Officer is to exchange his Tour of Duty, General or Regimental, without previously obtaining the sanction of the Commanding Officer.
- 7. All applications from Officers for leave of absence, whether Division or General, must be made to the Commanding Officer at Orderly hour, and Officers are strictly prohibited from making such applications to the Superoff authorities direct.
- 8. It is to be observed with reference to Para. 3, Section 1, that all applications for Leave, &c. from Subaltern Officers must be made through the Captains of their Companies.

- 9 Officers proceeding on leave of absence are required to lodge a Memorandum of their address in the Adjutant's Office, and they will notify any subsequent change therein.
- 10. When an Officer obtains permission to be absent from Parade, &c. notification there-of is invariably to be made to the Adjutant.
- 11. Should an Officer be from home when the order Book goes round, it will be his duty on his return to inform himself of the nature of the order issued.
- 12. Any Officer wishing to refer to General Orders, or other public records, must do so at the Adjutant's Office.
- 13. Whenever an official Memorandum or pass order may be circulated, Officers concerned are to affix their initials thereto in proof of its having been seen by them.
- 14. Every Officer joining the Corps from furlough or duty is to make himself acquainted with the orders which have been issued during his absence.
- 15. All documents, of whatever nature, requiring the countersignature of the Commanding Officer, or of the Staff by his order, are to be made out on Europe paper.
- 16. The Adjutant and Quarter Master respectively will be held responsible for the perfect correctness of every document submitted by them for the Signature of the Commandant, and it will, therefore, be their duty to return to Officers such as may be transmitted to them and which, on examination, may be found to be in any manner incorrect.

- 17. The Orderly Hour of the Regiment will be notified from time to time in Regimental Orders as may be requisite.
- Martial, and Courts of Inquiry or Requests, will not be liable to the performance of Regimental Duty, other than the interior charge of their Companies, and their attendance at Drill or parade, excepting on such days as the Court may not sit, is dispensed with. The Adjutant and Interpreter are not, however expected to take advantage of this order unless the sittings of the Court may actually interfere with the execution of their Regimental Duty. Unless otherwise directed by superior authority, ordinary Committees will not exouerate Officers from any part of their Regimental Duty, except that when such Committees may assemble at the same time as that ordered for any Regimental Duty, the former will, of course, have the preference.

An Officer being warned as next for guard is not to be put on duty as orderly Officer,—if on that duty he is to be relieved. An Officer being on Guard, however, may be ordered for duty as Orderly Officer on his relief should the limited number of Officers for duty render it necessary in the opinion of the Commanding Officer. In this case the Guards will be marched off by the Adjutant, and the Orderly Officer of the previous day will remain on duty until the other comes off Guard.

19 All Officers are desired to pay particular attention to the manner in which the Men of the Corps do their duty, and too take proper notice of any neglect or slovenly conduct which may come under their observations, by

admonishing or reporting the individuals whether belonging to their own Companies or not.

20. Every Officer must see the necessity of at all times paying the customary marks of respect to his superiors, as intimately connected with the first principles of discipline, and it is not, therefore, deemed requisite to prescribe any particular rules on this head, further than to observe that the Officer in Command of the Regiment is at all times to be acknowledged as such, by the usual compliment from all Officers.

The Senior Officer on every Parade, or other occasion of duty, is also entitled to the salute of the hand, from all Junior Officers, on arriving on or quitting the Parade, &c.

General Rules.

Native Ranks.

- 1: The most perfect harmony and good feeling should subsist amongst Soldiers, and any man who uses reproachful or abusive language to, or strikes another, shall be punished. Whenever disputes may unfortunately arise, they shall be submitted through Heads of Sections and Sub-divisions to the Company Officer.
- 2. All gaming, of whatever nature, amongst the men, is strictly forbidden. Lotteries of all kinds are included in this restriction.
- 3. If a Soldier conceives that he has any cause of complaint, he is to mention it to the Non-Commissioned Officer of his Section, and it will be the duty of the Subadar either to go with the man or send with him the Jemadar or Orderly Havildar, to the European Officer of the Company, who will immediately examine into, and redress, or report the grievance to the Commanding Officer, as the case may require: and no offence shall ever be taken at a man making a complaint in a proper manner, although when the matter is enquired into, he may prove to be mistaken. If he be right, justice shall immediately be done him.
- 4. Soldiers who may have a representation to make, are to take an opportunity of doing it when they are not on duty, but any man who murmurs or even speaks on Parade, at Drill, or other duties, unless in answer to some question put to him by a Superior, shall be liable to punishment.

- 5. If any Soldier who conceives himself to be ill treated by a Non-Commissioned Officer, shall, in return, make use of threatening or provoking words of actions, instead of taking the proper means of redress before pointed out,—he shall be liable to punishment for the breach of Military Discipline, notwithstanding that on enquiry the Non-Commissioned Officer may be found to have been to blame in the first instance. The same rule is equally applicable to disputes between a Non-Commissioned Officer and another of higher rank.
- 6 If any Non-Commissioned Officer or Soldier conceives himself to be insulted by any person not in the Service, or by a Soldier of another Corps, without provocation, he is to make a complaint to the Commanding Officer, through the Officer Commanding his Company; and every means will be used to obtain satisfaction for him; but, if he shall take the law into his own hands, by striking or fighting with any person with whom he may have quarrelled, he shall be liable to punishment, notwithstanding he may have received provocation.
 - 7. Any Officer or Non-Commissioned Officer who finds a Soldier of the Corps quarelling in the streets, is immediately to order him to the Lines, and, if necessary, to confine him.
 - 8. Any man who shall presume to give a false name, or to run away, when called by his superior, will render himself liable to punishment.
 - 9. Any Soldier who finds money or other articles, or who wishes to purchase any thing

about which doubt can exist, especially in the case of Regimental necessaries, is immediately to acquaint the Non-Commissioned Officer of his Section in order that due scrutiny may be had. Should lost or stolen property be found in any man's possession without such report having been made by him, he will be liable to punishment as a thief.

- whatever time and under whatever circumstances, will be liable to punishment—The sale of intoxicating liquors or drugs, within the Regimental Lines, is most positively prohibited.—Any Native Officer or Non-Commissioned Officer indulging in their use, will be marked as unworthy of his Rank. Every exertion must be made to check the progress of drunkenness amongst the men, and their frequenting Arrack or Toddy Shops should, as far as practicable, be prevented.
- 11. It is positively forbidden to the Men of the Regiment to borrow Money from, or lend it to, one another, directly or indirectly, or to be engaged in any transaction whatever which shall establish a Debtor and Creditor account between the parties, without the express permission of the European Officer of the Company,—and in no case shall Interest be allowed.

No complaint arising out of pecuniary transactions at variance with this Order, will, consequently, be attended to, further than that any Money proved to have been so lent will, on being recovered from the borrower, be appropriated to such public purpose of the Regiment as the Commanding Officer may think fit to determine.

A Native Officer, Havildar, or Naigue, shall not at any time be permitted to borrow Money from his inferiors in the Regiment.

- 12. No men of the Regiment are ever to be employed on duties of fatigue without the previous sanction of the Commanding Officer, notified in Orders.
- 13. Applications for permission to beat Tom Toms in the Regimental Lines must be made to the Adjutant before Orderly Hour of the day on which the leave is required.
- description of Music such as the Sitar, or similar instruments. Dholkee, Singing, &c., at their own houses, without any application for leave.
- any time appearing in mixed costume; either they must wear all or no part of their Uniform. Thus the Regimental Jacket can never be permitted to be worn with any but the Regimental Trowsers. Especially are they forbidden to wear a Cloth or Kerchief of any kind with or about the Regimental Turband,
- 16. Respect to their Superiors in every situation, must be conspicuous in the Men of the Regiment, and every instance of the contrary will invariably meet with punishment.
- 17. It is the duty of the Native Commissioned and Non-Commissioned Officers and Soldiers to pay the proper compliments to Officers of other Regiments, as to those of their own Corps.
- 18. When a Non-Commissioned Officer, or other, without arms, or with side arms only, meets an Officer, he will continue to move on,

and will salute with the right hand, in the ordered mode, looking at the same time in a respectful and soldierlike manner towards the Officer.


- 19. Non-Commissioned Officers and Soldiers, with Arms, are to carry them when passing an Officer, continuing to move on.
- 20. Non-Commissioned or others when speaking to an Officer, without Arms, are to salute on first approaching him, and are then totake the hand down, saluting again on going away.
- 21. If with Arms, they will stand steady at the position of attention, with carried Arms, whether shouldered or advanced.
- 22. When entering a room to accost an Officer, they will salute on first coming in, and are then to stand at attention; on withdrawing, they are again to salute, face about, and retire leisurely and respectfully.—Drummers or Musicians are never to take off their Caps on such occasions.
- 23. When any Officer visits the Barracks, the first man by whom he is seen is to give notice by the word "attention!" in a loud voice on which every Man is to stand up, and remain perfectly silent, but not to Salute.
 - 24. When an European Officer visits a Company at Roll Call, the Native Officer will immediately give the word "attention!"—when every man is to stand to his front, and continue in that position, without saluting, until further orders.
 - 25. Towards the Havildar Major of the Regiment the same marks of respect are to be paid

as towards the Native Officers, with the exception of compliments from Sentinels;—towards all other Havildars, the greatest respect, but no Salutes: all Commands from them to be received at the position of attention.

- 26. No Commissioned, Non-Commissioned Officer, or other, when dressed in unifom, is ever to make use of the Native Salam in acknowledging an Officer.—When in their Native Dress, they may, at their pleasure, salute in the usual Military Style, or make the Native Salam.
- 27. Not only are all inferiors to shew the above ordered marks of respect to their superiors in their several Ranks, but all superiors, whether Commissioned or Non-Commissioned Officers, shall insist upon the same, never permitting, without reprimand, the smallest inattention from those who are subordinate.
- 28. All Men attending at the quarters of an Officer on duty, or appearing before Committees, as witnesses at Courts of Inquiry, &c. &c. are to be dressed in Regimentals and with side arms.
- 29. On other occasions, not off duty, they are permitted to visit their Officers in a clean and respectable Native dress.
- 30. When attending Reviews of other Corps, they are to appear in "Review Order," and with side arms.
- 31. No Man shall assume the appearance of a Fukeer, or Byragee, in his dress or person, on or off duty, without the special sanction of the Commanding Officer.
 - 32. No Man is to be absent from the Re-

gimental Lines after Tattoo beating, without leave from his Company Officer.

- 33. No Man shall presume to take up his abode elsewhere than in the Regimental Lines.
- 34. Whenever a Man present with the Regiment may have any application to make, or complaint to prefer, he shall do so verbally. Written Petitions will not be received.
- 35. Any individual presenting a letter to be franked by the Commanding Officer which is not bonâ fide his own, will be subject to punishment as guilty of a serious fraud.



SECTION XV.

Native Festivals, etc.

- 1. THE Festivals for which general leave will be granted to the different casts, are specified in the general Regulations.
- 2 The annexed Tables contain the particulars of leave which will be granted to individuals on occasions of Marriages, and Deaths—and by which Officers of Companies are to be guided in making applications to the Commanding Officer.



- 3. The Assistants required on occasions of Deaths will be given at once on the authority of the Adjutant, as the delay which would be occasioned by a previous reference to Officers of Companies, might prove extremely inconvenient.
- 4. The Men for this duty may be selected at the pleasure of the parties, the Men themselves being willing;—when necessary, however, the requisite number, of the proper Cast, will be detailed as for a regular Tour of Duty.
- 5. The limitations given in the preceding Tables are not intended to apply to Native Officers, in whose instance Officers of Companies will exercise their discretion as to the extent of leave to be applied for.



SECTION XVI.

Officer of the Day.

1. THERE will at all times be an Orderly

Officer of the day.

2. The Officer of the day will mount with the Regimental Guards of which he has the general superintendence.

- 3. He is on no account to quit the lines of the Regiment, during his tour of duty, and when absent from his own quarters, he must leave word where he is to be found.
- 4. He is to visit the Barracks, Hospital, and all Regimental Guards, observing that the Arms and Accoutrements are properly lodged and hung up, and that the cocks of the muskets are let down,—that the sick are in proper order,—and during the prescribed hours, that not more than one-third of any Guard are absent from their posts: ascertaining that all have been made duly acquainted with the Parole, and issuing such instructions for the night as he may deem requisite.
- 5. Whenever circumstances may necessitate the relief of any man on duty, notification thereof will be made by the Orderly Officer to the Adjutant.
- 6. The Officer of the day is responsible to the Commanding Officer for the preservation of Order within the lines of the Corps. In the event of fire-breaking out, or disturbance arising, it is his duty immediately to repair to the

spot, and to adopt such measures as the case may require.

- 7. The Officer of the day when out of his quarters must invariably appear completely dressed and accoursed, to denote his being on duty.
- 8. The Officer of the day shall be liable to the performance of every ordinary duty of the Regiment. Thus he will attend all Parades and Drills, unless when otherwise directed, and he will be available for all Committees and Courts Martial, when their sittings may not interfere with his duty as Orderly Officer.
- 9. When he visits the Hospital he shall examine the condition of the Patients with respect to clothing, cleanliness, and attendance, ascertaining by personal inquiry of the Men, whether they have any cause of complaint, or are in want of any thing, and reporting accordingly.
- 10. The Officer of the Day on receiving a charge against any Man placed in confinement will, after entering it in his Report, immediately forward it to the Adjutant.
- 11. On Sundays it will be the duty of the Orderly Officer to ascertain that the Serjeants, and such of the Drummers and Musicians as are either of European or Indo British Birth, regularly attend the performance of Divine Service, according to their respective persuasions, and he will note the circumstance in his Report.
- 12. On being relieved he will transmit to the Commanding Officer a report agreeably to Form No. X, delivering a similar one, on the Guard Parade, to the Officer by whom he is relieved.

SECTION XVII.

Native Officer of the Day.

- 1. A Native Officer of the Day will be appointed, whose duty it will be to assist the European Orderly Officer, under whose immediate Orders he is placed. At Guard mounting he will fall in with the Barrack Guard.
- 2. He is held responsible for the preservation of order within the Native Lines of the Corps, reporting to the Orderly Officer all irregularities which may come to his knowledge.
- 3. He is to visit the Barracks, Hospital, and Guards, and to go Night Rounds, at such time as may be directed by the Orderly Officer, and he is never to appear beyond his own quarters otherwise than completely dressed and accounted.
- 4. He is to visit the Regimental Schools at any uncertain time during the day, observing whether Teachers and Scholars are all present, and reporting to the Orderly Officer accordingly.
- 5. He is to assemble the Commandants of Guards on being relieved, and accompanied by them, to report the completion of the Relief to the Orderly Officer.

SECTION XVIII,

Regimental Guards.

- 1. The Regimental Guards are to be paraded and inspected every morning by the Adjutant at an hour which will be specified in Regimental Orders.
- 2. The rejection of every individual deemed by him unfit to go on duty from being improperly or dirtily dressed, &c., is to be reported by the Orderly Havildar of the Company to his Officer. It is to be considered as a Standing Order that every Man so rejected shall be sent to Extra Drill and shall also make up his tour of duty, remaining at Drill until that shall have been performed, or for a longer period if ordered.
- 3. The Guards are to be given over with the prescribed forms to the Officer of the Day coming on duty, the Native Officer of the Day falling in with the Barrack Guard. Their strength will be fixed in Regimental Orders, in which will also be published every change which may be directed in that particular, or in their Stations.
- 4. The full forms of Guard Mounting are to be observed unless prevented by the weather, or unless the Regiment has been out for Parade or Exercise, in which case the Guards, after inspection, will be dismissed to their posts with out further ceremony.

- 5. The strictest adherence is required to the General Regulations on the subject of "Duties in Garrison," which, with a few obvious alterations, are equally applicable to Regimental Duties. The Reports therein directed to be made to the Field Officer, Main Guard, &c. are to be made to the Orderly Officer, Barrack Guard, &c.
- 6. The Havildar, Naigue, or Lance Naigue, Commanding any Guard, is on no account to quit it during his tour of duty.
- 7. All Sentinels must be taught firmly to enforce the orders of their Posts, without respect of persons.—It opposed or resisted, they will call to the Guards for assistance.—It will be the especial duty of the European Officers to instil this important principle into the minds of the Men, both by their own prompt submission to the orders of every Sentinel, and by their strict notice of any remission on his part in exacting such submission.
- S. Whenever any Man may be placed in confinement, or released therefrom, a report is to be made to the Commanding Officer, Adjutant, and Officers of the Day, European and Native.—Notification is also to be made, if requisite, to the Orderly Havildar of the Company, or to the head of the Department, to which the Prisoner may belong—When the Prisoner may be a Camp Follower, not in the Regiment, notification will be made to the Havildar Major.
- 9. As a general rule, Prisoners are only to be confined in the Barrack, Hospital, and Bazar Guards—In the first, Military Offenders: in the second, Sick and Hospital Attendants: and in the last, Camp Followers.—In cases of emer-

gency, however, offenders might be confined in the nearest Guard, without distinction.

- 10. The Regimental Guards are not to leave their Posts to join the Corps for Drill or Parade. When their attendance may be required at General Reviews, Inspection, or Muster, it will be specified in Regimental Orders.
- 11. The orders for each particular Guard, and the rules respecting the honors and Compliments to be paid to different Officers, &c. &c. are to be legibly written in Hindoostanee, Teloogo, and Tamil, and hung up in each Guard Room. These are to be provided, and renewed, when necessary, by the Interpreter of the Regiment, in communication with the Adjutant.
- 12. All Orders issued to any Guard, intended for its guidance beyond the same day, are to be forthwith entered in these Boards—and, in like manner, all existing Orders, rescinded, are to be immediately erased.
- 13. The number of Sentinels required for the security of the Arms, &c. of the Regiment, will depend upon local circumstances;—no fixed rule can, consequently, be laid down on this head—It is to be observed, however, that wherever situated, and under whatever circumstances, this duty is to be conducted strictly in accordance with the established regulations for Guards.

The Commanding Officer will issue such instructions on this subject as the localities of the Barracks may render necessary, but Kote or Company Guards, as hitherto sanctioned, are henceforth entirely prohibited.

- 14. In order to ensure the requisite degree of regularity in keeping the Roster, the following rules are to be generally observed.
- 15. European Officers—The Adjutant's Roster to be kept from Senior to Junior of each class. There is to be one Roster for Guard—a second for Courts Martial superior to Regimental—a third for all other general duties, and a fourth for all Regimental duties, so as to give each Officer as fair a proportion as practicable of each description of duty.

For Detachments,—Officers to go with their Companies, unless the Commanding Officer may select for the duty.

- 16. Native Officers.—As for European Officers, Subadars and Jemadars being separately Rostered.
- 17. When different duties may fall to any individual to be performed at the same time, to tour will go according to the general regulations.
- 18. Non-Commissioned Officers and Naigues.

 The Adjutant's Roster of these Ranks to be kept from Senior to Junior of each—for Ordinary Duties the Roster to be in the Form prescribed for Privates, (No. 2.)—For Detachments a separate Roster.
- 19. Privates.—The Adjutant's Roster to be kept by Companies agreeably to the annexed Form No. 1.—Each Company being rated for its quota (not, however, for a less number than three Privates). Detachments to be Rostered separately.
 - 20. The individual Roster of Privates to be

kept by Company Officers agreeably to the annexed Form No 2, running, for all ordinary duties, from No. 1, upwards.—Detachments to be Rostered separately.

21. In telling off Guards the following system is to be observed.

The details for duty from each Company being brought up by their respective Orderly Havildars, Honorary Guards, and Orderlies, are first to be selected. The remaining Privates are then to be arranged by Companies—Grenadiers and Light Infantry on the right, which will always be assigned to them—Battalion Companies to follow in order of number, but successively changing—thus, No. 1. takes their right to-day. No 2. to-morrow. No: 1. going to the left No 3 the next day, No 2, going to the left of No 1, and so on. The Guards required according to the List, which is always to be in the Havildar Major's possession, are then to be told off from the right of all, which process will generally afford a fair change of Guard to all in succession

The Havildars and Naigues to be drawn up, each Rank indiscriminately, and to be told off at the Adjutant's pleasure, from Right to Left,—Left to Right,—Flanks to Centre,—or Centre to Flanks.—This will place all upon an equal footing in respect to choice of guards, at the same time that all possibility of collusion will be prevented.

22. In order, however, to combine the comfort of the Men as much as possible with a fair distribution of duty, it is directed that the Details of the ensuing day's duty be paraded at Evening Roll Call (in their Roll Call Dress) and

then told off, as above directed, in readiness for the morning. This may be done by the Native Adjutant or Havildar Major subject to the revision of the Adjutant or Officer parading the Guards the following morning.

- 23. Duties of Detachment are to be taken from the right, from Companies, Nos. I to 6 inclusive.—Thus, a Company being required for Detachment, No I, as first on the Roster, goes.—A Detachment less than a Company being next required, No. 2, gives it, and having commenced, continues to give all such minor detachments until exhausted—If, in the mean time, another full Company be required, No. 3, will be detailed, and so on.
- 24. The Adjutant is himself to superintend his several Rosters.
- 25. Officers of Companies are required to keep their own Rosters of Privates, themselves detailing the individuals for Duty.
- 26. The Commanding Officer will call for and inspect the above Rosters whenever he thinks necessary.

SECTION XIX.

Parade and Drill.

- 1. The Men are never to commence assembling before the passing of the ordered signal for that purpose.
- 2. One Bugler and one Drummer will attend the Commanding Officer at all Parades and Drills.
- 3. The Adjutant will give the time for the different signals and calls for the assembly of the Regiment for Parade, Drill, or other purpose, according to the orders of the Commanding Officer.
- 4. For Parades and Drills the following signals will be used:

If by Bugle, preceded by the distinguishing Regimental Call;—

- 1. 'The "Parade Call" for all to Dress and turn out.
- 2. The "Assembly"—the Men to assemble for inspection by squads and to form Company under the European Officers, on their private Parades.
- 3. The "Form Column"—for Officers to form their Companies on the Regimental Parade.

The "Officers Call" will be sounded if the Commanding Officer should wish for the attendance of Officers;—otherwise, they are not required to quit their Companies.

If by Drum,

- 1. The Taps and Drummers' Call.
- 2. The Long Roll, and
- 3. The Assembly.
- 5. Should the Commanding Officer not have arrived at the last signal, the Adjutant will make his report to the Senior Officer present who will assume Command.
- 6. On all occasions of Parade, &c., Officers are required themselves to tell off, inspect, and prove their Companies, in the fullest manner.
- 7. The greatest attention is required to the strict and punctual performance of the inspection. Officers must carefully observe whether the Arms, Accontrements, &c, are all clean and in good order—the Ammunition complete and fit for Service, and the Arms well flinted.—If in marching order, that the Knapsacks are well packed and carried according to order, occasionally examining their contents to prevent the Men from crowding them with articles not required.
- S. The Pouches are invariably to be examined, and more particularly when the Men are to fire Blank Cartridge, when an omission of this essential duty may be the cause of serious accident.
- 9. On the conclusion of a Field Day Companies will be inspected, and should any Muskets remain loaded, the Officers will particularly examine the Flints, and should it appear that the Muskets have missed fire in consequence of the Flints being badly fixed, the Menmust be punished.

- wise ordered, the Adjutant will make a verbal report to the Commanding Officer of the number of Files under Arms, and number, if any, absent without leave. The reports of Companies are to be collected verbally from the Orderly Havildars, who will attend on a Signal from the Havildar Major for that purpose.
- Parade for inspection in Marching Order the following system is to be observed.—On the order for Officers to inspect their Companies, the Officers, if with closed ranks, will take open order, and will first examine the Arms and Accoutrements:—then, Piling Arms, the Men remaining at open order, the Rear Rank will be directed to face about and the word will be given, "Open Packs" on which every Man will unsling and open his Pack, and spread its Contents for inspection. As each Pack is examined, the Man will re-pack and sling it. All having concluded, the Rear Rank will be ordered to front. The Arms being unpiled, Ranks will be closed, and the Company will stand at ease and await further orders.
- 12. With the exception of the Field Officers and Adjutant, no Officer is to appear mounted on Parade unless the Second in Command is specially ordered, on any particular occasion.
- 13. When the Commanding Officer may appear on the Parade dismounted, the Field Officers and Adjutant will also dismount, unless ordered to the contrary.
- 14. There will be Roll Call once a day, at least,—Morning or Evening,—unless the Regiment may be otherwise employed, or speci-

ally exonerated therefrom on particular occasions. The hour and place will be determined from time to time by the Commanding Officer as may be expedient.

15 At Roll Call the Native Officers and Men are permitted to appear in their own Dress, unless it may be otherwise directed, The Native Adjutant, Staff and Orderly Non-Commissioned, &c., are to attend in Regimentals.

SECTION XX.

Target Practice.

- 1. Each Company will fire once Monthly, or oftener as may be ordered. No Soldier, excepting the Sick in Hospital, is ever to be absent. The practice of the Target is to be considered prior to all other duties; and no duty which has been interrupted for this one is ever to be brought up.
- 2. When Companies practice separately, the firing, unless otherwise ordered by the Commanding Officer, is never to be by more than one file at a time. The practice shall generally be by single shots, each Man taking his own time and method of firing. It may also occasionally be by files in the ranks, but not by a greater number. Each Man is, for the first round, to load separately, under the superintendence of the Officer.
- 3. Change of position is an object much to be attended to, in the instruction of the Men. When firing with Blank Cartridge, they should be accustomed to level at different moving objects, and for the perfection of their Target Practice, a moveable Target will occasionally be used. The ground cannot be too much varied for Target Practice—Woods, heights, hollows, plains, brushwood, water, in short every description of surface should be fired over. The Trunks of Trees, or other objects, should also be occasionally fired at in lieu of the regular Targets.

4. The Officers are requested to encourage their Men, in every way, to become expert at the Target.

The Officers themselves may practice with them, for which purpose they are allowed to indent for extra cartridges in the same proportion as issued to the Men.

5. All Non-Commissioned Officers, Drummers, and Musicians, not specially exonerated therefrom, are to fire with their Companies, on all occasions of separate Company Practice.

SECTION XXI.


Colors.

- 1. THE Regimental Colors will be lodged in the Barrack Guard. They are to be placed by themselves, distinct from all other articles which may be in the Guard, carefully cased, and under charge of a Sentry.
- 2. When required to be taken thence, on occasions of Parade, &c. the two Jemadars for duty accompanied by the Color Havildars told off for the Centre, will attend at the Barrack Guard. The Colors, if necessary, are to be uncased. The Commanding Officer having arrived on the Parade, and Officers having taken post with their Companies, the Colors are then to be brought from the Barrack Guard and to assume their station with the Regiment. The Barrack Guard, which is always to turn out on these occasions, is to present Arms to the Colors, cased or uncased, on their quitting the Guard Room.—The Regiment is to receive them with Shouldered Arms.
 - 3. In returning them to the Barrack Guard, similar ceremony is to be observed —The Regiment remaining with Shouldered Arms, and the Officers in the Ranks, on the order to "Lodge the Colors," the Jemadars and Escort of Color Havildars, will proceed to the Barrack Guard, which is to receive them with Presented Arms, and there case and lodge the Colors, and until this be done the Regiment is not to be dismissed.

- 4. Whenever it may be necessary for any particular purpose to take the Colors from the Guard Room, the Regiment not being under Arms, the Escort to attend them shall consist of a Sub-division of the Grenadiers or Light Infantry.
- 5. Every Saturday Morning, at such hour as may from time to time be prescribed, weather permitting, the Subadar Major, attended by two Jemadars and two Color Havildars, will take out the Colors, uncase, and air them, and at the same time the latter will clean the Spears and Ferrules. The Colors are to be exposed to the air for a period of not less than half an hour. The Barrack Guard is to present arms both on their being taken out and displayed, and on their being re-lodged. Should the Subadar Major be prevented from attending by duty or other cause, an Officer will be named in his lieu.
- 6. In marching order, when marching, and in Camp, the Colors will be kept cased unless otherwise ordered.
- 7. In Camp the Colors, weather permitting, are to be planted in front of the centre of the line, with the Drums—and double Sentries will be posted for their protection.—On the Regiment getting under Arms, no ceremony will be required further than that the Colors are not to take post until the men have all fallen in, and the Officers have joined their Companies—the Sentries remaining for their protection until that time.
- 8. On arriving at the new ground, the Colors, if uncased, are to be re-cased before the Officers quit the Ranks;—and unfil the ordered Sentries be posted for their protection, their

Escort of Color Havildars will remain with them.

9. Every person of whatever Rank, on passing the Colors, when uncased, is to salute them.



SECTION XXII.

Recruits and Adjutant's Drill.

- 1. Every individual proposed to be enlisted in the Regiment, whether Soldier, Drummer, Boy, Puckally, or Lascar, shall, after being approved of by the Commanding Officer, be carefully examined by the Surgeon, without whose final approval the enlistment will not be made.
- 2. A Register made out agreeably to Form No. XI, will be kept in the Adjutant's Office, and will be sent with the Men to the Surgeon, who, after examination, will insert in the column of remarks his opinion as to the fitness or otherwise of each, filling up also the column of Age.
- 3. The Quarter Master will have a similar Register for the Regimental Lascars and Puckallies.
- 4. The Surgeon will vaccinate every individual, on enlistment, who cannot shew to his satisfaction that he has had the Small-Pox or has been vaccinated.
- 5. All Recruits joining the Regiment from Recruiting Parties will be examined by a Committee to be composed of the Major or other available Officer, the Adjutant, and the Surgeon.
- 6. All Recruits or others, enlisted, or joining the Regiment from Recruiting Parties, are to be paraded in presence of the Commanding

Officer or Major for the purpose of having the 1st and 4th Sections of the Articles of War, and such of the Standing Orders as he may direct, read and explained to them by the Interpreter.

- 7. Every Recruit enlisted, or joining the Regiment, is to be taken for the inspection of the Officer Commanding the Company to which he may be posted. The Officer will see that he is provided with the ordered Drill Dress as soon as possible, to wit, a black Kerchieffor the head, White Jacket, Black Trowsers, and Sandals. Collars are not to be worn by Recruits except on occasions of Parade.
- 8. Whenever a Recruit is enlisted, or a Boy transferred to the ranks, the Adjutant will furnish the Officer Commanding the Company to which he may be posted with an extract from the Regimental Register.
- 9. A stoppage agreeably to the scale prescribed in Section XII, Paragraph 22, is to be made from the pay of each Recruit for the provision of the requisite equipments, and the Officer Commanding the Company will be held responsible that those articles are furnished, and the Men's accounts adjusted, with the least possible delay.
- 10. All Recruits are to receive their Pay in two Instalments, until they commence firing, when they shall receive it in one issue—This change will be duly notified to Officers Commanding Companies by the Adjutant
- 11. The Recruits until dismissed Drill, are to be under the immediate control of the Adjutant in all matters of duty, discipline, and leave. By leave is intended present leave on particular occasions only. No Recruit at Drill

will be granted furlough from the Regiment, unless on very urgent occasions.

- est attention is required on the part of every instructor—each Recruit must be made individually to comprehend the meaning and utility of each thing that he is taught. The signification and correct pronunciation of every English word used in the Drill must be well impressed upon his memory. When the Adjutant may consider the Recruit sufficiently acquainted with his Drill to commence firing, he will inform the Commanding Officer. The Recruits will practice first with blank cartridge, and subsequently with ball. They will fire once a day only, and always in the morning when practicable.
- 13. Every Recruit is individually to be thoroughly instructed in Sentry duty. He must be patiently taught the correct enunciation of each English word used in Challenging, &c., and he must be made to learn, by heart, the exact signification. The re-assembly of Men posted as Guards and Sentries is always to be performed by the formation of the Rallying Square. This rule applies also to the Boys who will thus be accustomed to this essential manœuvre.
- 14. Every Recruit is further to be instructed in the duties of Light Infantry, it being essential to the efficiency of the Regiment that every individual should be competent to act as a skirmisher.
- 15. The ammunition required for the practice of the Recruits will be drawn by the Adjutant.

- 16. Recruits are never to be employed on duties of fatigue during the period of their Drill.
- 17. All Recruits before joining their Companies are to mount Guard as Supernumeraries for such period as the Adjutant may consider necessary.
- 18. If any Non-Commissioned Officer or other person employed as an instructor at the Drill be known to receive the slightest present from any Recruit, or to employ him in any manner, even to clean his Accoutrements, he will be forthwith dismissed from his situation at the Drill, besides receiving such further punishment as may be deemed necessary by the Commanding Officer.
- 19. When the Adjutant may consider any of the Recruits qualified to join their Companies, he will report the same to the Commanding Officer:—if approved of by him they will then be exonerated from the Drill, and a Parade will be ordered for the purpose of administering the Oath of fidelity, previous to which no Recruit is to be admitted into the Ranks.
- 20. This ceremony will be performed in the following manner.

The Regiment, in Review Order, will be formed in three sides of a square, facing inwards, and at open order.—The Recruits, in Review Order but without Arms, to be drawn up under the Havildar Major on the fourth side, fronting the Regiment, Moosulmans, Hindóos, &c., arranged in succession—A Havildar from each of the Companies to which the Recruits belong, to attend in rear of the Centre of the Regiment

with the Men's Arms.—The Colors will be advanced sufficiently in front of the Centre, and countermarched to face the Regiment.


The following Oath will then be administered to each Individual under the Colors by his respective Priest or Gooroo.

"I.........., Private, do swear that I will serve the Government with truth and loyalty, and that I will faithfully obey the orders of all Officers set over me, I do also swear that I will never abandon these Colors and that I will defend them with my life."

The Oath having been administered to the whole, the Colors will be wheeled back on the right and left forming a Street, through which the Recruits will file and pass to the rear of the Regiment through the Centre. The Recruits will then receive their Arms from the Havildars, who will march them to their respective Companies in which the necessary vacancies will have been preserved for the purpose.

The Colors will then resume their station under the compliment of Presented Arms from the whole Regiment.

21. The Adjutant is authorised to submit Recommendation Rolls from time to time as may be required by the Commanding Officer, for such of the Private Instructors attached to the Drill, as he may deem worthy of promotion to the rank of Lance Naigue.



SECTION XXIII.

Recruit and Pensioned Boys.

- 1. THE Boys of the Regiment are to be formed into a Company, under the immediate control of the Adjutant.
- 2. They are always to remain at the Head Quarters of the Regiment unless, on special occasions, the Commanding Officer may see fit to grant them the indulgence of accompanying their relatives when detached on permanent duty.
- 3. No Boy will be allowed to have furlough from the Regiment but under urgent considerations of which the Commanding Officer will be the Judge.
- 4. The Recruit Boys are not to be attached to Officers as Servants but are to be considered in every point of view as Soldiers, to be treated as such, and to be regularly trained and habituated to the performance of Military Duty.
- 5. Officers will be permitted to have each one pensioned boy to attend upon them, if they desire it, making the requisite application to the Commanding Officer through the Adjutant. All Boys so employed are to attend the Regimental School, daily for two hours, and Drill Twice a Week on such days as may be fixed for the purpose.
 - 6. The Company is to be divided into four

118 , Boys.

Sections, to each of which there will be appointed one Havildar and one Naigue, the former being invariably selected from amongst the Recruit Boys, the latter from either Recruit or Pensioned.

- 7. The Boys thus selected will be required to keep a Roll of their respective squads, and will be held responsible for them in every respect.
- 8. A Havildar Major, selected as the most intelligent and active of the Boys, will have the general charge of the whole. He will collect the Reports of Squads, and keep the Roster for duty, under the superintendance of the Drill Naigue and Drill Havildar to whom he will make his regular reports.
- 9. He will be exempted from all Guard and Orderly Duty.
- 10. No Boy shall be eligible to the above Rank who cannot read and write sufficiently well to keep a Roll of his Squad.
- 11. The Boys are to be regularly drilled and instructed in every part of Company Drill, (the Musket Exercise excepted,) as well as the Sword Exercise, and every practicable part of Duties in Garrison. They are to be individually taught the accurate pronunciation of every English word used in the Drill, and must be made thoroughly acquainted with the signification of each. This is a point of considerable consequence, and every attention must be paid to it. They are also to be regularly practised with Moogdurs, of a size adapted to their strength, as well as in every kind of athletic exercise calculated to expand their

chests, and to form and strengthen their Limbs and Muscles.

- 12. They will be paraded for the above purpose once a day, either Morning or Evening, as, with reference to circumstances, of season, &c., may be deemed expedient.
- 13. Such Boys as from their youth may be unequal to this course of Drill may be exempted from it, but they will be required to attend twice a week properly dressed, and will be taught the salute, facings, &c., care being had to grant them intervals of relaxation.
- 14. All Boys above four years of age shall attend the Regimental Schools regularly every day, and no one shall presume to absent himself without the previous permission of the Adjutant obtained in the ordered manner.
- 15. The Dress of the Boys will be kept in strict conformity to the following particulars.
- 1. For all Boys of sufficient age and strength to be employed on Orderly Duty.

Turband.—Of light frame work with black cover, similar in shape to that worn by the Men, but the Cover being fixed in which manner it is always to be worn.

White Jackets — Similar to those of the Men—the Jacket made to fit—Collars to be worn on occasions of Parade and Duty, but not to Drill.

Wings —Of a small neat size to be made of black wool—the shoulder straps laced as those of the Light Company on a ground of

Sash.—Of Black wove linen Cloth with tassels, tied on the right side—tassels hanging down in front of the right hip. It is to be particularly observed that the Sash must be tied on the natural waist, just above the hips, so as not to press upon the ribs or stomach, and it is not to be tied broader than its own width.

Trowsers.—Black made as directed for the

Sandals. - Of the Regimental Pattern.

2d. For all other Boys, those only excepted who may be excused on account of extreme youth.

Head Dress - A Black Kerchief, uniformly tied, - but not to be made up in a fixed manner.

White Jackets

As for the others—The jackets to be without collars—and no Wings.

16. The following Table contains the quantity of Necessaries which each Boy is required to have in his possession.

- 17. Whenever it may be necessary to reduce a Havildar or Naigue, or to inflict corporal punishment upon any of the Boys, such reduction or punishment is to take place in front of the Company paraded for that purpose.
- 18. The punishments to which the Boys will be subjected are extra Drill, restriction to the Barracks, and lastly corporal punishment to the extent of 12 cuts on the hands or breach, to be inflicted by a Boy Havildar with a light rattan; misconduct of serious a nature as to require still heavier punishment, will subject the culprit to be discharged from the Service.
- 19. A Register agreeably to Form No. XII will be kept in the Adjutant's Office in which will be entered the names of all candidates for enlistment as Boys, Sons of deceased Soldiers of the Corps.

SECTION XXIV.

Regimental Schools.

- 1. The Regimental Schools will be under the immediate management and supervision of a Committee which will be composed of the Commanding Officer or Major as President, with the Interpreter, and another Officer as Members.
- 2. The Interpreter will officiate as Secretary to the Committee, and the accounts of the School Fund will be kept in his office.
- 3. Each Member of the Committee will have the superintendence of one of the Schools, under the general direction of the President.
- 4. Besides the Regimental Boys, who are ordered to attend, the Schools will be open to all Boys whose Fathers or other relations are or may have been in the ranks of the Regiment, to such number as may be determined by the Commanding Officer.
- 5. Such Men of the Regiment also, particularly Recruits, as may wish to attend, shall be permitted to do so, under similar limitation.
- 6. No Individual other than above described, shall be received into any of the Regimental Schools.
- 7. No Scholar shall be admitted but by order of the Commanding Officer.
 - 8. Boys, not Regimental, being once admit-

ted into the School, will be subject in every particular to the established rules.

- 9. When the Parents or friends of any Boy not Regimental may wish him to be excused attendance for any purpose, application must be made through the Master to the Superintending Officer for his perinission.
- 10 The hours of attendance at the several Schools will be fixed by the Committee, from time to time, according to circumstances.
- 11. No Corporal Punishment shall be allowed in the Schools but under the personal authority and supervision of the European Superintending Officer, who is permitted to award its infliction to the extent of six cuts on the hands with a light rattan, by a Boy Havildar.

12. When more severe punishment may be deemed necessary, a report must be made to

the Commanding Officer.

- 13. Neglect of duty, or other offence on the part of the Masters which may call for punishment, will subject them to fine, by order of the Committee, to an extent not exceeding one eighth of their pay monthly.
- 14. All Fines are to be carried to the credit of the School Fund.
- 15. All subsidiary rules will be framed by the Committee, and published in Regimental orders for general information.

SECTION XXV.

Surgeon or Assistant Surgeon and Hospital.

- 1. The responsibility for the order, regularity, and cleanliness, of the Regimental Hospital, for the due care of the patients, and for the general conduct and economy of the whole establishment rests entirely with the Surgeon: and his particular attention is required to the general Regulations on this subject.
- 2. Every Non-Commissioned Officer, or other person of inferior Rank, who is unable from sickness to do his duty shall be restricted to the Hospital, and must not on any account be permitted to remain elsewhere without the express permission of the Surgeon sanctioned by the Commanding Officer.
- 3. The Staff Serjeants and Native Officers when taken sick will be allowed to remain in their Quarters, attending at the Hospital for inspection at such hour as may be ordered by the Surgeon, unless prevented from doing so by the nature of their disorder, in which case the Surgeon will visit them in their houses.
- 4. Whenever an Officer may be taken ill, or recover, the Surgeon will send a report to the Adjutant agreeably to Forms Nos. XIII and XIV.
- 5 The Surgeon will also notify to the Adjutant whenever he may deem it necessary, for an Officer on the sick report to quit his quarters for the benefit of air and exercise; spe-

cifying the hours during which he may consider it requisite.

- 6. The Surgeon is required to visit the Hospital once, or oftener if necessary, during the twenty-four hours.
- 7. He will attend at the Hospital daily at —
 A. M. at which hour all recovered Men are to be discharged and handed over to the Orderly Naigues, who are to be in waiting for the purpose.
- 8 All Men taken Sick are to be carried to the Hospital immediately their illness is known. Should the Surgeon not then be at the Hospital, they will be received by the Apothecary or Dresser who will act agreeably to such instructions as may have been given by the Surgeon.
- 9. No man once admitted into Hospital is to be discharged thence but by the authority of the Surgeon and at the prescribed hour. The Surgeon will personally examine all individuals brought to the Hospital and any Men rejected by him as Malingerers are to be reported to the Commanding Officer at Orderly Hour.
- 10. The Sick are not to go out of the Hospital without leave from the Surgeon, under whose orders they are to consider themselves immediately placed, and the Surgeon is authorised to place under restraint any patient who may disobey his instructions or commit any kind of irregularity; unless specially reported by the Surgeon, such restraint is to be considered as local only, and may be removed at the pleasure of the Surgeon.
 - 11. Every Non-Commissioned Officer in the Hospital is expected to do his utmost to prevent

irregularity, and to report the offender to the Surgeon.

- 12. If any man thinks himself ill-treated in the Hospital, or has any other cause of complaint, he is to state it to the Orderly Officer of the Day as well as to the Orderly Havildar or Naigue of his Company, that he may have redress if aggrieved.
- 13. The Surgeon will transmit to the Adjutant by —— A. M., a report made out agreeably to Form No. XV., noting against the Name of any individual whom he may think it necessary to excuse from Drill and duty, the period for which the indulgence will be requisite; this report is to be circulated in the Order Book for general information.
- 14. All Men thus excused are to attend daily at the Hospital for the inspection of the Surgeon. They are also to attend Roll Call, and at Parade they will appear dressed and accoutred, unless otherwise ordered, in rear of their Companies for the Commanding Officer's inspection.
- 15. All Men who go into Hospital on account of contusions received in any affray, or with Venereal, or whose sickness is known to have been brought on by intemperance of any kind, or who have committed any irregularity while in Hospital, are to be noted accordingly in the Surgeon's report on their discharge, in order to their being punished in such manner as may seem expedient.
- 16. A similar rule is to be observed with respect to Men who may be ascertained to have

concealed their disorder instead of reporting its first appearance.

- 17. All Men, affected with Itch, whether taken into Hospital or otherwise, shall attend the Adjutant's Drill (without Arms and in a distinct Squad) morning and evening until cured, unless specially exempted therefrom by the Surgeon. It is the special duty of the Commissioned and Non-Commissioned Officers to note every Man who may have any appearance of Itch or other cutaneous disorder and to report him accordingly.
- 18. Whenever the Surgeon may deem it requisite that any Patient should have the attendance of a Comrade, he is to inform the Adjutant who will immediately give the necessary orders.
- 19. Over the head of each Man's berth in Hospital shall be suspended a small board on which shall be noted the Patient's Name, Number, Company, date of Entrance, and nature of disease.
- 20. An immediate report will be made by the Surgeon to the Commanding Officer whenever he considers the life of any Patient in danger.
- 21. The Arms and Accourrements of all Sick Men shall be lodged with the Arms of their respective Companies; and Officers will adopt the requisite measures for having them properly cleaned, either by Men ordered for fatigue as a punishment, or by Men detailed in course of Roster for the duty. When marching, the Arms of the Sick will be provided for by the Quarter Master.

- 22. The Surgeon will wait upon the Commanding Officer of the Regiment every Monday morning at Orderly hour with a weekly state of the Sick made out agreeably to Form No. XVI.
- 23 The Surgeon will attend whenever the Regiment fires Blank or Ball Cartridge—and he will provide for the attendance of an Assistant at all similar practice of a single Company or of Recruits.
- 24. He will also attend all infliction of Punishment and at Muster Parades.
- 25. It will be the duty of the Surgeon to communicate to the Commanding Officer all such instructions connected with his Regimental duties as he may receive from the Superintending Surgeon or other authority, and to lay before him all official letters received, or to be despatched.
- 26. The Naigue of the Guard is not to receive orders from any of the Hospital Servants, The Hospital Havildar in the absence of the Surgeon, is authorised to give such instructions as may be requisite.

SECTION XXVI.

Hospital Havildar.

- 1. The Hospital Havildar is placed under the immediate orders of the Surgeon, to whom he is responsible for the good order and management of the Sick.
- 2. He will report to the Adjutant every morning at A. M., the number in Hospital, admitted, discharged, and Casualties.
- 3. He is immediately to report all Casualties to the Adjutant, and Orderly Havildar or Naigue of the Company.
- 4. He has under the Surgeon the particular direction of the Hospital Guard.
- 5. It will rest with the Surgeon in communication with the Commanding Officer to prescribe such further rules for the guidance to the Hospital Havildar, as he may deem advisable.

SECTION XXVII.

Detachments.

- 1. It will be the duty of the Quarter Master to prepare the necessary ludents, &c. required for the Equipments of any party ordered on detached duty.
- 2. From Detachments under the Command of European Officers, Monthly Returns will be required, and which must be transmitted so as to reach the Adjutant, on or before the last day of the month.
- 3. From Detachments under Native Officers or Non-Commissioned, Native Reports must be transmitted in like manner, notifying all Casualties and any circumstance worthy of note which may have occurred.
- 4. The Official correspondence with the Regiment of all Officers Commanding Detachments must be addressed to the Adjutant or Quarter Master respectively, by whom it will be submitted to the Commanding Officer—No such communication will be permitted to be made direct, except in special cases on which the Commanding Officer may otherwise determine.
- 5. No Officer Commanding a Detachment shall appoint any individual to act in a higher grade than that held by him in the Regiment without previously obtaining the sanction of the Commanding Officer, unless in cases of emer-

gency on actual service, when there may be no ready communication with Head Quarters.

- 6. European Officers Commanding fixed Detachments are permitted to grant leave of absence for a period not exceeding one Month, reporting the Names, &c. in the Monthly Return, for insertion in the Regimental Register of Furloughs.
- 7. When detached on distant duty, and not at a fixed post, Officers will exercise their discretion in granting such Furlough as may be necessary reporting the circumstance to Regimental Head Quarters.
- 8 All Casualties, and any circumstances worthy of note, are immediately to be reported to Head Quarters.
- 9. A Weekly Report of Sick is to be sent in from all fixed Detachments.
- 10 Men absenting themselves without leave are not to be struck off as Deserters without Orders from the Commanding Officer.
- 11. Agreeably to the General Regulations of the Service all references on Regimental matters, are to be made to the Regiment, as are likewise all applications for exchange or removal, for Furlough beyond the Division or District in which the Corps may be situated, and for Courts Martial, &c.
- 12. When, however, Detachments may be sent to a distance, as in the case of treasure escorts, the Officers in command are allowed to act in those particulars as circumstances may require, but conforming to the preceding rule as far as practicable.
 - 13. Every Detachment, of whatever strength,

staff, is to be furnished with one, when practicable, by the Quarter Master of the Regiment, written in English, Hindoostanee, Teloogoo, or Tamil, according to circumstances. The route thus given is not to be deviated from, without some urgent cause which must be duly reported.

- 14 Officers Commanding Detachments are held responsible for the conduct of all those under their Command, whether Soldiers or Followers, and they are required by every means in their power to secure the inhabitants of the districts through which the Detachment may pass, from any act of violence or oppression.
- 15. The strictest adherence in every particular is required to the established system of the Regiment. The Character of the Corps is so visibly involved in the conduct and appearance of its Detachments, that Officers cannot pay too much attention to this subject. Should it ever be brought to the notice of the Commanding Officer, that Native Officers or others in charge of Detachments have permitted their Men to march in a straggling unsoldier-like manner, to appear improperly or dirtily dressed or accounted, or in any way to act otherwise than they would if at Head Quarters, they will not fail to incur his severest displeasure.
- 16. The Flank Companies are not to be included in the Roster for the ordinary Detachments of the Regiment.

SECTION XXVIII.

Furlough.

- 1. The mode in which application for Furlough is to be made has been specified in Section XII.
- 2. No man shall receive the indulgence of Furlough if there are any claims against him in the Bazar or elsewhere unadjusted.
- 3. 'The Arms, Accourrements, Small Stores, and (whenever practicable) Knapsacks of Non-Commissioned Officers and others proceeding on Furlough shall be lodged in the Regimental Store Room,—Labels shall be attached to them bearing the Rank, Name, Company, and Number of the Individual, and receipts for them shall be granted by the Quarter Master, as directed in Section XII, paragraph 1820.
- 4. The strictest attention is required to the General Regulations, and the Adjutant will reject all Passports brought to him for entry which are not made out in accordance with the established Form.
- 5. Every Man proceeding on Furlough for a period beyond the Returns, is to be furnished with a Pay Certificate, which will be granted by the Pay Master on the Passport being presented to him signed by the Officer of the Company.
- 6. Unless urgent circumstances require more immediate communication, all Passports, in common with other Papers, will be sent to the

Adjutant before orderly hour, for the countersignature of the Commanding Officer, and then having entered them in his Register, he will return them to the Officers of Companies.

- 7. In like manner all Pay Certificates will be submitted for the countersignature of the Commanding Officer at the same hour.
- S. Passes to Men whose absence is not to exceed three Parades, will not require the countersignature of the Commanding Officer, nor registry in the Adjutant's Office, unless otherwise directed.
- 9. The Passports of all Men rejoining the Regiment from furlough, or otherwise, are to be sent by Officers Commanding Companies to the Adjutant, Pay Certificates to the Paymaster.
- 10. Any Man who overstays his furlough without sufficient cause certified by the Commanding or Staff Officer of the Station at which he may be detained, or who shall be convicted of having solicited an extension of his furlough on false pretences, shall be punished.
- 11. Every Non-Commissioned Officer, or other of inferior rank, upon rejoining the Regiment from absence, on furlough or sick, exceeding the period of one mouth, shall attend the Adjutant's Drill, as long as that Officer may deem necessary.
- 12. The number of Men in each Company who can be allowed to be absent on furlough at the same period must vary with circumstances. It will, therefore, be notified to Officers from time to time as may be necessary.

SECTION XXIX:

Duties when Marching.

- 1. When the Regiment forms part of a body of Troops, in Camp or Quarters, the whole of which is ordered to march, the signals will be as the General or other Officer Commanding may direct.
- 2. When the Regiment, being part of a Brigade or Force, may be ordered to march singly, no other than the usual Parade Calls are to be used, and those only when the Regiment may march after Reveillée. No general signal is to be used until out of hearing of the Main Body.
- 3. When the Regiment may be marching singly, the Signals will be first, the General, second, the Assembly, and third, the First Part of the Grenadiers' March.
- 4. On the first Signal the Men are to turn out and accourte,—baggage to be packed, and Tents struck—not a movement nor sound of any description can be allowed to disturb the Camp previous to this Signal, unless special permission to the contrary may be given.
- 5. On the second Signal, the Men are to assemble in their respective Companies, and Officers will proceed to inspect them—ascertaining that all are present, and that all are correctly equipped.
- 6. On the third Signal, Officers will take post in the Ranks, and the Regiment will stand

with ordered Arms. The Commanding Officer will give the order to fix Bayonets and Shoulder, and the whole will move off on the word "Quick March," or on the sound of the "Advance."

- 7. The Regiment, unless otherwise directed, will always assemble for March in Column of Companies, right or left in front as may be specified in the Orders of the Day—The intervals between the signals will be fixed in Orders.
- 8. The Regiment will march with every attention to the preservation of distance, to keeping the step, and to the closeness of files and ranks, until the beating of the "Drummer's Call," on which Officers of Companies will give the words "unfix Bayonets," and "March at ease,"—Swords are to be returned, the Colors taken by the Havildars, and Officers are allowed to mount. The Men may then be allowed to open their files, carry their Arms as they please, and converse. The Pivot files are still carefully to preserve their distances, and they are, therefore, to be relieved from time to time during the March.
- 9. All Camp Guards and inlying Picquets will join their respective Companies on the sounding of the first Signal, the Quarter Guard excepted, which will stand fast—Outlying Picquets will receive orders according to circumstances.
- 10. The Quarter Guard will not leave the encampment until every thing is off the ground. It will then follow as a Rear Guard—all stragglers whom it may encounter on the route are to be made to join and march with it, unless they state themselves to have received permis-

sion to remain behind the whole stage, in which case their Names, &c., are to be reported on the arrival of the Rear Guard in Camp, and should any individual be proved to have made such statement falsely he will be punished.

11. The advanced Guard will usually be formed by the Quarter Guard coming on duty, the rear Section under the Native Officer, will form the reserve, advanced in front of the Column to such distance as may be directed by the European Officer of the day, whose duty it will be to station this Guard. The leading Section under a Havildar will form in advance, throwing forward a double file under a Naigue. The distances between these several parties will depend upon the nature of the ground and other circumstances at the time. Patroles on the Flanks will not be thrown out unless specially ordered by the Commanding Officer.

The Advanced Guard will move to its station in front on the sounding of the second Signal.

- 12. European Officers of Companies are to ride on the Pivot Flank of the Column, never proceeding to a distance from their Companies nor going off the line of March without first obtaining the Commanding Officers leave.
- 13. The Native Officers will ride on the reverse Flank, unless in Command of Companies.
- 14. No Officer is at any time, on any account whatever to ride between the Sections of a Company. When compelled by the nature of the road, and not otherwise, Officers may

ride between Companies, resuming their places on the Flank as soon as possible.

- 15. The Recruits and Boys under the Drill Havildar will be formed in rear of the Column.
- 16. The Puckallies, when moving with the Column, are to be on the reverse Flank of their respective Companies.
- 17. Drummers, Fifers, and Musicians, will precede the Regiment at such distance as may be ordered.
- 18. The Station of the Surgeon is in rear of the Column.
- 19. The Orderly Officer will move in front of the Regiment, in command of the Advanced Guard.
- 20. The Adjutant will be in rear of the Column, which is to be considered as his habitual post.—He is not, however, to confine himself to this one Station, but will give his attendance whenever it may be necessary.
- 21. When there is a Second Field Officer with the Regiment, he will move in rear of the Column.
- 22. An Orderly Drummer will be attached to the Commanding Officer, and one is also to move with the rear division of the Column.
- 23. Whenever it may be requisite to pass any word or notice to the Commanding Officer or to any particular Company or Section, it must be repeated by Officers and Non-Commissioned only, not by the Men.
- 24. Whenever the Halt is ordered, either by Command or Signal, the Head of the Column

will halt, and rear divisions, if not then at, will close up to their proper distances—The Taps are then to be passed from the Rear, as a notice to the Commanding Officer that the Column has closed, and is ready for movement.

- 25. The Men are never to exceed the regular pace unless by word of Command.
- 26. When any Company, supposed No. 4, cannot keep up without running or stepping out, its Officer must call out "No. 4 cannot keep up" which is to be repeated by the Companies in front of No. 4, until it reaches the Commanding Officer—In the interim No. 4 is to continue at the regular step, and is on no account to exceed it.*
- 27. In passing a stream or other obstacle, the Officer Commanding a Company is to be the last to cross, that he may observe the regular execution of the movement as ordered.*
- 28. No Man is to remain behind or to quit the ranks, for any purpose whatever, without the permission of his Officer.
- 29. Officers are authorised to grant permission to their Men to quit the ranks for the purposes of nature. The Arms of such Men are invariably to be carried by the Section to which they belong until they return.
- 30. When leave to quit the Ranks may be required otherwise than as above specified reference must be made to the Commanding Officer.

This will seldom be found necessary if the Commanding Officer duly superintend the general movement of the Column.—In passing a defile, &c., the Commanding Officer is particularly required to give this attention.

- 31. Should any man be taken ill he is to be sent under charge of a Havildar or Naigue to the Surgeon who will decide upon the necessity of his falling to the rear.
- 32. No followers, whether servants or others, are to be permitted to march between the advanced guard and the rear of the Column. When any of them may be overtaken by the Corps, when marching singly, they will draw up on the reverse flank, and stand fast until the Corps has passed them.
- 33. The sick carriage is under charge of the Quarter Master, to be distributed as the Surgeon may require. It is to be used for the accommodation of the sick only, or of the arms of Men taken sick on the line of march.—It is not to be employed in any other manner whatever.
- 34. The necessary arrangements with regard to the manner and time of movement of the sick and convalescent will be made by the Surgeon in communication with the Commanding Officer.
- ordered in the 24th Paragraph, the "Drummer's Call" will be beat, on which Officers will dismount and take post, drawing their Companies to fix bayonets. The Colors to be resumed by the Jemadars.*

^{*} The Colors are to be displayed when entering or passing through a Cantonment, Station, or large Town, or when in presence of another Regiment or of a Superior Officer—At other times in ordinary route marching, it may be dispensed with.

On the word "Quick March" the whole will move forward with every attention to step an distance; and in perfect silence.

- 36. The Regiment being formed on the new ground, the Adjutant will collect the reports of Companies. The Regiment, if in line, will be broken into Column, and Officers having inspected their Companies and having sent their Men for duty, under the orderly Havildar, to the Centre of the Parade, Arms will be piled, and the Regiment dismissed. The guards having been inspected and told off by the Adjutant will be delivered over to the Officer of the day.—On halting days, the usual forms of Guard Mounting will be observed—at other times, the Guards will be sent to their posts, after inspection, without further ceremony.
- 37. The Arms, Accourtements, Ammunition, &c &c. and necessaries, particularly Sandals, Cloaks, and Havresacks, are to be carefully inspected by Officers of Companies every second or third halting day according to circumstances—unless otherwise ordered.
- 38. When the Regiment is marching singly, a safe guard will always be sent on in advance to the next stage. This party will generally be under the command of a Havildar—It will leave the Camp at such time as to ensure its arrival at the next stage twelve hours before the Regiment. The Quarter Master will furnish it with a guide, if requisite, and he will also communicate the necessary orders for the guidance of the Havildars. On reaching the new ground the Havildar will proceed with his party to the Kotwal's Choultry of the Village, stationing such Sentries

as may be necessary for the due security of the Village Bazar.—It will be the special duty of the Havildar carefully to protect the Villagers against any violence or oppression on the part of the followers or others of the Regiment.

He will instantly apprehend and send to the Officer of the day any persons, whether Soldiers, Officers' Servants, or others, who may in any manner molest the inhabitants.

His report will be made to the Orderly Officer of the Day.

SECTION XXX.

Courts Martial.

- 1. It will be the duty of the Adjutant to conduct the Proceedings of all Native Courts Martial of the Regiment:
- 2. The Adjutant will attend at all European Regimental Courts Martial, and it will be his duty to furnish the President with the Charges and every other particular relative to the Prisoner to be tried, as well as to ensure the attendance at the appointed time of all parties concerned. He will also provide the Court with the Articles of War, Mutiny Act, Compendium of the Law of Evidence, Bible, and any other necessary books.
- 3. The Native Adjutant or Havildar Major will be in attendance at all Native Courts.
- 4 The Proceedings of all Courts Martial, when closed, are to be delivered or sent to the Commanding Officer of the Regiment, by the President.
- 5. Whenever it may be necessary to assemble Native Courts of Inquiry the Proceedings are to be conducted by an European Officer, the Interpreter also attending.
- 6. Courts of Inquiry are however to be discouraged as much as possible, their frequent recurrence being of very prejudicial consequences to the discipline of the Regiment, and it is certain that if the European Officers do their duty, and give their personal


attention to the investigation and adjustment of such disputes as may at times arise, little necessity will be found to exist for their assembly.

- 7. Young Officers are to attend every Court Martial, European and Native, which may be held in the Regiment during the first year of their Service with it, or for a longer period as the Commanding Officer may deem requisite.
- 8. On the promotion of any Man to the rank of Jemadar, he shall be required to attend all Native Courts Martial which may be held in the Regiment, as well as all General Courts Martial which may be assembled at the Station, for such time as the Adjutant may deem necessary, and until reported qualified by that Officer, he is not to be placed on the Roster for Court Martial Duty,
- 9. The Crime and Sentence of every Man of the Regiment brought to trial before a Court Martial whether Regimental or otherwise will invariably be published in Regimental Orders.
- 10. Unless rendered inexpedient by circumstances, all Parades ordered for the infliction of Punishment, or publication of the Sentence of a Court Martial, will be in Review Order.

SECTION XXXI.

Orders and Articles of Unar:

- 1. The 1st and 4th Sections of the Articles of War, and the Standing Orders of the Regiment, will be read to the Regiment alternately, at Muster Parade,—Boys, Departments, &c. all being present.
- 2. The whole of the Articles of War will be read at the Muster Parade in January and July.
 - 3. It will be the duty of the Interpreter to have fit persons in attendance for the purpose of reading them.
 - 4. Such of the Articles of War and Standing Orders as affect or are intended for the guidance of the Men, will be read to the Recruits once a week at Roll-Call.
 - 5. The Interpreter will have written translations prepared in Hindoostanee, Teloogoo, and Tamil, of all Proclamations, and General and other Orders required to be read and explained to the Men, and he will have them copied on boards to be suspended against a convenient part of the Barrack for general information.



SECTION XXXII.

Punishments.

1. Punishments are of two kinds, Private and Public.

The former consist of extra Drills, extra Duty, the withholding of Furlough and present leave, confinement to the Barracks or Guard, and confinement in Cell, not exceeding seven days.

The latter class consists of such punishments as are awarded by the Court Martial.

- 2. All Prisoners, Regimentally confined, (Men ordered for Trial, or under Trial or Sentence excepted,) shall attend the Adjutant's Drill, Morning and Evening, but, as every Man in confinement must be held to be in temporary disgrace, they are not to fall in with their Companies; when required to be present for Muster or other purpose, they will parade in rear of them.
- 3. On confining any Man in a Cell, his Clothes, &c are to be carefully searched to prevent his taking with him any liquor or drugs. His food is always to be taken to him twice in the day, the Naigue or Havildar attending each meal, and the Naigue will be held responsible that no conversation with him is permitted. In instances where the prejudices of Cast may interfere, as in the case of Rajpoots, the Individual shall be permitted to quit the Cell, under two Sentries, for a period of one hour at

a time, twice in each day, not being suffered to hold communication with any one, and within such limits as may be prescribed with reference to the locality of the Cell.

- 4. Orderly Naigues of Companies are to carry to the Guard or other place of Confinement, the Arms and Accourrements of all Prisoners ordered to attend Drill and are to march them thence to the Drill Ground.
- 5. All Men in confinement, other than those in the Cells, shall clean their own Arms and Accourrements excepting such as are for trial or under trial or sentence.

SECTION XXXIII.

Drummers, Fifers and Band.


- 1. The immediate charge of the Drummers, Fifers and Band, devolves upon the Adjutant to whom the Drum and Fife Major and Master of the Band are to be responsible for the Men and Instruments placed under their charge. They are to be inspected and provided with necessaries by the Adjutant, who will communicate to Officers of Companies the amount of stoppages to be made—such stoppages to be transmitted by them to the Adjutant who will keep the ordered accounts.—They are to be mustered and paid in their own Companies.
- 2. The Drum and Fife Majors are to attend daily, by turns, at the Orderly Room to receive the detail and Orders respecting their charge.
- 3. The Master or Serjeant of the Band will also attend for the same purpose.
- 4. An Orderly Drummer, or Bugler, with his Drum or Bugle, is to attend daily at the Orderly Room.
- 5, All Orders regarding the practice and instruction of the Drummers and Musicians will be issued by the Adjutant, as may be required.
- 6. It will be the duty of the Adjutant to observe that none but the regulated sounds and beats are used for the purposes of duty,

and he must forthwith check any attempt to introduce innovation or variation in those points.

- 7. The Drum Major is to be provided with a correct plummet by which he will regulate the time of the Music and Drums.
- 8. Whenever a Drummer, Fifer or Musician, may require present leave, he will apply to the Adjutant through the Drum or Fife Major or Master of the Band, and the Adjutant will grant the indulgence required, under such restrictions as may be specified by the Commanding Officer.
- 9. When Furlough from the Regiment may be required, application is in like manner to be made to the Adjutant, who, if he approve of the request, will refer to the Commanding Officer, and if the leave be granted, he will then send the Man with an official Memorandum to the Commandant of his Company for a Passport.
- 10. All Reports, &c. are to be made by the Drum Major, in collecting which he is to be assisted by the Fife Major, who is to be considered as under his immediate Orders.
- 11. When marching, the Drummers, Fifers and Musicians, are to move with the utmost regularity and steadiness, at the head of the column When an individual may require permission to fall out of the Ranks for any purpose, application must be made to the Commanding Officer.
- 12. The Bass Drummer will be assisted and relieved during the March by the Fifers, two of whom are to be named every morning for this duty.

- 13. The Musicians are to carry their own Instruments. They are to be provided with Knapsacks and Havresacks. Their Knapsacks may be carried with the Baggage of the Corps, if so allowed at the time in Regimental Orders, but at their own expense and risk.
- 14. Such of the Drummers and Musiciaus as are either of European or of Indo-British birth, are to be regularly marched to Church every Sunday, unless at a station where the means of attending Divine Service may not be afforded.

On these occasions they are to be dressed in Review Order, with belts but without arms.



SECTION XXXIV.

Puckallies.

- 1. The Puckallies of the Regiment are under the general direction of the Quarter Master.
- 2. With regard to leave, &c. the same rules are to be observed as have been prescribed in Section XXXIII with regard to the Drummers, substituting Quarter Master for Adjutant.
- A Puckally proceeding on furlough will be required to provide a substitute during his absence.

SECTION XXXV.

Artificers.


- 1. THE Artificers attached to the Regiment are under the charge of the Quarter Master, from whom only they are to receive their orders.
- 2. They are to work every day, Sundays excepted, from 8 A. M. to 4 P. M., or if they prefer taking two hours at mid-day for their meals, then their working hours are to be from 7 A. M. till Noon, and from 2 to 5 P. M.
 - 3. They are not to work on Sundays.
- 4. The Artificers are never, on any account, to be employed away from the Regimental Workshop on any duty other than strictly public, unless in situations where hired workmen are not procurable.
- 5. They are to be regularly registered in the Quarter Master's Office.
- 6. Whenever it may be necessary to attach Artificers to Detachments of the Regiment, their number and description will be specified in Regimental Orders.
- 7. The Regimental Workshop is to be at the most safe and convenient place near the Store-room, but not in any private yard or compound.

SECTION XXXVI.

Regimental Lascars.

- 1. The Quarter Master will have the general charge of the Regimental Lascars in as far as regards their Registry, Mustering, Pay, &c. but the immediate charge of those attached to particular Companies as Washermen will rest with the respective Officers Commanding.
- 2. Such Regimental Lascars as do the duty of Camp Color Men are to be considered as immediately under the Quarter Master, and are available for every description of work pertaining to the office of Pioneers, or connected with the Regimental Stores.
- 3. They are never to be employed on any but public duties, occasional assistance to the Regimental Mess being, however, understood as included in this term.
- 4. The Regimental Lascars are considered adequate to the performance of all ordinary work, but in extraordinary cases when further aid may be required, the Quarter Master will apply to the Commanding Officer, at Orderly hour, for a fatigue party.



SECTION XXXVII.

Regimental Lines.

- 1. The Regimental Lines are under the immediate charge of the Quarter Master whose duty it will be to exercise a strict and constant supervision thereof, for the preservation of cleanliness, and to prevent any obstruction or nuisance in any of the streets.
- 2. No buildings of any kind are to be erected without the permission of the Commanding Officer obtained through the Quarter Master.
- 3. For the prevention of accidents, all Wells are to be surrounded by a wall or railing.
- 4. The tenant of each House is required to provide two strong moderate sized Chatties of water (say of 12 measures each,) to be placed outside or near to the door of the House or yard as a provision against fires, and the Native Officer of the day will be held responsible that these Chatties are kept filled with water and ready for immediate use. The water to be changed twice a week.
- 5. Every precaution must be taken against fires, and the Native Officers and Non-Commissioned of each Company will consider it their duty to notice any act of negligence or carelessness in this respect which any person residing in the Lines may commit.
- 6. The Native Officers and Non-Commissioned Officers of each Company will be held re-



sponsible for the preservation of order within their respective lines, as also that no unauthorised or improper persons are allowed to dwell therein, or to resort thither.

- 7. All disputes occurring within the Lines which cannot be accommodated by the Native Officers or others of the Company, are to be reported to the Native Officer of the Day.
- 8. Relations of the Men, although not in the Service, may be permitted to reside with their Friends in the Lines of the Regiment, with the understanding, however, that they will be liable to expulsion in the event of misconduct, or any infringement of the orders of the Regiment.
- 9. Any person of this description found drunk in the Lines will be expelled, and will on no consideration be allowed again to reside there.
- 10. No man discharged from the Regiment for Theft or Drunkenness is to be permitted, on any consideration, to remain within the boundaries of the Regimental Lines, and any individual harbouring such persons, whether relations or otherwise, will be liable to punishment.
- 11. With a view to prevent the resort of improper characters to the Regimental Lines, a Register shall be kept in the Quarter Master's Office, in which shall be entered the name, occupation, &c. &c. of every adult male, not in the Service, residing therein, without exception. Any man who may be found living in the Regimental Lines, whoever and whatsoever he may be, whose name is not duly en-

tered in this Register shall be summarily expelled therefrom,—and the person harbouring him, as well as the Non-Commissioned Officers of the Street, shall be punished.

- 12. Whenever any person whose name has been entered in this Register may permanently quit the Lines or become a casualty, a report is to be made to the Quarter Master through the Orderly Havildars of Companies, that the circumstance may be noted in the Register thus keeping it at all times complete, and fit for reference.
- 13. It must be fully explained to all ranks of the Regiment that each will be held responsible for the conduct of those residing in his house, and for the strictest obedience to the preceding Orders.



SECTION XXXVIII.

Regimental Bazar.

- 1. THE Regimental Bazar will be under the immediate control of the Adjutant.
- 2. The strictest attention is required to the General Regulations on this subject which is one of much consequence to the comfort and efficiency of the Corps at large.
- 3. Every encouragement must be given to the connexions of the Men to settle as Shop-keepers in the Regimental Bazar, and as productive of general advantage to the Regiment, individuals available as Coolies, &c. will be allowed to reside within the boundaries to such extent as the Commanding Officer may determine.
- 4. It must be well explained to the Bazar Men and others residing within the boundaries of the Regimental Bazar, that they are subject to trial and Punishment by Military Courts, and to summary expulsion at the pleasure of the Commanding Officer.
 - 5. Such of the Articles of War, General Regulations, and Standing Orders of the Regiment, as affect individuals of this Class are to be transcribed in Hindoostanee, Teloogoo, and Tamil, and lodged with the Chowdrie for general reference, to be produced for the information of any resident Bazar Man requiring it.
 - 6. This collection of Orders is to be public-

168

ly read in the Bazar, once a Month, under the superintendence of the Chowdrie.

- 7. The Chowdrie will attend at the Adjutant's Office daily at ———— A. M. to make his report and receive Orders. He is not to be detained longer than necessary on this occasion as it is desirable that he should be absent as little as possible from the Bazar.
- 8. On the 2d or 3d of the Month, the Chowdrie will give in a written statement of all authorised sums due to the several Shop Keepers by the Men of each Company, as also a General Return of the Bazar itself.
- 9. Bazar Debts are limited to such credit, not exceeding half the rate of pay, as may be sanctioned by Officers Commanding Companies to enable Men to procure the necessaries of life—No others will be taken cognisance of.—All such Debts are to be liquidated on each issue of Pay under the superintendence of Officers of Companies—For this purpose extracts from the general statement furnished by the Chowdrie will be made by the Orderly Havildars of each Company under the superintendence of the Adjutant, as soon after the 1st of the Month as practicable and it will be the Duty of the Company Officer to ascertain from his Men their admission or rejection of the Charges, and to determine upon such as may be disputed, in readiness for the issue of Pay.
 - 10. The Chowdrie-will be held responsible that no Non-Commissioned Officer or other individual of inferior rank, receive credit in the Bazar, during any one Month, for a greater amount than the half of his Monthly Pay. In the event of this order being disobeyed, the

overplus on being recovered from the individual shall be devoted to such public purpose of the Regiment as the Commanding Officer may determine in Regimental Orders.

- 11. No Officer of the Regiment can be permitted to send for the Chowdrie or other official persons attached to the Bazar.
- 12. The Dookans are all to be registered in the Adjutants' Office, and no person shall be allowed to establish one, or reside in the Bazar, without previous application to the Adjutant for the sanction of the Commanding Officer.

Conclusion.

Whenever local or temporary circumstances may render any of the foregoing orders inapplicable, their suspension and its cause will be notified in Regimental Orders, reference being made to them by Sections and Numbers, such suspension not continuing longer than circumstances render necessary.

Para. 114. Substitute the [following:—

Powder Horn—The Powder Horn is to be slung on the right side, the line passing over the left shoulder.—It is to lie above and clear of the Pouch, the curve fitting to the body, muzzle to the front, and so far back as not to interfere with the Musket.

The line is to be tied short to the Horn in a running knot, the spare ends and tassels hanging down the side; when required to be used the line is to be let out to its full length.

The Horn is to be worn in Review order, heavy and light marching Order, and for Ball Practice.

Para. 115: For the "lower corner of the breast plate," substitute the fourth button from the top of the Jacket.

Para. 116. Waist Belt.--The Waist Belt must be of exactly the same breadth as the Pouch Belt,

the Bullet and Patch Bags being at equal distances on each side of the Clasp. The buckles must always be kept free from blacking, so as to admit of the Belt being readily lengthened or taken up. The Belt is to be fitted and worn soas to be just above the bottom button of the Jacket, and it is on no account to be loose or liable to slip.





For the guidance of Officers absent on detached duty, or otherwise, the following Memoranda on the subject of reports, &c. have been extracted from the General Regulations.

REPORTS FROM INDIVIDUAL OFFICERS.

- 1. To the Commanding Officer of every Station through which they may pass, in person unless prevented by sickness, then if there be no Staff Officer, to the Commandant in writing, otherwise to the Staff Officer.
- 2. Report must also be made to the Staff Officer of every Station, either personally or in writing, stating cause of arrival, intended place of abode during stay, and proposed time of departure.
- 3. At Stations, being the Head Quarters of Divisions or Forces, such as Bangalore or Trichinopoly, reports to be made to General Officer and Staff, as well as to Station Commandant and Staff.
- 4. At the Presidency, to report arrival at Adjutant General's Office and Town Major's. To the former in person, unless prevented by sickness, then in writing—To the latter either personally or in writing. Similar reports to be made of departure.
- 5 Application for extension of Leave to be made to Regimental Head Quarters; it can be admitted in cases of great urgency only.

- 6. Officers appointed to the Regiment, or arriving at the Presidency or elsewhere from Europe, Sea, &c. to rejoin, to report to the Adjutant for the Commanding Officer's information.
- 7. Officers on route to join to report progress, Monthly, to the Adjutant.

- 1. The Officer's Sick Certificate, copy or duplicate of which he must take with him, will specify the period to which granted.
- 2. Should continued indisposition preclude an Officer from rejoining at the expiration of that period, an application for an extension must be forwarded to the Regiment accompanied by a Medical Certificate.
- 3. When circumstances prevent the possibility of such applications being received at Army Head Quarters in proper time, Officers are permitted to forward duplicates direct to the Adjutant General.
- 4. Sick Officers arriving at the Presidency to report themselves to the Surgeon of the District in which they reside, as well as to the Adjutant General and Town Major.

This notification always to be made at least one day previous to arrival. If the Officer Commanding the Station be of Superior Rank, Present State to be given him on arrival.
- 4. Reports of Detachments approaching the Presidency to be forwarded to Town Major so as to reach on or before the morning of the day previous to the arrival of Detachment.
- 5 Detachments proceeding to Presidency to be reported on arrival to Adjutant General and Quarter Master General, and Present States to both.
- 6. Death of any European Officer to be reported to Adjutant General direct and to Regiment.
- 7. On entering any division a report to be made to Divisional Adjutant and Quarter Master General, accompanied by Present State. Similar report on quitting Division, and progress reports to the latter while marching within its limits.
 - 8. When it may be necessary to leave any Man behind Sicke in any Station Hospital, a Nominal Roll and Pay Certificate must be given to the Station Staff Officer, and a report made to Regimental Head Quarters.
 - 9. Should more than one Man be left behind or quit the Detachment, a separate Pay Certificate must be given for each.
 - 10. Whenever practicable the Arms, &c. of

Men left behind Sick are to be retained with the Detachment.

- 11. The Arms, &c. of Men quitting the Detachment on furlough must always be retained.
- 12 When Arms, &c. are left behind with Men, a List of them must be attached to the Nominal Roll furnished to the Staff Officer or Commandant of the Station.
- 13. When it may be necessary to deposit Arms, &c. in any Depôt, a receipt must be required for them from the receiving Officer—Breast and Waist Plates are never to be returned into Depôt, but must be brought back to the Regiment, and the ammunition is also to be retained.

The following Documents, &c. are required.

- 1. Address a letter to the Presidency Paymaster stating intention of proceeding to Europe, and requesting he will ascertain if Government have any demands; specifying the Division in which serving for the past year, and Pay for what months drawn in each Division.
- 2. An Extract from General Orders granting the Furlough.
- 3. To draw Pay for the Month in which embarking, and allowances up to date of embarkation inclusive.
- 4. To procure from the Paymaster a Certificate of Pay as above drawn, and another of "no demands."
- 5. To deliver these Certificates to the Accountant General, and to procure from him, a Certificate of "no demands" and a Pay Certificate.
- 6. To deliver the first of these Certificates to the Adjutant General—notifying the name of the Ship on which proceeding; that an order may be obtained through him from Government, to be received on board.

Note.—Officers having obtained Leave to Europe cannot draw Indian Allowances beyond three Months from date of G. O. without special authority of Government.

- 7. If with a Family or Servants, address the Secretary to Government in the Military Department, applying for an order for their embarkation.
- 8. A Certificate of subscription from the Military Fund Office.

2 .- On Sick Certificate.

As for Officers proceeding on Furlough with the following additions.

- 1. To apply at Military Fund Office for Certificate on which to draw pay in England, for Equipment allowance, and if above the rank of Subaltern for Passage Money.
- 2. Passage Money of Subalterns to be drawn at Pay Office.
