*Allowance for the cost of preparing the quarterly return of marriages, etc.* The Chief Commissioner of the Central Provinces informed that the allowance of Rs. 500 assigned to the Roman Catholic Archbishop of Madras for the cost of preparing and submitting the quarterly return of marriages, etc., was intended for the Madras Presidency only, and that any separate claim of the Diocese of Nagpur that might be admitted would appear to be rather to a share in the allowances paid in other provinces than to a share in the allowance paid in Madras.
