### ACCOUNTS.

*Aroot, South.*—The expenditure of Rs. 24-4-8 for plague-preventive measures in connection with the Ani Tirumanjanam festival at Chidambaram, sanctioned.

May 1, No. 350 (Mis.).

*Bellary.*—The payment of a cart-hire of Rs. 4-9-0 incurred by the hospital assistant and the nurse attached to the plague hospital, —, for visiting the various health camps in the — town, sanctioned.

March 12, No. 221 (Mis.).

— The expenditure from “contingencies” of a sum of Rs. 4-14-0 incurred as cart-hire by the nurse attached to the — plague hospital for visiting the health camps in the — Municipality, sanctioned.

June 8, No. 439 (Mis.).

*Cost of printing certain forms at the Government Press.*—Stating that the charges incurred by the Government Press, Madras, in printing certain plague forms should be met from Provincial funds, and that no recovery need be made on this account from the local bodies or the railway administrations concerned.

April 6, No. 292 (P.).

*Debit of charges.*—Stating that the leave allowances of a medical subordinate proceeding on leave from plague duty and the transit pay and travelling allowances of his substitute should be charged to “Provincial—Reserve Medical Subordinates”.

August 26, No. 602 (P.).

*Ganjdm.*—Directing that the expenditure incurred by the Collector of — in supplying lamboo tatties for the use of the steam disinfecting machine at Baruva will be met from the provision for plague charges for 1906-1907 under the head 24-D. Medical—Grants for Medical Purposes.

— The Managing Agents of the British India Steam Navigation Company (Limited), Calcutta, addressed in regard to the payment by them of a sum of Rs. 2,675-15-4 being a moiety of the total expenditure incurred up to the end of March 1907 on account of the working of the disinfecting machines at the ports of Gopalpur, Baruva and Calingapatam.

**BUILDINGS, SHEDS AND CAMPS.**

*Anantapur.*—An estimate amounting to Rs. 4,675 for constructing five sheds for the plague staff at Guntakal, sanctioned; and the estimate of Rs. 575 for repairing the existing plague sheds at that station, returned to the Superintending Engineer, III Circle, for disposal. *No. 726 W., 4th July 1907 (Press).*

*Bellary.*—The execution of repairs to the plague hospital and contact sheds in the Municipality at a cost not exceeding Rs. 550, approved. *September 2, No. 613 (Mis.).*

*Cuddapah.*—The expenditure of Rs. 17-7-8 incurred by the District Board of Cuddapah in constructing certain sheds for plague purposes, sanctioned with remarks. *July 12, No. 512 (Mis.).*

*Detention camp at Tuticorin.*—The Government of Ceylon informed that the extension of the plague — in the manner proposed by the Chairman, Plague Committee, Colombo, would not permit of its being used with safety for the accommodation of persons coming from areas infected with cholera or small-pox. *May 22, Nos. 398-99 (P.).*
