#### Introduction

The Madras Institute of Development Studies was founded in January 1971 as a trust by Dr. Malcolm S. Adiseshiah and Mrs. Elizabeth Adiseshiah with a four-fold objective :

To undertake studies and research pertaining to development problems with special reference to the agro-rural aspects of Tamilnadu and the problems of the economically and socially backward sections of the population throughout the country :

To conduct seminars and conferences on development problems and programmes of the State ;

To foster inter-university cooperation among the social scientists of the Universities of the four Southern States and to promote interdisciplinary research; and To bring out publications relating to the above three functions.

During 1976 the Government of India through the Indian Council of Social Science Research, New Delhi, sent a mission headed by Prof. D. T. Lakdawala to study the possibility of developing the Institute into a

National Institute of Social Science Research. On the basis of the recommendations of the mission the Institute was reconstituted as a National Institute in March 1977 under the joint sponsorship of the Government of India through the Indian Council of Social Science Research and the Government of Tamilnadu with a Governing Council comprising representatives of the ICSSR and the State Government and of the Universities of the four southern states, the original trustees of the Institute and coopted social scientists. The trustees gifted to the reconstituted National Institute its land and building, its library, furniture and equipment and a cash endowment

Dr. Malcolm S. Adiseshiah served as the Director of the Institute from its inception till June 1978. Dr. C. T. Kurien took up charge as Director of the reconstituted Institute in July 1978.

The reconstituted Institute has been operating with widened objectives and activities which include :

Research leading to Ph.D. and M. Phil degrees and enlarged social science documentation centre and library service.

The Annual Report for 1985-86 must begin recording with sorrow the sudden demise of Mrs. Flizabeth Adiseshiah. one of the founder trustees, in the early hours of November 23. 1985. The decision to start the Madras Institute of Development Studies was taken by Dr. and Mrs. Adiseshiah in 1970 and the Institute took shape in 1971 located in a property belonging to Mrs. Adiseshiah. In the early years of the Institute, Mrs. Adiseshiah was closely associated with the work of the Institute. She paid special attention to the library and the Bulletin. When the Institute came within the Indian Council of Social Science Research, she generously donated the property to the reconstituted National Institute. As a trustee, she became a member of the Institute's Governing Council. She took a very keen interest in the building up of the new research centre without ever trying to impose her views. We would like to record here our deep appreciation of Mrs. Adiseshiah's contribution and role in founding and shaping the Madras Institute of Development Studies.

## **Changes in the Governing Council**

As provided in the Trust Deed, necessary changes were brought about in the membership of the Governing Council in July 1985. The two year term of the University representatives came to an end then and hence in the place of Prof. R. Radhakrishna of the University of Hyderabad, Andhra Pradesh, Prof. E. G. Parameswaran of the Osmania University became a member of the Governing Council. Prof. M. Madaiah of the University of Mysore, Karnataka was replaced by Prof. A. M. Rajasekhariah of the Karnatak University, Dharwad, In the place of Prof. C. N. Purushothaman Nair of the University of Calicut, Kerala, Prof. E. T. Mathew of the University of Kerala came on to the Governing Council, and in the place of Prof. V. Gomathinayagam of the Annamalai University, Prof. C. M. Abraham of the Bharathiar University, Coimbatore became the University representative from Tamil Nadu on the Governing Council. Prof. Subba Reddy, coopted member of the Institute retired from the Governing Council after a 4 year period. Prof. S. Gopal, formerly of the Jawaharlal Nehru University and Prof. U. Rajagopalan, Vice-Chancellor of the Tamil Nadu Agricultural University were co-opted as members of the Governing Council. On the demise of Mrs. Elizabeth Adiseshiah, Mr. E.R. Prabhakar, new trustee has become a member of the Governing Council. (The names of the members of the governing Council for 1985-86 are given in *Appendix I*).

## FACULTY

## 1. Research and Writings

In 1985-86 there was no change in the Faculty of the Institute, and no change in the Faculty structure either. The Faculty of the Institute now consists of 3 Professors/ Senior Fellows including the Director, 5 Fellows, 5 Research Associates and 2 Research Assistants Dr Malcolm S Adiseshiah and Dr. R. N. Poduval have continued their association with the Institute's academic activities. as Honorary Professors. A list of the faculty and other members of the Institute is given in Appendix II. In March 1986 Dr. V. N. Deshpande, formerly of the Department of Philosophy, Karnatak University, Dharwad joined the Institute as a Visiting Fellow making use of a Senior Fellowship he has received from the ICSSR for 2 years to work on "The Methodology of Research in the Social Sciences", Prof. Subbiah Kannappan of the Department of Economics, Michigan

State University, United States spent a little over a month in the Institute as a Visiting Professor during July-August, 1985.

Members of the faculty have continued their research and writing on a wide variety of issues. Mr. Guhan's major area of work was on rural development, poverty, and State finances. Prof. Vaidyanathan has concentrated on irrigation, agricultural growth, and rural economy. Dr. Kalpagam has continued her work on women's issues with special reference to women in the informal sector. Dr. Nagaraj has concentrated on demographic aspects in Tamil Nadu with special reference to infant mortality. Dr. Tyabji has been doing work on child labour and small scale industries Mr. Sengupta's major area of concern has been indigenous systems of water management. Mr. Subramanian has concentrated on social choice theory and on measurement of inequality. Dr. Majumdar has continued his work on pre-capitalist production units and their involvement in commodity production. Dr. Padmini Swaminathan's major area of work related to business houses in South India. Dr. Radhakrishnan has completed a major part of his studies on the history of Indian

Ramachandran completed Ph. D. his thesis on agricultural labourers in the Cumbum Valley. Mr. Bharathan continues his work on the Handloom industry in Tamilnadu. Mr. Chandrasekara Naidu has been working on poverty and agricultural changes and Mr. Annadurai on public distribution system. Dr. Kurien's main area of research continues to be the evolution and logic of the market. During the year, members of the Faculty brought out in all over 50 pieces of writings, most of which have appeared in professional journals or as seminar papers within the country and outside. The writings of the members of the faculty have also appeared in the Publication Series of the Institute, as can be seen from the section dealing with publications. In view of the fact that many of the writings by members of the faculty now appear outside the Institute, and sometimes not readily available to members and others interested. it has been decided that selected papers presented/appearing elsewhere should be brought out as MIDS Offprints. The Offprints so far brought out are also listed in that section. (A list of papers written by members of the faculty is given in Appendix III).

Education in the Pre-British period. Mr. V. K.

Members of the Faculty have participated in academic activities outside the Institute. Mr. Guhan presented a paper on 'Rural Development and the Integral Calculus' at the National Workshop on Rural Development and Poverty Alleviation, Hyderabad and a paper on 'Adjustment to What end?' at the Second International Conference of the Research and Information System for the Non-aligned and other Developing countries, New Delhi. He was one of the participants in the Franco-Indian Colloquium on Technological choices for Rural Development held in Montpellier, France in March 1986 where he presented a paper on "Rural Poverty Alleviation in India: Policy, Performance and Possibilities". Along with Mr. R.M. Shroff he also edited Essavs on Economic Progress and Welfare: In honour of I. G. Patel which was published by Oxford University Prof. Vaidvanathan attended Press. the meeting of Economists convened by the Government of West Bengal to discuss the New Economic Policy in September 1985 and presented a paper on "Agricultural Development Policy". He presented a paper on "Aspects of Structure and Change in India's Rural Economy" at the Seminar on State and Development organised by the School of Social Sciences of the Jawaharlal Nehru

University in December 1985, Dr. Kalpagam was a Visiting Fellow at the Centre for Asian Development Studies, Boston University, USA from late November 1985 to early January 1986 where she gave a seminar talk on "Urban Labour Markets in India - Some pretheoretic considerations". She also gave seminar talks at the Institute for Employment Policy, Boston University and at the School of Oriental and African Studies, University of London. She participated in the conference on "Women and the Informal Sector" at Osterwijk. The Netherlands and the Svmposium on "Anthropological Perspectives on Women's Collective Action" held at Mijas. Spain. She presented papers at both these She has also given talks at conferences. the Indian Institute of Technology, Kanpur and the SNDT University, Bombay. Dr. Nagaraj presented a paper on "Infant mortality in Tamilnadu" at the seminar on "Development Experiences in Third World Countries", Rabindra Bharathi University, Calcutta and conducted a seminar at the Department of Economics, Calcutta University, Dr. Tvabii presented a paper on "Child Labour: Dimensions and Implications" at a National Seminar at the Institute for Social and Economic Change, Bangalore. Mr. Nirmal Sengupta presented a paper on "Field Systems, Property

Reform and Indigenous Irrigation" at the Cambridge-Delhi-Leiden-Yogyakarta project on the Comparative Study of India and Indonesia, at Leiden, Holland. He also presented a paper on "Socio-cultural aspects of Big Dams in India" in Udaipur and a paper on "Some recent Fortunes of changing land relations in India" at the seminar on "Land Reforms in India" in Chandigarh. Mr. Subramanian presented a paper on "Rights and Paretianism in a Framework of Fuzzy Preferences" at a Conference on Economic Theory and Related Mathematical Methods at the Indian Statistical Institute, New Delhi. Dr. Kurien gave the Key-note Paper on "The Global Food System" at the National Seminar on the World Food and Hunger Situation, Sydney, Australia and conducted seminars at the New South Wales University, Australia, the University of Illinois, Chicago and the North-Western University, Chicago,

Dr. Malcolm S. Adiseshiah, Honorary Professor edited 4 books during the year:

- 1. "Seventh Plan Perspectives" (Lancer International)
- 2. Enterpreneurship Development for Tamilnadu (East-West Press Pvt. Ltd.)

- 3. The Why, What and Whither of the Public Sector Enterprises (Lancer International)
- 4. Role of Foreign Trade in Indian Economy (Lancer International)

As in previous years, he prepared a Monograph on "Mid-Year Review of the Economy, 1985" and has written several other papers, among which special mention should be made of "Agricultural Development and Social Change" delivered as Sir William Meyer Endowment Lecture of the Madras University and "The State of the Developing World in Education" at an international conference organised by the World Bank. Dr. R.N. Poduval Honorary Professor has completed his study of the "Food Economy of Tamil Nadu", which will soon appear as a publication of the Institute.

The Tamil translation of Dr. Kurien's *Dynamics of Rural Transformation* has been completed by Mr. Annadurai and this will soon appear as the Institute's first publication in *Tamil*, for which arrangements have been made with the Chennai Books, Madras.

In The Tamil Nadu Economy Book Project, practically all first drafts have now been

received. The members of the faculty are now considering what would be the best way to make the material available to a wider public.

## 2. Projects

# (a) Regional Variations in agricultural growth in India

The Food and Agricultural Organisation of the United Nations commissioned the Institute to prepare a survey paper on "Regional Variations in agricultural growth in india". The paper was prepared by Prof. A. Vaidyanathan and was submitted to the FAO in June 1986.

## (b) Management of Irrigation and its effect on productivity under different environmental and technical conditions.

This project is funded by Union Planning Commission and is for a period of 2 years. Prof. A. Vaidyanathan is in-charge of the project which was launched in January 1986. Mr. S. Janakarajan was appointed Project Associate. The Project also has some investigators.

(c) Indigenous Property Relations and Development Strategies : A Comparative Study

## of Water Management in India, indonesia and Phillipines

Under the Indo-Dutch Programme of collaboration in Alternatives in Development" which is being administered by the Indian Council of Social Science Research, Mr. Nirmal Sengupta has been provided funds for a 2 year period to do this project. This is the first international comparative study to be undertaken by a member of the Faculty of the Institute. Mr. Sengupta started work on the project in April 1986.

## 3. Related Activities

Apart from their academic activities, the members of the Faculty have also made contributions to the public life of the country. Dr. Malcolm S. Adiseshiah continues as President of the International Institute for Educational Planning, Paris, President of the Tamilnadu State Council for Science & Technology and President of the Tamilnadu Board of Contining Education/State Resource Centre. Mr. Guhan is chairing a Committee set up by the Ministry of Commerce of the Government of India on the functioning of the Indian Institute for Foreign Trade, the Trade Development Authority and the Trade Fair Authority of India. He completed an evaluation of the State Resource Centre for Non-formal Education. Tamilnadu and a study of the Finances of the Voluntary Health Services, Madras. Prof. Vaidvanathan is a member of the Panel of Economists of the Planning Commission and of the Commission's Research Advisory Committee. He is a member of the Group of Economists organised by the Ministry of Finance and participated in the Annual Pre-Budget Meeting of the state of the economy. He also serves as a member of the Committee. to Improve Statistical System of Andhra Pradesh. He is the ICSSR nominee on the Governing Councils of the Institute for Social and Economic Change, Bangalore and the Sardar Patel Institute, Ahmedabad He also chaired the ICSSR Review Committees for the Centre for Economic and Social Studies. Hyderabad, Institute of Economic Growth, Delhi and the Giri Institute, Lucknow, Dr. Kalpagam is one of the organisers of the Third National Conference on "Women's Studies". Dr. Tvabii has been appointed by the Ministry of Labour. Government of India as a member on a Committee to Review the Working of the Child Labour Project in Sivakasi. Mr. V. K. Bamachandran and Mr. K. Bharathan

have given lectures to the IAS trainees at the Lal Bahadhur Academy. Mr. Ramachandran was also involved with the Training Programme for IAS Probationers of the Tamilnadu Cadre. Dr. Kurien continues to be a member of the Panel of Economists of the Planning Commission and of the Governing Body of the National Sample Survey Organisation. He chaired the ICSSR's review committees for the Gandhian Institute of Studies, Varanasi and G.B. Pant Institute of Social Science, Allahabad. He is also the Vice-President of the Tamilnadu Academy of Sciences.

#### 4. RBI Chair

The Reserve Bank of India has endowed a Chair in the Institute for undertaking Applied Research in Regional Economics for a period of 5 years starting in April 1986. The Executive Council of the Institute welcomed this initiative of the Reserve Bank of India and decided that Dr. Vaidyanathan should be seconded as the RBI Professor in the Institute. The RBI's Endowment also provides for a Research Associate, and for secretarial and messengerial services.

#### 6. External Evaluation

During the year the works of 3 more members of the Faculty, 2 Fellows and 1 Research Associate have been submitted for external evaluation. The reports regarding one of them have been received and the other 2 are yet to come.

## TRAINING PROGRAMMES

#### 1. Ph.D. Programme

It was reported last year that Miss P. Usha became the first full-time Ph.D. scholar of the Institute to complete her Ph.D. Programme. She was declared eligible for the Ph.D. Degree in August 1985. Mr. M. S. S. Pandian followed and submitted his dissertation to the Madras University in October 1985. It is now being adjudicated. Mr. S. Janakarajan has completed his thesis and expects to submit it within the next couple of months, Mr. J. Selvaretnam has also made good progress in his Ph.D. work. He was appointed Assistant Director; Industries, Government of Tamilnadu in June 1986 and has taken up the post, but he expects to complete his

thesis within one year. Mr. M. N. Sivasubramanian also has made considerable progress in his work and has started writing his thesis. Mr. J. Jevaraian has been doing field work in Thanjavur for his thesis. Mr. Edwin Innocent and Mr. K. T. Thomson have both completed their Part I Examination and have started work on their thesis. Mrs. Asha Krishnakumar's work is also making progress. The selection for the award of the ICSSR Ph.D. fellowship was held in February 1986 and Mr. M. Udayakumar and Mr, R. Vidyasagar were selected and have joined the Ph.D. Programme of the Institute as ICSSR Ph.D. scholars. Mrs. Bukmani Ramani who was included in the panel of selected candidates in February 1986. but could not get an ICSSR Ph.D. fellowship joined the Institute subsequently as a non-stipendiary Ph. D. scholar. Mr, T. C. Mohanam, Assistant Professor, Bharathidasan Government College for Women, Pondicherry who was given a Ph.D. fellowship directly by the ICSSR joined the Institute as as a fulltime Ph.D. scholar.

Among the Faculty members who have been doing Ph.D. programme, Mr. V. K. Ramachandran completed his thesis and submitted it to the University in March 1986. Mr. K. Bharathan continues his research on "Handloom Industry in Tamil Nadu" for his thesis. Mr. V. Chandrasekara Naidu has conducted some preliminary field work and has been getting ready for a more detailed field investigation for his thesis on "The impact of agricultural transformation on rural poverty". Mr. C. Annadurai has been working on "Public Distribution System" and has completed one paper for his Part I Examination.

#### 2. Meeting of Ph.D. Scholars and Guides

The annual meeting of Ph.D. scholars and Guides was held in the Institute from 15th to 18th April, 1986. It was attended by 25 Ph.D. scholars from different parts of Tamil Nadu along with a number of Ph.D. supervisors and specially invited :esource persons.

Those specially invited for the session as resource personnel included Prof. K. L. Krishna of the Delhi School of Economics; Prof. U. Sankar of the University of Madras; Prof, V. N. Deshpande, ICSSR Senior Fellow; Prof. T. Prabha of the Lady Doak College, Madurai; Dr. N. Jayaram, Department, of Sociology, Bangalore University, Prof. K. L. Krishna gave two lectures, one on "Gaps in Research in Industrial Economics" and the other on "Econometric Methods the Study of Indian Agriculture". in Prof. Sankar's lecture was on "Quantitative Methods in Social Science Research" and Prof. Deshpande made a presentation on "Methodology of Evaluation Studies". Dr. Prabha gave a lecture on "Issues in Research on Agricultural Costs and Prices" and Dr. Javaram on "Procedures of Research into Social Sciences with Special Reference to Health and Education". Dr. A. Vaidvanathan dealt with "Issues In Research in Bural Development" and Dr. C. T. Kurien made an informal presentation on "Shaping a Ph.D. thesis".

Apart from these lectures and discussions on them, there were a series of group meetings which were meant to enable each Ph. D. scholar to place before the group his/her research proposal and to receive comments from other scholars and guides. The Ph.D. scholars also had opportunities for detailed individual discussions with resource persons.

During the Plenary Session on the final day, the participants expressed the view that they found the 4-day programme extremely useful to share their ideas and research

problems and to get help from other scholars, including the resource persons. In response to the desire expressed by the participants for further help in their research, the Director of the Institute made two specific offers:

- If a research scholar wants to meet a resource person in a different centre in the State and this is endorsed by his/her supervisor, the MIDS would agree to meet the cost of the scholar's travel, and
- ii) If any institution would accept the responsibility for housing/organising the meetings of research scholars such as research methodology courses for those in the early stages of research or more specialised meeting for those at advanced levels, the Institute would make efforts to seek funding for such meetings.

#### 3. Short-term Internship Programme

During the year under review, no one was selected for the Internship Programme.

#### 4. Computer Training Programme

After the Apple II Plus Computer was commissioned in the Institute in February

1986, a 2-month Training Programme for members of the Faculty and Ph.D. scholars of the Institute was organised by the Centre for Applied Statistics. 6 members of the Faculty and 6 Ph. D. scholars took the course. A qualifying examination was conducted in June 1986:

Under the sponsorship of the Union Ministry for Human Resources Development, the Institute organised a National Seminar on 'Financing of Education' which was held on October 23, 24 and 25. It was part of the series of seminars being conducted in different parts of the country in connection with the formulation of the new education policy. The participants of the seminar included Thiru C. Aranganayagam, Minister of Education, Government of Tamil Nadu, Dr. R. J. Chelliah, Member, Union Planning Commission. Shri Anand Sarup, Secretary, Department of Education, Government of India, Shri J. Veera Raghavan, Adviser (Education), Union Planning Commission, Thiru T. D. Sundar Rai, Commissioner and Secretary for Education, Government of Tamil Nadu, Dr. G. D. Sharma and Dr. J. B. G. Tilak, National Institute for Educational Planning and Administration, Prof. P. R. Brahmananda, University of Bombay, Dr. V. C. Kulandaiswamy, Vice-Chancellor, Anna University, Dr. P. R. Panchamukhi, Director, Indian Institute of Education, Poona, Dr. R. Radhakrishnan, Director, Centre for Economic and Social Studies, Hyderabad, and Dr. Amric Indian Book Chronicle. Singh. Editor. Dr. Malcolm S. Adiseshiah chaired the seminar on the first two days and Dr. C. T. Kurien on the third day. Mr. S. Guhan acted as the rapporteur.

#### b) Seminar on World Development Report

On Friday, August 2 under the joint sponsorship of the Institute and the Institute for Financial Management & Research, a seminar on the World Bank's *World Development Report 1985* was held at IFMR. Mr. Francis Colaco, the principal author of the Report made a presentation on the main theme of the Report, viz., International Capital and Economic Development. The presentation was followed by a very lively discussion. The seminar was attended by academics, officers of the Government, industrialists, bankers and journalists and was moderated by Dr. Malcolm S. Adiseshiah.

#### c) Seminar on Financing of Elections

The Institute collaborated with the Rajaji International Institute for Public Affairs and Administration and the Institute for Financial Management and Research to hold a seminar on "Financing of Elections". The seminar was held at IFMRon Saturday, 28th September, 1985. The seminar brought together persons who were directly involved in elections as candidates or agents of candidates, administrators who had special responsibilities for holding elections and social scientists with special interest in the study of elections. The main participants were Mr. C. Subramaniam, former Union Minister, Mr. Era Sezhiyan, Tamil Nadu Janata party Leader, Mr. S. L. Shakdher, former Election Commissioner, K. Ganesan, former Secretary, Election Commission. Mr. R. V. Chandramouli, Chief Secretary. Guiarat, Mr. G. V. K. Rao, former Member, Planning Commission.

Dr. Malcolm S. Adiseshiah, Mr. S. Guhan Mr. A Vaidyanathan and Dr. C. T. Kurien from the Institute participated in the seminar. The seminar made many concrete recommendations for reducing campaign and election expenses. These included the introduction of electronic voting machines to reduce the campaign period, partial State financing of election expenses of candidates, introduction of mobile polling booths to discourage the practice of candidates/parties providing transport for voters, compulsory registration of all political parties with compulsory audit of the accounts of the parties etc.

## INTER-UNIVERSITY COOPERATION

## 1. Fifteenth Meeting of Social Scientists

The Fifteenth annual Meeting of Social Scientists from Southern Universities was

held in the Institute on Saturday, 7th and Sunday, 8th December. Only 12 social scientists attended the session, the lowest during all the past 15 years. The disciplines represented were anthropology, commerce, economic, geography, library science, political science and sociology and the participants were drawn from 4 universities, the ICSSR Southern Regional Centre and Madras Institute of Development Studies. The Review Paper on Teaching and Research was on Commerce by Dr. D. Amarchand, Professor and Head, Department of Commerce, University of Madars. As none of the other professors of commerce invited could attend the session. the discussion on the paper was rather limited. Following up the statistical analysis that the ICSSR Southern Regional Centre had made in the past 2 years on the Ph.D. research work in South Indian Universities, this time there was a presentation of the trend in Ph.D. research in South India. once again prepared by the Southern Regional Centre. The procedure followed was for one or in some cases two, social scientists in each discipline to examine the list of Ph.D. theses prepared in the Universities in South India and to identify the trends and gaps. The group found the exercises extremely valuable and suggested that a more detailed analysis of the material should be prepared with an attempt being made to ensure that the coverage is comprehensive. For this purpose a committee of 3 in each discipline has been indicated. The expectation is that under the sponsorship of the ICSSR Southern Regional Centre and the Madras Institute of Development Studies, a detailed analysis of Ph.D. theses themes in the social sciences in South India would be taken up in 1986 to be placed before a larger meeting of social scientists towards the end of the year and to be published thereafter.

## 2. Sixteenth Census of Social Science Research

The annual Census of Social Science Research in the Southern States was conducted early in 1986. The total number of entries received was 536 which was the highest number of entries received so far compated to 408 last year and 422 in 1984. Even so, the census is still not what it should be and many leading research institutes, universities and colleges have not responded to make the census report a comprehensive document of social science research in South India. The largest number of entries, 217

were from Tamil Nadu. The second place went to Andhra Pradesh with 146 entries and the third place to Karnataka with 140 entries. From Kerala there were only 33 entries which, however, was one more than the last year's 32. In terms of subjects, the largest number of entries, as usual, was from Economics (211 entries, i.e. 39 per cent). This was followed by Commerce & Business Administration with 83 entries. History with 47 entries, Education 37 entries, Anthropology, 31, Political Science 26, Agriculture 16, Sociology 15, Geography 13. Law 12. Social Work 8, and Home Science 7. Of the 536 entries, 278 related to Ph.D. thesis and 179 to M Phil dissertations. The results of the census were published in the May-June issue of the Bulletin.

## 3. Sixteenth Interdisciplinary Research Methodology Workshop

The Sixteenth Interdisciplinary Research Methodology Workshop organised jointly by the Institute and the Indian Council of Social Science Research was hosted by the Department of Sociology, Bharathiar University, Coimbatore from 4th to 7th June, 1986. The session was attended by 29 participants belonging to the disciplines of agcinritural economics, environmental science, economics, industrial engineering, management science, material science, political economy, philosophy, psychology, sociology & anthropology. The main theme of the Workshop was "Science, Technology and Society". The following papers were specially prepared for the Workshop and were presented and discussed there :

#### LIBRARY

The library added 1817 volumes between June 1985 and July 1986. It received 194 journals which include journals on subscription, exchange and gratis. A special effort has been made this year to identify and secure books relating to the socio-economic history of Tamil Nadu.

The library continues to bring out the list of additions to the library and list of articles from the journals received, Consultancy service is provided for researchers and scholars of other institutions and a number of scholars of other institutes have made use of the library.

The Library Committee in which all members of the Institute take turns to serve have been meeting regularly almost once a fortnight and continues to guide the Librarian in procuring books and periodicals and in matters relating to the use of library materials.

#### VISITORS

Many distinguished scholars and public figures visited the Institute during the year, as can be seen in *Appendix V*. Special mention must be made of a delegation of social scientists from Vietnam led by Prof. Pham Nhu Cuong, President of the Social Sciences Committee of Socialist Republic of Vietnam and 3 other scholars who visited the Institute on 29th March, 1986.

Prof. P. N. Dhar, Chairman, Prof. Kuldeep Mathur, Member-Secretary and Prof. Victor D'Souza, Member of the Third ICSSR Review Committee visited the Institute on 8th April. They met with the members of the Institute as well as social scientists from the city and had a discussion on the role of the Indian Council of Social Science Research in promoting social science research in the country.

#### FINANCE

For the year 1985-86 (1st April 1985 — 31st March 1986) the ICSSR sanctioned and released a total sum of Rs. 6.90 lakhs towards recurring expenditure (Rs. 5.75 lakhs under non-plan and Rs. 1.15 lakhs under plan). The Government of Tamil Nadu have sanctioned as part of their matching share a sum of Rs. 6.00 lakhs but released only Rs. 5.13 lakhs after deducting a sum of Rs. 0.87 lakh which was treated by them as the excess grant released for 1984-85. It has been brought to the attention of the Government that there has been a misunderstanding in this matter, and a representation has been made to have the balance amount of Rs. 0.87 lakhs also released. The Tamil Nadu Government have also been approached for the further sanction of Rs. 0.90 lakh to match the amount sanctioned subsequently by the ICSSR.

Under non-recurring items the ICSSR sanctioned and released a sum of Rs. 1.35 lakhs, but specifying it as the second instalment towards the grant 'on account' basis for the purchase of a Computer. The ICSSR has been approached for reappropriating this amount for the purchase of furniture and equipments which was postponed due to paucity of funds. The ICSSR has agreed to comply with this request and to place the matter before the Research Institute's Committee for reappropriation.

During 1985-86, the Tamil Nadu Government also sanctioned and released a sum of Rs. 3.50 lakhs towards the balance recurring grant for the year 1984-85. The final instalment of Academic building grant of Rs. 45,000/- was also sanctioned and released. A. sum of Rs. 30,000/- due towards the nonrecurring expenditure for purchase of library books for the year 1983-84 was also sanctioned and payment received. A sum of Rs. 50,000/- towards non-recurring grant for the purchase of back volume of journals and equipments for the year 1984-85 was also sanctioned and payment received. (Financial Statements for 1985-86 are in *Appendix VI*).

When the State Government accepted the recommendation of the Fourth Pay Commission and revised the pay scales of its employees, the Executive Council of the Institute decided to revise the pay and allowances of the non-academic members of the Institute in line with the revised scales of the Tamil Nadu Government and to accept the new allowances suggested for the academic staff. The decision of the Executive Council was ratified by the Governing Council at its meeting in September 1985.

#### SEVENTH PLAN REVIEW

The Seventh Five Year Plan Review Committee with Prof. V.M. Dandekar, former

Director, Gokhale Institute of Politics and Economics, Poona as Chairman, Dr. B.B. Sundaresan, Vice-Chancellor, University of Madras, Madras. Dr. T. S. Papola, Director, Giri Institute of Development Studies, Lucknow, Prof. V. M. Rao, Fellow, Institute for Social & Economic Change, Bangalore, Dr. K.K. Subramanian, Fellow, Centre for Development Studies, Trivandrum and Mr. Harsh Sethi, Deputy Director, Indian Council of Social Science Research visited the Institute on Tuesday, 3rd December and Wednesday, 4th December. The Review Committee held sessions with the academic personnel as a group and with individual members who had expressed a desire to meet the Committee, Ph. D. scholars and administrative and library staff. The Committee also had a session with the members of the Governing Council resident in Madras. The Committee made an evaluation of the work and progress of the Institute during the Sixth Plan period and has also indicated guidelines for the development of the Institute during the Seventh Plan period in terms of the acadmic programme and financial and infrastructural facilities. The report of the Review Committee is yet to be received.
