Dr. Malcolm S. Adiseshiah and his wife Elizabeth founded the Madras Institute of Development Studies (MIDS) in 1971 with the following objectives :

- To undertake studies and research pertaining to development problems with special reference to the agro-rural aspects of Tamil Nadu and the problems of the economically and socially backward sections of the population throughout the country.
- To conduct seminars and conferences on development problems and programmes of the State.
- To foster inter-university cooperation among the social scientists of the Universities of the four southern states.
- To promote interdisciplinary research, and bring out publications relating to the above three functions.

In 1977, MIDS was reconstituted as a national institute jointly sponsored by the Indian Council of Social Science Research, New Delhi and the Government of Tamil Nadu.

The research concerns of the faculty are wide ranging from the concerns of development economics such as agriculture, rural development, industry, urbanisation and labour, to emerging interdisciplinary areas such as gender, environment, human development, social and political movements, and social criticism.

Through its seminars and workshops, MIDS has become a centre for critical thinking on development issues, particularly relating to Tamil Nadu. The service of faculty members is increasingly sought by State and Central Government departments, Autonomous agencies, Universities and Colleges, Non-Government and International organisations. In 1996, MIDS celebrated its Silver Jubilee with a number of programmes and workshops, and by improving the quality of its library and computer infrastructure. The composition of the Governing and Academic Councils of the Institute are furnished in *Annexures I and II*.

Preamble

The reporting year has witnessed the Institute striving to achieve the blend required between stability and dynamism which is so critical for the welfare and growth of an academic centre. Continuing excellence is contingent on firm anchorage as well as the enthusiasm to engage in newer and relatively under explored terrains of inquiry. The report which follows, hopefully, brings this into relief.

Professor C. T. Kurien relinquished office as Chairperson on 31 July 2003. On 1 August Professor M. Anandakrishnan took over as Chairperson. Professor Anandakrishnan is a former Vice-Chancellor of the Anna University and earlier Scientific Advisor to the Indian Embassy in the USA. He has also had a long association with the UN.

The list of faculty members and their areas of research is provided in *Annexure III*. The composition of administration, research support staff and library is given in *Annexure IV*.

A noteworthy feature is that the trend towards relative financial stability which the last annual report referred to has continued. Although there has been no major benefaction we have not had to cope with financial stress. This has certainly had a salutary effect on the functioning of the Institute.

No recruitments to the faculty were made during the year but some are planned in the coming months.

There is an impressive increase in the number of research projects in the Institute. Particularly worthy of note is that many of them are of comparatively long duration which helps in capacity building apart from contributing to the Institute's financial well being.

Professor Y. Subbarayalu, eminent historian and epigraphist, spent five weeks as the Adiseshiah Visiting Professor in November-December 2003. During this period he delivered a special lecture on "History & Epigraphy" in Tamil, a first of its kind

in MIDS and also organized a seminar on "Formative phase in South Indian History & early epigraphy" which was attended by all the leading scholars in the field. We believe this to be a reflection of the expanding range of interests in the Institute. The seminars by visitors and faculty are given in *Annexure XIV*. The list of visitors to the Institute is provided in *Annexure XV*.

Professor Andre Beteille, distinguished sociologist, has agreed to be the Adiseshiah Visiting Professor for two weeks in early 2005.

The last year also saw the institution of the Founder's Day Lecture. The inaugural lecture was delivered by Professor U. R. Anantha Murthy, renowned writer and Janapith Awardee, on 19 April 2004. The title of his lecture was: "Globalisation and its portents for Indian culture". The lecture will be an annual event. Professor Anantha Murthy also released the Adiseshiah Memorial Lecture delivered by Professor Jandhyala Tilak on the occasion of the conferment of the Adiseshiah Award for distinguished contributions to Development Studies.

The jury for the Adiseshiah award for 2004 has recommended Professor Dipankar Gupta, Professor of Sociology, JNU, for the award. The presentation will be on 22 November 2004. The jury comprised of Prof. K. N. Panikkar, Sri Sankaracharya University of Sanskrit, Kerala; Prof. K. L. Krishna, Delhi School of Economics, Delhi and Prof. Andre Beteille, Retd. Prof. of Sociology, Delhi School of Economics.

An achievement to be recorded is the increasing dissemination activity especially in Tamil. On 26 December 2003 the volume edited by Professor Janakarajan titled: *Avala Nilayil Tamizhaga Arugal* was released by the Governor of Tamilnadu Thiru P. S. Rammohan Rao. Professor V. C. Kulandaiswamy spoke about the book and highlighted its major contributions. Several members of the faculty have been publishing in Tamil. In the domain of dissemination should be included the intervention in the Cauvery dispute mainly through bringing the farmers of

Tamilnadu and Karnataka together. This initiative of Professor Janakarajan's has resulted in several rounds of meeting of what has come to be known as the "Cauvery Family". The next meeting is likely to be held in Karnataka in September.

A number of activities are planned for the coming year. Among them will be a workshop on the idea of south India in which we are collaborating with CSSSC, Kolkata. This is scheduled to take place towards the end of the year. Also on the anvil is a seminar on social sciences tentatively planned for early 2005. In September we shall hold a seminar on Information technology and Social Sciences. This is being organized as part of the Adiseshiah Chair in Policy Studies.

We have also benefited from the presence of visiting scholars who have come to us as affiliates. A list of affiliates are given in *Annexure XVI*. The list of Ph.D. candidates and their areas of study are given in *Annexure XVII*. Some of them have made seminar presentations. Workshops were conducted during the past year as part of on-going projects. Among them may be listed the one organized by Professor Janakarajan on his DFID project on peri-urban water problems, and one on devolution in an international perspective which is part of the project on devolution. In January we co-sponsored a workshop on India's demographic profile which was organised in connection with the release of the book "21st Century India: Population, Economy, Human Development & the Environment" authored by Robert Cassen, Tim Dyson and Leela Visaria.

There is a steady accretion to our pool of research scholars and attempts are being made to streamline the course work for them. The increase in numbers has made their presence noticeable and has played its role in widening the work perspectives of the Institute.

Research Orientations

The diverse work of the faculty and their academic activities are mentioned in *Annexures V to XIII*. The academic activities of the programme, Ph.D. Scholars and project staff are given in *Annexure XVIII*.

THEORETICAL PERSPECTIVES

Professor S. Subramanian represents one of the principal theoretical reference points in our work. In the year under review he has published papers which address questions relating to the following: the Foster-Green-Thorbecke poverty indices, poverty redress through direct income transfers and wage employment programmes, anti-poverty policies with an egalitarian constraint and inter-connections and indicators of horizontal and vertical inequality. The last of these is co-authored with Dr. Jayaraj. Professor Subramanian has also contributed to the discussion on the Basu-Foster framework. Four of his papers were published in the UNU-WIDER research paper series. He has also engaged himself in teaching the Ph.D. scholars in the Institute.

A quite different strand of theoretical work is represented by Dr. Ananta Kumar Giri. Continuing his contestation of the theme of development he has published papers which deal with questions such as pluralism and rights, politics and ethics of consumption, and knowledge and human liberation. Dr. Giri has made presentations in seminars and conferences on these and related themes many of them converging on issues pertaining to what he terms 'development as global responsibility'. He co-organised an international seminar on global responsibility at the Research Center Percik, Salatiga, Indonesia which also coincided with the publication in Bhasa Indonesian his co-edited book *A Moral Critique of Development as Kritik Moral Pembangunan*. He has also to his credit a paper on social science research in India.

DEMOGRAPHY

Demographic studies continue to be important on our research agenda. This area is notable for the fruitful collaborative work between Dr. Jayaraj and Professor Subramanian. An important paper of theirs on women's well-being and the sex ratio at birth is to be published in the *Journal of Development Studies*. They have also published an incisive critique of a book on religious demography as a review article in *EPW*. Dr. Jayaraj is working on the trend in sex differentials in

mortality in India. One of his Ph.D. students, Dr. Antony Raj was awarded a Doctorate in May for his thesis on child labour. Along with Professor Subramanian he is working on a book on "Poverty, labour and population"

GENDER

Professor Padmini Swaminathan has a project, along with Dr. Anandhi, to survey 'Women's Studies in Tamilnadu'. Supported by the Malcolm & Elizabeth Adiseshiah Trust they aim to map out the meaning of women's studies in the state. A preliminary paper was presented at a seminar in JNU in March 2004.

Professor Padmini Swaminathan has published papers and made seminar presentations on gender locating it within the broader perspective of the development discourse.

Dr. S. Anandhi, a historian by training, concentrates on situating her work on gender within a historical framework. One of her significant publications is a discussion of the women's question in the Dravidian movement. Equally important is her contribution to the Abortion Assessment Project sponsored by the Health Watch Trust and CEHAT, Mumbai. Dr. Anandhi co-ordinated an exceptional workshop on the "Dialogue across margins: Culture, Gender and Empowerment among Minorities" jointly with the University of Michigan, which promoted a dialogue between Afro-Americans and Dalits.

Both Professor Padmini Swaminathan and Dr. Anandhi have invested time and energy in dissemination relating to gender studies.

HUMAN DEVELOPMENT, POVERTY AND EMPLOYMENT

Three members of the faculty and a research scholar made a critical study of the Tamilnadu Human Development Report which was published in *EPW*. The review looks at the HDR from a variety of perspectives and proved useful at a workshop which MIDS organized on the report in March 2004.

Professor Padmini Swaminathan has co-

authored a monograph on understanding poverty in India. She has worked on the role of interventions in transforming rural livelihoods. Given her strong interest in gender studies she seeks to explore the inter-connections between economic reforms, gender and health.

Dr. M. Vijayabaskar works broadly in the Political Economy of Indian Industrialisation with focus on the relationship between industrial organization, technology and labour. His work includes studies of industrial clusters and on the impact of ICT diffusion on labour markets in India. He was Charles Wallace Visiting Fellow in Contemporary Indian Studies at SOAS, London. He has co-authored papers on these issues as also on constraints in high-technology clusters. His interests include employment and upgrading projects for labour.

WATER AND IRRIGATION

At least three members of the faculty contribute substantially to irrigation and water management studies.

Professor Nirmal Sengupta who has a long standing commitment to this line of study has worked on the role of institutions in irrigation, importance of rainwater harvesting, and common pool resources which he studies from the Indian legal system's perspective. Professor Sengupta's work is notable for its institutional emphasis.

Professor S. Janakarajan who also has a long standing interest in water management has come to focus increasingly on dialogue with stakeholders. One productive offshoot is the edited Tamil volume referred to earlier. A newer area he engages in is peri-urban issues in the context of the drinking water crisis in Chennai. A key feature of his work is the analysis of what he describes as "unequal contracts" and "unexplained conflicts" in water management. Professor Janakarajan directs two major research projects: one supported by IDRC, Canada, on local water management and the other supported by DFID, U.K. which deals with negotiations over water conflicts in peri-urban catchments. Apart from this he has initiated the

farmers' dialogue on the Cauvery dispute to which reference has been made.

Dr. K. Sivasubramaniyan has worked on efficiency of water use in Indian agriculture and on tank irrigation. Recently he has taken up a collaborative research study on efficiency of water use in canal irrigation in the Palar river basin. He is associated with Professor A. Vaidyanathan in data based estimation of the productivity of irrigated and unirrigated crops in major Indian states. Dr. Sivasubramaniyan has contributed articles in Tamil to the print media on his areas of work.

INTERNATIONAL TRADE

Dr. Moana Bhagabati is engaged in work on the multilateral and regional trading system, in particular relating to the WTO. She has participated in conferences and seminars pertaining to the WTO, IPR regime, and the trade and globalisation debate. Prof. Nirmal Sengupta and she are completing a project supported by the Union Ministry of Commerce on Trade Facilitation in India. They have brought out a joint Working Paper on this subject. She has also co-authored a contribution on trade facilitation for the India Development Report 2004. She is elaborating on her study on the subject to encompass cross border measures along India's Northeast. In addition she has contributed a paper on international relations in the Encyclopedia of Society & Culture in Assamese.

Professor Nirmal Sengupta blends his interest in trade and IPRs with his work on traditional knowledge. Apart from the project on trade facilitation (with Dr. Moana Bhagabati) Professor Sengupta has made contributions in the realm of traditional value systems, indigenous knowledge and IPRs.

POSITIVE DISCRIMINATION, IDENTITY POLITICS

Professor P. Radhakrishnan continues to pursue his research on affirmative action/positive discrimination. He has been actively involved in furthering the debate on the effects of globalisation on religion and more generally its "imperial characteristics". During the review year Professor

Radhakrishnan has participated in conferences devoted to higher education and the future of social sciences.

Dr. M. Thangaraj, presently at Dr. Ambedkar Centre for Economic Studies, University of Madras, is deeply involved in appraising India's development from the viewpoint of the oppressed. Significant among his works are an edited volume on land reforms in Tamil Nadu (published by Sage, 2003) and the evaluation of the Tahdco schemes in Tamil Nadu. The latter was supported by the Government of Tamil Nadu's Adi Dravidar and Tribal Welfare Department. Another major work of his is a paper on "Dalits and Panchayats in Tamil Nadu" to a project conducted by CSDS, Delhi for the World Bank.

Dr. C. Lakshmanan's work in a broad sense, belongs to the same genre. He has published on the question of Dalit masculinities in social science research and has reviewed the (Dalit) autobiography of Vasant Moon for EPW. Dr. Lakshmanan has actively engaged himself in the debate on the dialectics of Indian democracy, the Dalit movement and the wider issue of human rights. Only recently he has taken up a project on "Television, globalisation and social change in India" which is funded by the Victoria University, Melbourne, Australia.

Prof. Nirmal Sengupta has a keen interest in identity. Especially significant are his publications focusing on Jharkhand.

LITERARY, CULTURAL AND SOCIAL HISTORY

Dr. A. R. Venkatachalapathy's field is social and literary history and culture with a focus on colonial Tamil Nadu. He has published four books in Tamil, one of which is a translation and has several papers in edited volumes, all of them focusing on different dimensions of the Tamil cultural scene. He was an invited participant to the International Round Table at Yale University on language and historical imagination. He also participated in a seminar in George Washington University which was on autobiography. He attended an international seminar on Elites in South Asia in the University of

Tokyo. Dr Venkatachalapathy's work reflect both his training as a historian and intense commitment to Tamil cultural studies.

Dr. Anandhi, the other historian on our faculty, has publications dealing with women's writing and self-respect history, contemporary discourses on community and identities. Her work is a blend of a historian's approach and gender concerns.

DEVOLUTION AND GOVERNANCE

There are two long-term projects on devolution and governance. Both are supported by the Development Research Centre in the IDS, University of Sussex, U.K.

The first is a comparative study of decentralization in Tamil Nadu, Karnataka and West Bengal. Two working papers tracing the evolution of devolution in Karnataka and West Bengal have been brought out. Field work has been completed in all three states as also data collection on the finances of village panchayats. There is also a proposal to extend the study into an international framework by making comparisons with Ghana and South Africa. Professor V. K. Natraj, Dr. Chandrasekara Naidu, Dr. Manabi Majumdar, Dr. Kripa Ananthpur and Dr. Ganesh Prasad are involved in this study.

A related project is an evaluation of the training programme for elected Grama Panchayat members developed and conducted by the State Institute for Rural Development, Government of Karnataka. Dr. Ganesh Prasad is in charge of this study with which Professor V. K. Natraj and Dr. Kripa Ananthpur are associated.

Dr. Kripa Ananthpur has continued her research on the interface between informal/customary institutions and their formal/statutory counterparts. Her field work is complete in thirty villages in Karnataka. She plans to study the role and influence of customary panchayats during the elections to Panchayats to be held in Karnataka in early 2005. Her publications include a working paper in MIDS and one published recently by IDS, University of Sussex. As part of her study Dr. Kripa was invited to the Centre for Policy Studies,

Johannesburg in October-November, where she studied the role of traditional leadership in local governance in South African context. This should help situate her inquiries in a comparative international frame of reference. At CPS, she made presentations and participated in seminars and discussions. She along with Dr. Manabi Majumdar and Professor Natraj participated in the annual meeting of the DRC in July 2003 and made a presentation of her on-going work. She presented a paper in the National Academy of Administration, Mussorie in February on gender and land rights with a specific focus on the institutional dimensions. She has lectured to students of Mass Communication in the University of Madras on development and political communication.

Dr. V. Chandrasekara Naidu has been working in the study on devolution. He expects to finalise a working paper on the evolution of devolution in Tamilnadu shortly. He is also engaged in a study of Tamilnadu's finances and has lectured in several forums during the year. He represented MIDS in a workshop on the future of development assistance organized by SIDA in New Delhi.

In addition to the work on the above mentioned projects Dr G. S. Ganesh Prasad is also actively involved in directing the preparation of the State Development Report for Pondicherry. Professor Thangaraj is the Director of the project in which the Swaminathan Foundation and the Institute for Financial Management and Research are partners. Dr. Ganesh Prasad has contributed to the Atlas of Sustainability of Food Security prepared by the Swaminathan foundation. He made a presentation in the Indian Science Congress in 2003.

Apart from her work in the project on devolution Dr. Manabi Majumdar has a project supported by IDPAD/ICSSR on "Decentralisation reforms in education and their impact on access and quality of primary schooling". In this she collaborates with Dr. Jos Mooy of the ISS, The Hague. She has published papers in edited volumes as well as in journals. In July 2003 she was a Visiting Fellow at the Centre for Modern Oriental Studies in Berlin.

LABOUR

Professor K. Nagaraj has completed his report on "Contractual arrangements in labour markets: The case of plantations in Tamilnadu". The study was supported by the National Labour Institute and the Malcolm and Elizabeth Adiseshiah Trust. He directs an international project on: "Rights, Representation and the Poor". Funded by the DRC in IDS and the London School of Economics it spans Delhi, Bangalore and Coimbatore in India, Sao Paulo in Brazil and Mexico city. Active researchers in the project are drawn from India, U.K. and Brazil. Professor Nagaraj organized a workshop in Bangalore in June to discuss the project's preliminary findings. He has offered a course of lectures in the Asian College of Journalism.

MIDS has two Professors Emeritus, Professor C. T. Kurien and Professor A. Vaidyanathan. After relinquishing office as Chairman of MIDS, Professor Kurien, confines himself mainly to book reviews, on an average one a month on subjects dear to him such as economics, education and public affairs. In his own words he keeps busy reading all that he missed during his days as a full time academic—Malayalam fiction, philosophy and the like.

Professor Vaidyanathan has brought out two books. One is a collection of his papers and is titled: *Economic Reforms and Development*, Academic Foundation, Delhi. The other a volume co-edited with H. M. Oudshoorn is a collection of papers titled: *Managing water scarcity: experiences and prospects*, Manohar Publishers, Delhi. He has also brought out two working papers in MIDS, apart from a paper on interlinking of rivers in *EPW*.

What is presented here can at best be described as a snapshot picture of the Institute's research work. Capturing the work of the faculty in a brief report is daunting. It is the more so considering its variety and the fact that several have published in more fields than one.

Journal

The Institute's *Journal Review of Development*

and *Change* is being brought out with reasonable regularity. Edited by the Director it has the active involvement of three of the younger faculty.

Infrastructure

The IT infrastructure in MIDS has state-of-the-art computing facilities with the latest hardware, software and supporting equipment.

MIDS has configured a structured Local Area Network (LAN) catering to about 100 users in the Institute. The Institute has configured a 64 kbps leased line connectivity from VSNL for providing round the clock Internet facility to its members. The Institute has also configured its own web server (<http://www.mids.ac.in>) and mail server hosted in the campus.

Library

From July 2003 to June 2004 the library added 1250 documents including bound volumes of journals and books. 43 foreign journals and 85 Indian journals were renewed. A new Indian Journal Monthly Review of the Tamilnadu Economy brought out by the Centre for Monitoring Indian Economy has been added to the list.

The Ford Foundation has given us the JSTOR database (archival) wherein we can browse, search and download 299 journals pertaining to social sciences. This database can be accessed by all.

Finance

The audit report for the year under review is as per *Annexure XIX* presents the financial position of the Institute. A sum of Rs.120.47 lakhs is the recurring expenditure for the year 2003-2004. Against the recurring expenditure the ICSSR released by March 31, 2004 a sum of Rs.77.00 lakhs. The Tamil Nadu Government had released by March 31, 2004 a sum of Rs.35.00 lakhs (in arrears of 2002-03) and Rs.50.00 lakhs (2003-04). Taking into account all receipts and expenditure the actual surplus for the year 2003-2004 amounts to Rs.10.46 lakhs.
