ALLEVIATION OF THE DISTRESS OF ANOTHER HUMAN BEING IS THE NOBLEST SERVICE THAT WE CAN RENDER TO HUMANITY

-Inaugural Address by Hon'ble Chief Minister Puratchi Thalaivi Dr. J. Jayalalitha at the International Meet on Welfare of the handicapped (3.12.1994)

It gives me great pleasure to extend a warm welcome on behalf of the people and the State of Tamil Nadu to the Hon'ble Union Minister for Welfare, Shri Sitaram Kesri, the Hon'ble Ministers from various states, in charge of Social Welfare and the Specialists and Experts who have accepted our invitation and have come here

from various parts of the World. I wish to express my sincere appreciation of the fact that Shri Sitaram Kesri, the Hon'ble Union Minister for Welfare, inspite of his busy schedule and pressing engagement has taken the time and trouble to come all the way to Madras to participate in this Meet. We have gathered here on a solemn

occasion to discuss and deliberate upon important issues on the status, rights and welfare of the handicapped.

These deliberations will I hope, lead to the evolution of a State Policy for the welfare of the handicapped.

The Government of Tamil Nadu had been deliberating



about the issues connected with the welfare of the handicapped, and I thank each and every one of you for your dedication to this noble cause, and the expertise that you have so very willingly shared with us. This has enabled us to synthesise the framework of a state policy symbolising our genuine concern and care for the handicapped. implementation calls for heavy investments in terms of financial outlays, human resources and training. Integration and coordination and ensuring the convergence of services for the physically and mentally handicapped covering the entire gamut of activities and services, from prevention of disabilities at birth to rehabilitation programmes

What is a handicap? Perhaps everyone of us is handicapped in one way or another, though the percentage of handicap may differ. One may be handicapped by poverty or by physical or mental defects. Therefore, we should address first the psychological blocks that most of the handicapped would possess and then address their social needs, so that the quality of life of the physically handicapped persons is enhanced and brought up as near as possible on par wiht the standards that every one of us would like to attain in life.

We have brought out a policy for the handicapped which will be in the nature of a charter of the State. Planning a charter and its

implementation calls for heavy investments in terms of financial outlays, human resources and training. Integration and coordination and ensuring the convergence of services for the physically and mentally entire gamut of activities and services, from prevention of disabilities at birth to rehabilitation programmes covering the life span of the disabled, fall under various sectors of the plan; more particularly health, nutrition, education, science and technology, implementation and welfare, creation of public awareness and the like. We have to integrate the services of the Government Departments with the zeal and enthusiasm of Non-Governmental Organisations that come forward to lend their support, time and money. It is only when such coordination and effective intersectoral programme alignments and entwinement are achieved that the policy would get the much needed thrust for full implementation, to make the handicapped persons active, self-reliant and productive

citizens of the State and the

Nation drawing as much as possible from education, vocational training and economic and social rehabilitation services that are planned.

When we speak about research efforts to prevent and correct disabilities even before birth, the time and energy, skills and training and the dogged patience necessary in the pursuit of research goals would all call for substantial resource applications. Most of us who are from the Government and in charge of public administration or schemes, are well aware that the resources hitherto applied would only help us touch the fringe of the problem. It is estimated that 2% of the State's population are likely to fall under the category of disabled persons. In the State's Annual Plan outlay of 2,750 crore rupees, ordinarily, a budgetary support of 2% or 55 crore rupees for the rehabilitation of the disabled should be provided. We have been able to provide an outlay of only 8.40 crore rupees during this financial year, owing to resource constraints, though this com-

pares well with the 39 lakh rupees spent by the State for the Welfare of the Disabled during 1978-79 and the 400 lakh rupees spent by the Government of Tamil Nadu during the year 1989-90.

It is in this context that we would suggest to the Government of India that if we are able to mobilise additional resources or earmark additional resources towards fulfilment of this noble cause. there should be a 200% matching grant from the Government of India, without which policies would take much longer for translation into plans and programmes resulting in anticipated benefits.

I am sure, our meeting here today and our sense of togetherness and sense of purpose would enable us to

chalk out programmes for the individual handicapped, and also to develop collective programmes which would inspire educationists, psychologists and paramedical workers and health workers, in and outside the Government orbit, to better equip themselves for rendering service to those impoverished individuals who are physically and mentally less fortunate than their brethren. I seek your assistance to develop new role models for the aid and service that not only the State but every citizen in Society can render to the handicapped. Driven by noble inspiration to reach out to those who cannot reach out for themselves, we all have gathered here from different parts of the globe and also from different corners of India. Let our united need.

efforts help to share and lighten the burden and anguish of our less fortunate brothers and sisters. Alleviating the distress of another human being would be the noblest service that we can render to humanity. Let us unstop our ears, uncover our eyes, and unlock our hearts with the courage to look at the world with the eves, and ears of the handicapped. We will then listen to the mute, hear the deaf, walk with the limbless and converse with the mentally retarded.

I am happy to inaugurate this International Meet, and express the hope that your deliberations will prove to be rewarding and assist us to provide succour to those in

forward, not merely as a plan of action but as a constructive programme of curative and welfare measures, to be funded and implemented, whatever be the outlay and resources required. Many great minds from different fields, from India and abroad, have assisted us to shape and put this policy together, and I would like to thank all of you who have been kind enough to give us your valuable contributions.

The world over, human beings or able bodied men and women have extended their kindness and helping hands to their disabled brothers and sisters. Perhaps this kindred spirit has been fostered and nurtured by the carnage of 2 World Wars during the first half of this century, followed by more military activity later. During this century alone, man, whatever be the reason and justification, has produced more disabled persons than even the Lord Almighty!

We loftily say that we have a rendezvous with destiny. But think of our handicapped brothers and sisters and the siblings who are either born handicapped, or

have been allowed to become even more supreme music, so, because of the ignorance his greatest Masterpieces. parents. Where do they go? They march slowly to their beautiful lines of hope from Milton:-

"So much the rather thou, Celestial Light. Shine inward"

(said Milton, when he became blind)

"and the mind through all her powers Irradiate; there plant eyes; all mist from thence Purge and disperse, that I may see and tell Of things invisible to mortal sight".

You are all aware that Beethoven, the musical genius was afflicted with deafness. Had Beethoven, by a superhuman effort of will, managed to just maintain the quality of his musical compositions despite his deafness, that itself would have been a most inspiring and incredible feat. Yet, truth is even stranger than fiction, for, in fact, it was during his years of total deafness that Beethovan excelled himself and wrote

or carelessness of their own Beethoven's life is an inspiration to our belief and conviction that the "Differently rendezvous with despair. Abled". as we should call the Here I wish to recall the handicapped, can accomplish wonders, given the right environment.

> I am certain in my own mind that progress depends, above all, on the temper and attitudes of the nation, state and policy and that temper must find expression in a firm spirit and resolve. It was the urge to give shape, design, direction and momentum to this spirit and this resolve that spurred me earlier to envisage a vision for women, a 15 Point Programme of Child Welfare and now this State Policy on the Welfare of the handicapped.

Happily for us, rehabilitation is not the infant prodigy of medicine as it was at the dawn of the century. The aftermath of the terrible World Wars triggered activity in this field and has revolutionised rehabilitation medicine, especially technology. The improvisation of aids and devices to allow the handicapped to help themselves has helped millions of disabled people all over the



world now, to lead rewarding lives as independent, productive workers and housewives, largely because of a very caring and supportive environment.

Let me share a story with vou. At a circus show, a Robber called aside the Acrobat who was jumping and swinging on the ropes and platforms, and offered him a huge reward if he would fix an explosive on the high dome of a Bank Vault. The Robber took the Acrobat to the compound wall at the dead of night and asked him to jump on to the dome. But the Acrobat stood motionless, hesitated and said: "You want me to jump, but I need an audience. I cannot jump now" The fact was that it was the encouraging applause of the people in the audience that gave him all the motivation and the energy to perform his feats. Without all that cheering encouragement, he was just a vegetable. The lesson is that community based Rehabilitation should receive greater stress and support than institution based models.

I have heard of a system of marking in which only 50% of the marks earned by a student is awarded to him, and to that figure is added 50% of the class average. This is with a view to encouraging the brighter students to help the weaker ones not by copying but by helping in study - so that the class average is raised. Educationists may consider the possibility of some such sys-

tem in the special schools for the handicapped also.

We have proposed to include mental illness in the list of handicaps. Perhaps we should even include old age and the associated mental problems, but that would be a separate area. Frankly, I wonder if there is any perfectly satisfactory definition of mental illness, just as there is probably no perfect definition for mental health. With the relentless onward march of modern civilization as we know it, the incidence of mental illness is on the increase. I am told that in some places, one third of the population is in need of psychiatric treatment, and that in our present stage of growth and development, about 20% of our people lack mental health. Perhaps this portion includes those who readily resort to violence like causing damage to buses and public property and those who are merely depressed and unhappy. I hope that the Rehabilitation Council proposed to be constituted, as mentioned in the policy, will suitably define mental illness for the purpose of assistance under the schemes for the handicapped.

I am happy and proud to say that during the year 1993, the Government of India awarded to our State of Tamil Nadu, the first prize for placement of the maximum number of physically handicapped persons. It would be the endeavour of my Government, to consider

and bring in a legislation that the property due to disabled children, especially the mentally disabled and ill, would accrue to and devolve upon them in the event of the demise of their parents or guardians. It would be our further endeavour to ensure that the dedicated efforts of the Government, both at the Centre and in the State and the voluntary organisations, have proper linkages and convergencies, so that the laudable schemes that are framed or formed really percolate and reach the persons for whom they are intended.

I would like to thank all of you who have made the release of this State Policy possible and would like to conclude with some announcements which will spearhead the implementation of this Policy.

- 1. The State Rehabilitation Council, consisting of concerned Heads of Departments and experts, under the Chairmanship of the Hon'ble Minister for Social Welfare, will be constituted immediately.
- 2. A single State Level Agency will be formed by coordinating the activities of the Institute of Rehabilitation Medicine, Institute of Speech and hearing, Institute of Ophthalmology, Institute of Mental Health and other institutes. This institute will be responsible for implementing the recommendations of the State Rehabilitation Council.
 - 3. Legal measures protect-

ing the rights of the handicapped will be initiated immediately.

- 4. Mental illness is included in the categories of Handicaps, as suggested by the leading specialists in the field.
- 5. Efforts will be intensified to ensure that every handicapped child is identified and admitted to school for education within 6 years of age; recreation and leisure activities will receive a special thrust; special nurseries for handicapped pre-school children will be started.
- 6. I am happy to announce that the Women's Development Corporation of Tamil Nadu - MAHAM- which embarked upon the project, Annai Sandhya Children's Amusement and Educational Complex at Coimbatore, will regularly donate 10 lakh rupees every year from the profits of the Complex, from this year onwards, for the vocational training and gainful employment of the handicapped women in rural areas.

The human brain, our brain, is the best and cheapest computer ever produced. Let us use these computers effectively, in the service of the handicapped.

Hon'ble Sri Sitaram Kesriji, made a most remarkable and inspiring address. I thank him for the very many kind remarks he made, about the functioning of our State Government. I would like to tell all of you that you need not feel disappointed that Sri Sitaram Kesriji did not make announcements which we ex-

pected today.



The Union Minister said very little work had been done to help sort out problems faced by multiple handicapped. "There is need to serve this category of disabled persons in a professional manner. More research and manpower development is required, "the Minister added.

The Union Minister said that according to the national sample survey 16.15 million people in the country had visual, communication or locomotor disorders, 29 out of every 1000 children in urban areas and 31 out of 1000 children in urban areas and 31 out of 1000 children in urban in rural areas had developmental problems which could result in intellectual retardation. "It is evident that this task of educating and integrating into our social and economic lives of such a large number of people with disabilities is a gigantic one that calls for a concerted effort on the part of the Government, voluntary organisations, and the community at large," he added.










A Stone archway is being constructed at the entrance to the Thanjavur Tamil University. Intricate sculpting will be the hall mark of the archway.



Hon'ble Chief Minister Puratchi Thalaivi Dr. J. Jayalalitha announced a package of concessions for the development of the Adi Dravidar community while speaking after unveiling the statue of late Sivaraj - the first Adi Dravidar Mayor of Madras - at the Mint Junction in Madras on 6.12.94.

She said a special scholarship scheme would be implemented 'to enthuse the students from this community to take to higher education. It would be extended to those whose family income was less than Rs.50,000 per annum.

The grant in aid scheme under which Rs.500 was given for providing the primary education to Adi Dravidar Girl students would be extended to five more districts - Chengalpattu-MGR, North Arcot-Ambedkar, Salem, Tiruchi and Nagapattinam-Quaid-e- Milleth. The annual grant is now made available for each airl student from the community studying in classes three to five in the districts of Dhar-Villupurammapuri, Ramasamy Padayachiyar, South Arcot-Vallalar, Tiruvannamalai-Sambuvarayar and Kamarajar. By extending the scheme to five more districts.

30,000 more students would benefit.

For helping the students to continue the collegiate education, a monthly stipend of Rs.150 would be given to 1,000 girl and 1000 boy students who had come first in the plus two examinations.

A Rs.10 lakhs Trust - 'Mayor Sivaraj Education Trust' - would be set up in the proposed Law University to provide financial assistance to students both boys and girls - studying law.

The grant now provided under the self employment scheme through THADCO

would be increased to Rs.25,000 from the present Rs.15,000. The Governmental assistance to the beneficiaries towards their equity participation would be increased to Rs.1.25 lakhs from Rs.81,000.

The Government would distribute lorries through THADCO to educated Adi Dravidar youths and it would set apart Rs.50 crores every year for this purpose. At the time of handing over the lorry, each beneficiary would be given Rs.1.25 lakhs by way of grant and equity participation.

For the economic development of Adi Dravidar women, a Rs. 10 crores loan scheme would be implemented for self employment of 10,000 women every year. Of the Rs. 10 crores, Rs. 5 crores would be distributed as outright grant.

Towards undertaking repairs in their dwelling units, Rs.5,000

would be given to Adi Dravidars and Scheduled Tribes. The Government would set apart Rs. 15 crores to benefit 30,000 families.

Free house pattas would be provided to five lakhs Adi Dravidar families before December 31, 1995.

One thousand community halls would be constructed at a cost of Rs.25 crores for as many Adi Dravidar habitats.

Colour TV sets would be installed in Adi Dravidar habitats and in the first phase 2,000 colonies would be covered at a cost of Rs.3 crores.

An award would be instituted in the name of Ambedkar to be given every year to one who had done extraordinary service for the betterment of Adi Dravidars.

Paying glorious tributes to Sivaraj, she said he enforced total prohibition in the city when he was Mayor in 1946 and toiled hard to retrieve the poor from the drink habit.

He showed exemplary enthusiasm in the spread of education and appointed four special officers to supervise whether the parents, especially those in the Adi Dravidar Community were sending their wards to schools under the compulsory education scheme, the Chief Minister added.

TUCS - HOLDING THE PRICE LINE

The Triplicane Urban Co-operative Society Ltd., commonly known as T.U.C.S. Ltd., is the pioneer of the Consumer Co-operative movement in the Country. The T.U.C.S. Ltd. was organised on 9.4.1804 under the patronage of 14 Pioneers. Rt. Hon'ble V.S. Sreenivasa Sastri was the first President of T.U.C.S. The Society had 14 members and a paltry sum of Rs.310/- to serve as Share Capital. These Fourteen enthusiasts embarked on a bold venture.

At a time when the Government badly needed one organisation for the distribution of necessary food-stuffs during the Second World War in 1942 T.U.C.S. withvast experience in the distribution of essential commodities came forward and undertook the arduous task of rendering yeoman service and discharged efficiently the tremendous task of feeding the whole City with necessary food.

It will be no exaggeration when we say that in appreciation of the invaluable services rendered by the T.U.C.S. Ltd. during 1942-45, the Government was pleased to make an ex-gratia grant to the Society to the order of Rs.1.87 lakhs equivalent to one half of the net profits eamed on behalf of the Government by T.U.C.S. for working out efficiently the emergency food supply scheme initiated by the Government of Madras.

Dung the year, 1959-60, the Society was offered the sole distribution of Rice to the City of Madras. The Society procured and distributed Rice to the extent of 38,000 tonnes valued at about Rs.1.73 crores. The Government of Tamil Nadu

awarded a shield to the Society for the best run Urban Consumers Cooperative Society in the year 1959-60. The administration of T.U.C.S. is being managed by the Special Officer from 10-6-1976 onwards.

PUBLIC DISTRIBUTION . SYSTEM:

The T.U.C.S. Ltd., is running 211 Fair Price Shops in South Madras, Essential commodities like Rice; Sugar, Kerosene, Palmolein, Etc., are issued through the Fair Price Shops to 2.83 lakhs family card-holders. The quantum of allotment made per month on an average is given below:

MOBILE SHOPS:

In order to boost the sale of Noncontrolled commodities, Mobile Shops to effect sales in the newly developed colonie were introduced. Accordingly two Mobile Shops by name "KAMADHENU-ON-WHEELS" and "TUCS-ON-WHEELS" were introduced. The mobile is parked in 16 Centres in a day between 9.00 A.M. and 1.00 P.M. and between 3.00 P.M. and 7.00 P.M. At all places, there was warm welcome to the Mobile Shops and the sales is also encouraging.

ROLE OF DISTRIBUTION OF INDANE GAS:

The T.U.C.S. is the major distribu-

tor of L.P.G. by name 'INDANE'. The total number of customers (both domestic and commercial) is 54869. T.U.C.S. is distributing refills through our 17 booking points located in various places in the Madras City.

The average monthly sales of refills is about 46200. T.U.C.S. is being paid a commission of Rs. 3.15 per refill. The margin of profit works out 6.67%.

COLLECTIONS OF DEPOSITS:

- i) The Society receives Deposits both from its Members and Non-Members only at such a rate of interest fixed from time to time.
- ii) The Deposit will be acceptable for a minimum period of 3 months and above and the present rate of interest is as follows.
 - a) 3 months to 6 months 15.5%
 - b) More than 6 months 16% and

minimum amount of Rs.500/- and multiples of five hundred will alone be accepted,

c) As on 31-10-94 the deposit position stands at Rs.150 lakhs.

PETROL BUNK:

The Petrol Bunk which is situated at Alwarpet is run by T.U.C.S. A Service Station is also attached to the Petrol Bunk Complex. All the Government, Quasi-Government Department, Govt. Corporation are drawing fuel and they are sending their vehicles for servicing. To fall in line with Modern trend, by an agreement with the City Bank and I.O.C. and extended credit card facilities to the public in the sale of petrol prod-

ucts also. T.U.C.S. has already extended this facility in our Super Market for the purchase of all commodities by our customers.

"KAMADHENU" COOPERATIVE SUPER MARKET

The Kamadhenu Cooperative Super Market, a Unit of T.U.C.S. Ltd., was started on 14.10.1966. The Super Market was started in pursuance of the scheme sponsored by Government of India to hold price line and to supply all the Household requirements under one roof. The Super Market was started functioning initially with the following departments:-

- 1. Grocery Department
- 2. General Merchandise Department
- 3. Consumer Durable Department
- 4. Textile Department
- 5. Vegetable Department
- 6. Cafeteria Department

As all the commodities are made available under one roof at reasonable rates, the number of customers increased day-by-day and the name of "Kamadhenu" become popular in the midst of public. Though it was not a full fledged one, the grocery wing is functioning as a Self-Service Department since 1976.

The total sales of Kamadhenu Cooperative Super Market Complex in June, 1986 was Rs. 48.80 lakhs and whereas the quantum of sales effected in June '94 was Rs. 56 lakhs.

The progress was steady from its inception. It was felt that the Super Market should have a building on its own and efforts were taken in this

direction. The efforts yielded fruitful results and a new Super Market Complex was constructed at a cost of Rs.77/- lakhs and the same was declared open by the Hon'ble Chief Minister of Tamil Nadu on 18.10.1985. The New Super Market Complex is considered as the second biggest in India.

MARKET INTERVENTION

T.U.C.S. - Kamadhenu is playing a vital role in the sphere of market intervention whenever the prices of essential consumer commodities are registering very high price in the open market. To quote a few examples, T.U.C.S. - Kamadhenu entered the rice market in a big way by offering rice at very cheap rate of Rs.7/per Kilo when ruling open market price was in the range of Rs.8/- to Rs.8.50 per kilo during the months of Feb.'94 and Mar.'94. Similarly when the price of Sugar skyrocketed eted in the open market and it was sold at Rs.17/- to Rs.18/- during the months of May, 94 and June, 94. T.U.C.S. Kamadhenu fixed its selling price of Sugar to customers between Rs.15/- and Rs.15.50 per Kilo and sold huge quantity through its 225 retail outlets. Similarly when the customer in the City faced acute problem of non availability of Coffee Seeds and Powder at a very high price in the open market, T.U.C.S. -Kamadhenu came to the rescue of the public by offering Coffee powder at the rate of Rs.80/- per kilo initially and later on changed to Rs.100/- per Kg. when the ruling prices in the market was around Rs.150/- to Rs.160/- per Kg. This. was possible to T.U.C.S. - only due to careful planning, utilising its bargaining power and following strict financial discipline besides purposefully keeping low margin for these products for the benefit of consumers during the period of crisis.

TANFED - ENRICHING RURAL TAMIL NADU

Tamil Nadu Co-operative Marketing Federation Ltd., popularly known by its brand name "TANFED" serves in the field of distribution of Agricultural inputs, Marketing of Agriculture produce etc. since 1959. Its basic objectives are:

- i. To identify the agricultural input requirements of the farmer members of Primary Cooperative Agricultural Banks and arrange for storage and distribution through Co-operative outlets.
- ii. To provide market support to the affiliated member societies in procuring, storing and marketing agricultural commodities.
- iii. To provide storage facilities of specialised nature for perishable agricultural commodities and agro-based products.
- iv. To undertake manufacture of agricultural inputs such as granulated fertilisers, manure mixtures and quality seeds.

Input Marketing Distribution of fertilisers

TANFED is distributing fertilisers and other agricultural inputs through the Co-operative outlets viz. the Primary Co-operative banks situated all over Tamil Nadu except Thanjavur, Nagapattinam-Quid-e-Milleth and Nilgiris districts where the Thanjavur Co-operative Marketing Federation and the Nilgiris Co-operative Marketing

Society take care of these functions. During the year 1993-94 TANFED has distributed 3,16,273 tonnes of all types of fertilisers worth Rs.14,369.55 lakhs. During the year 1994-95 (upto September '94) TANFED has distributed 1,84,923 tonnes worth Rs.8531.73 lakhs.

Manufacture of fertilisers

TANFED manufactures its own granulated mixtures of P.F.17:17:17 fertilisers with right mix-up of NPK and ingredients like neem cake. This product is now very popular with the farmers in Tamil Nadu. Annually about 30,000 tonnes are produced in the factory at Pamani village near Mannargudi. During the year 1993-94 a quantity of 25,936 tonnes was produced and a quantity of 22.093 tonnes worth of Rs.1.309.37 lakhs was sold. During the year 1994- 95 (first six months) a quantity of 9,610 tonnes was produced and a quantity of 14,039 tonnes worth of Rs.840.96 lakhs was sold.

Agro Super Markets

Fully realising the need for implementing the concept of supply of all Agricultural inputs under one roof, the Government entrusted the work of establishing Agro Super Markets to TANFED.

To activise the performance of these Agro Super Markets, TANFED made supplies of poly pallets for scientific storage of

fertilisers, name boards, price exhibition boards, banners, wooden racks, bicycles, uniform clothes to sales personnel etc. of 100 Primary Agricultural Co-operative Banks and started 100 Agro Super Markets in 1992-93. It has also proposed to impart training to the staff of the Agro Super Markets through the Co- operative Training College at Madras and Co-operative Training Centre at Madurai. Adequate quantities of fertilisers, seeds, pesticides and Agricultural Implements are also made available to these Super Markets, It has been proposed to start another one hundred Agro Super Markets during the year 1994-95.

Subsidy Fertilisers

The Fertiliser concession scheme announced by Government of India was introduced by the Government of Tamil Nadu.

The concession was given to TANFED to be passed on to the farmers for Chemical Fertilisers. viz. Muriate of Potash, SSP, D.A.P. Vijay 17:17:17, Factamphos, Paramphos and IFFCO 10:26:26. During 94-95, the concession is being passed through the manufacturers and they are supplying the above fertilisers after deducting the concession.

Agricultural Marketing

As a marketing organisation, TANFED undertakes procurement of agricultural commodities such as cotton, chillies, coriander, pulses and oil seeds. Providing market support to the farmers is its main aim and therefore the procurement operation is undertaken through the marketing societies on joint venture and on agency basis besides outright purchases. Despite serious setbacks in realising the sale proceeds from the Co-operative Spinning Mills to the order of nearly Rs.8 Crores, TANFED continues its procurement of cotton for supply to National Textiles Corporation Mills.

During the year 1993-94, TANFED programmed marketing of agricultural commodities to the extent of Rs.1940 lakhs and achievement had been made to the extent of 23197 tonnes worth Rs.2826.16 lakhs. During the year 1994-95, a quantity of 19,564 tonnes of agricultural commodities worth Rs.2702.77 lakhs has been procured upto September 94 as against the annual target of Rs.2,777 lakhs.

Distribution of pesticides, seeds and Agricultural Implements:

Like fertilisers, TANFED distributes plant protection chemicals viz., pesticides and insecticides through the Primary Co-operative Banks and also seeds and Agricultural implements according to farmers' preference.

During the year 1993-94 TANFED distributed seeds, pesticides and agricultural implements to the value of Rs.45.69 lakhs, Rs.589.07 lakhs and Rs.2 lakhs respectively. The achievement so far in the current year 1994-95 (upto September '94) are Rs.13.51 lakhs, Rs.96.11 lakhs and Rs.0.30 lakhs for seeds, pesticides and agricultural implements respectively.

Cold Storage

The existing Cold Storage of TANFED situated at Basin Bridge Road, Madras is now utilised to 50% of its installed capacity of 1250 tonnes. A renovation work for strengthening the racks in Chamber No.1 with 50% capacity as well as conversion of the defunct Ice Plant space into Cold Storage at an estimated cost of Rs.26 lakhs has been taken up.

Inspite of its limited utilisation, the income earned by this Unit is quite steady. During the year 1993-94, this unit earned an income of Rs.13.54 lakhs and during the first six months of the current year 1994-95

Tourism is a key growth industry. Tourism offers good scope for gainful employment. The South can boast of a unique heritage and it has the best potential for becoming a favourite tourist destination. We welcome the concept of Special Tourism Areas. At the same time, it is necessary for the Centre to declare the South as the most favoured destination for foreign tourists and back this with a clear strategy, involving the prvovision of adequate investment. We shall join in this common endeavour.

Establishment of a New Cold Storage at Koyambedu:

TANFED is now constructing a modern and larger Cold Storage of 2500 tonnes capacity at the Koyambedu Wholesale Market Complex being developed by the Madras Metropoliton Development Authority. This prestigious work has been taken up at a total block cost of Rs. 162 lakhs.

Storage:

TANFED owns 36 godowns with a combined storage capacity of 26,560 tonnes.

Kerosene Tankage:

The Kerosene Tankage of TANFED at Madras is provided with only a limited scope. In the year 1993-94, it has distributed 3216 Kilo Litres of kerosene worth Rs.80.57 lakhs. During the year 1994-95 (upto September '94) TANFED has distributed 1,523 kilo litres valued at Rs.37.61 lakhs so far.

Working results:

TANFED has shown considerable progress in its overall operation especially in input distribution in recent years. The progress during the past five years is as follows:-
